Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of InterGen Services, Inc. Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets in liquidation available for benefits (liquidation basis) as of December 28, 2022 and December 31, 2021, and the related statement of changes in net assets in liquidation available for benefits (liquidation basis) for the period then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of InterGen Services, Inc. Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 28, 2022 and December 31, 2021 and for the period ended December 28, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America..
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Emphasis of Matter-Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 5 to the financial statements, the Plan sponsor, Intergen Services, Inc. approved a plan of liquidation on July 5, 2019 and management determined liquidation was imminent. As a result, the InterGen Services, Inc. Retirement Savings Plan changed its basis of accounting from the ongoing basis of accounting used in presenting the 2018 financial statements to the liquidation basis of accounting used in presenting the 2022, and 2021 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about InterGen Services, Inc. Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Notes to the Financial Statements

Note 1 - Description of the Plan

The following brief description of the InterGen Services, Inc. Retirement Savings Plan (the “Plan”) provides general information only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan was established as of June 1, 1999. The Plan is a defined contribution 401(k) Plan structured under the provisions of Section 401(k) of the Internal Revenue Code (the “Code”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan has been amended and restated to be in compliance with changes required under ERISA. InterGen Services, Inc. (the “Company”) acts as Plan administrator and controls and manages the operation and administration of the Plan. State Street Bank & Trust Company acts as the Plan’s trustee and custodian. Massachusetts Fidelity Trust Company also acts as a custodian. The trustee has contracted with the Transamerica Retirement Solutions Corporation (“Transamerica”), formerly the Diversified Retirement Corporation, to provide certain necessary functions, including all recordkeeping services, for the operation of the Plan. Transamerica also provides investment fund options to the Plan through affiliated companies.

Plan Termination

On July 5, 2019, the Plan sponsor adopted a resolution to terminate the Plan. As a result, no further contributions were allowed to the Plan and all participants were fully vested in their account balances. Participant account balances were liquidated and distributed to participants on February 8, 2022 and the plan was fully terminated on December 28, 2022. As a result of the termination of the Plan, the financial statements have been presented on the liquidation basis of accounting. No adjustments to the financial statements were required to present them on the liquidation basis of accounting.

Eligibility

All participants who had account balances prior to July 5, 2019 (the date of the resolution to terminate the Plan) are eligible to participate in the Plan unless otherwise stated in the Plan document.

Contributions

Effective July 5, 2019, no further participant contributions were allowed to be made to the plan.

Company Contributions

Effective July 5, 2019, no further employer contributions were allowed to be made to the plan.

Vesting

Participants are immediately vested in their elective contributions plus actual earnings thereon. Effective July 5, 2019, all participants in the Plan are 100% vested in their entire account balance.

Payment of Benefits

Participants may withdraw amounts equal to the total value of their pretax contribution or vested company contribution accounts after the age of 59 ½ or in the event of financial hardship or need. Upon termination after vesting, attainment of age 65 (normal retirement date), death or permanent disability, distributions may be made as described in the Plan document.

Note 1 - Description of the Plan (continued)

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the company's matching contribution, and allocations of (1) company discretionary contributions and (2) Plan earnings and charged with an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of their contributions and company matching contributions into investment options offered by the Plan. The Plan currently offers various registered investment companies (mutual funds), a stable value fund held in a common collective trust and cash reserve account.

Forfeited Accounts

Participants who terminated prior to full vesting forfeit the non-vested portion of Company contributions. Forfeiture amounts can be used by the Company for matching contributions, for the benefit of participants or for the payment of Plan administrative expenses. At December 28, 2022 and December 31, 2021 the Plan had unallocated plan assets totaling \$0 and \$650, respectively available for use as specified per the Plan document. During the year ending December 28, 2022 allocated plan expenses amounts of \$650 were used to cover Plan expenses.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The Company entered into an agreement to terminate the Plan. See note 1 and 5 for more information. As a result, the Plan's financial statements are presented using the liquidation basis of accounting. Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of account and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process. There have been no changes to these methods or assumptions. Management has not accrued any costs or income in the statement of net assets in liquidation available for benefits, as it believes the fair value, as presented, is the best estimate of liquidation value.

Year End

The Plan utilizes a December 31 calendar year end.

Use of Estimates

The preparation of the Plan's financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Note 2 - Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Shares of registered investment companies (mutual funds) are stated at fair value, where applicable, using quoted market prices as reported by the custodian. The Transamerica Retirement Solutions-Stable Pooled Fund is valued at the Net Asset Value (NAV) of units held by the Plan at year end. See Note 6 for further discussion and disclosures related to fair value measurements.

Investment earnings are composed of interest, dividends and realized and unrealized gains and losses on investments. Interest income and dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Purchases and sales of securities are recorded on a trade date basis. Interest income and dividends are recorded when received.

Payment of Benefits

Benefits are recorded when paid. Amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not yet been paid were not material at December 28, 2022 and December 31, 2021, respectively. Final payments of benefits to all participants were made on February 8, 2022.

Subsequent Events

For the period ended December 28, 2022, the Company evaluated subsequent events for potential recognition and disclosure through January 23, 2023, the date of the financial statement issuance. As a result of the spread of the COVID-19 coronavirus, economic uncertainties have arisen which are likely to negatively impact investment income and other plan transactions. Other financial impact could occur though such potential impact is unknown at this time.

Administration of Plan Assets

The trustee and custodian of the Plan, the State Street Bank & Trust Company, and the custodian the Massachusetts Fiduciary Trust Company hold the Plan's assets. Contributions are held and managed by the trustee and custodians of the Plan, which invests cash received, interest and dividend income and makes distributions to participants. Officers or employees of the Company perform certain administrative functions. No officer or employee receives compensation from the Plan. Administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. In addition, the company also provides certain administrative services to the Plan at no cost to the Plan.

Recent Accounting Pronouncements

In August 2018, the FASB issued ASU No. 2018-13, "Fair Value Measurement (Topic 820): Disclosure Framework - Changes to the Disclosure Requirements for Fair Value Measurement." This new guidance removes certain disclosure requirements related to the fair value hierarchy, modifies existing disclosure requirements related to measurement uncertainty and adds new disclosure requirements. This guidance was effective for the Plan beginning on January 1, 2020 and did not have a material impact on the Plan's Financial Statements

Note 3 - Information Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee, the State Street Bank & Trust Company and the custodian, the Massachusetts Fidelity Trust Company certified information as complete and accurate to the Plan's administrator and agreed to or derived the certified information regarding investment assets, notes receivable from participants investment transactions and investment income (loss) presented in the accompanying Statements of Net Assets in Liquidation Available for Benefits (liquidation basis) as of December 28, 2022 and December 31, 2021, the Statement of Changes in Net Assets in Liquidation Available for Benefits (liquidation basis) for the period ended December 28, 2022, and the Supplemental Schedules of Assets Held at End of Year (liquidation basis) as of December 28, 2022 and December 31, 2021.

Note 4 – Related-Party and Party in Interest Transactions

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Plan Sponsor, therefore, all transactions with these entities qualify as party-in-interest transactions. Certain Plan investments, including shares of registered investment companies (mutual funds), cash reserve accounts and contracts in a collective trust are managed by Transamerica Retirement Solutions Corporation ("Transamerica"), which also acts as the Plan's record-keeper. Fees totaling \$2,018 were paid for these services in 2022. Other fees incurred by the Plan for the investment related expense may be included in net appreciation/depreciation in fair value of investments. The Plan sponsor pays directly any other fees related to the Plan's operation.

Note 5 – Plan Termination

On July 5, 2019, the Plan sponsor adopted a resolution to terminate the Plan. As a result, no further contributions were allowed to the Plan and all participants were fully vested in their account balances. Participant account balances will be liquidated and distributed to participants as soon as administratively practical. As a result of the termination of the Plan, the financial statements have been presented on the liquidation basis of accounting. No adjustments to the financial statements were required to present them on the liquidation basis of accounting.

Note 6 – Fair Value Measurements

FASB ASC 820, Fair Value Measurement Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements)

The three-tier fair value hierarchy under FASB ASC 820 is described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.
- Level 2: Inputs to the valuation methodology include:
 - o Quoted prices for similar assets or liabilities in active markets;
 - o Quoted prices for identical or similar assets or liabilities in inactive markets;
 - o Inputs other than quoted prices that are observable for the asset or liability;

o Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observed for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 28, 2022 and December 31, 2021.

Registered investment companies (mutual funds): Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and, as a result, are classified as a Level 1 investment.

Cash reserve account: Bank accounts with daily quoted valuation. This account is classified as a Level 1 investment.

Management evaluates the significance of various inputs to assess the appropriate classification of the Plan's investments within the fair value hierarchy. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period. Management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the period ended December 28, 2022 and the year ended December 31, 2021, there were no significant transfers in or out of Level 1, 2 or 3.

Note 7- Stable Value Fund

The Transamerica Retirement Solutions-Stable Pooled Fund is a fully benefit-responsive investment contract. Investment contracts held by a defined contribution plan are required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contributions to the Transamerica Retirement Solutions-Stable Pooled Fund under this contract are maintained in a general account that is credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Transamerica. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion, of their investment at contract value. There are no reserves against contract value for credit risk. There are no unfunded commitments. Under the terms of the contract, the Plan sponsor must provide a minimum of 90 days' notice to MetLife prior to redemption of the contract. Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (2) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (3) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. The actual average yield earned by the plan for benefit responsive fund was 3.4% and 2.2% for 2022 and 2021 respectively.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investments securities will occur in the near term and that such change could materially affect participant's account balances and the amounts reported in the Statement of Net Assets in Liquidation Available for Benefits.

Note 9- Tax Status of the Plan

The IRS has determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt. Therefore, no provision for income taxes is included in the Plan's financial statements. The liquidation basis of accounting requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
