## Independent Auditors' Report

To the Board of Directors  
Autofair Ford, L.P. 401(k) Retirement Savings Plan  
Manchester, New Hampshire

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Autofair Ford, L.P. 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the six months ended June 30, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Autofair Ford, L.P. 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the six months ended June 30, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Autofair Ford, L.P. 401(k) Retirement Savings Plan, and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## Emphasis of a Matter – Basis of Accounting

As discussed in Note 1 to the financial statements, on December 6, 2021 the Company sold all of its business assets and the Plan's sponsor decided to terminate the Plan effective December 31, 2021. Accordingly, the Plan's basis of accounting is the liquidation basis for the Plan's 2022 and 2021 financial statements. Our opinion is not modified with respect to this matter.

## Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the liquidation basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Autofair Ford, L.P. 401(k) Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:


- Exercise professional judgment and maintain professional skepticism throughout the audit.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. DESCRIPTION OF PLAN

The following brief description of the Autofair Ford, L.P. 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan documents for more complete information.

General

Prior to termination, the Plan was a defined contribution plan covering substantially all of the employees of Autofair Ford, L.P., Autofair 1477, L.P., Keller St. Motors, L.P., Autofair Used Vehicles, L.P., Stratham Automotive, LLC, Tewksbury Automotive, LLC, Nashua Automotive, LLC, Haverhill Ford, LLC, and Haverhill Subaru, LLC (collectively referred to as the Company). The Plan had three major components: an employee salary deferral, a discretionary employer matching contribution, and a discretionary employer contribution. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was intended to be a qualified defined contribution plan which satisfies the requirements of Internal Revenue Code (IRC) Section 401(k). Under IRC Section 401(k), participants were not liable for federal income taxes on employee contributions, Company contributions, or Plan earnings until such time as they were withdrawn from the Plan.

Plan Termination

Effective December 31, 2021, the Plan sponsor approved the termination of the Plan due to the sale of the dealerships and the collision center owned by the Company on December 6, 2021. All of the employees were terminated and vested 100% in their account balances. Participants were notified of the termination and the Plan started the distribution process in January 2022. Participants were distributed their balances in a lump sum payment. Non-responsive participants with balances were distributed in the form of an IRA. All participant accounts were fully liquidated and distributed prior to June 30, 2022. As such, the Company has determined that June 30, 2022 is the final reporting date for the Plan.

Salary Reduction Provision

Prior to termination, an eligible employee was permitted to contribute up to 100% of gross compensation subject to IRC limitations. An employee was eligible to participate in the Plan provided they reached 21 years of age and completed nine months of service. Salary deferral contributions were maintained in a separate account and were invested in accordance with the investment strategy selected by each individual participant. The Plan also provided for catch-up contributions for participants over age 50, subject to IRC limitations. All amounts credited to an employee's elective deferral account were 100% vested and non-forfeitable.

Employer Discretionary Matching Contribution

The Company could elect to make a discretionary matching contribution on behalf of eligible participants. Contributions were maintained in a separate Company Matching Contribution account for each participant and were invested in accordance with the investment strategy selected by each participant. There was no employer matching contribution for the six months ended June 30, 2022.

Employer Discretionary Contribution

The Company could also elect to make a discretionary contribution on behalf of eligible participants. Any such contributions are maintained in a separate Company Discretionary Contribution account for each participant and were invested in accordance with the investment strategy selected by each participant. For the six months ended June 30, 2022, there is no discretionary contribution.

Participant Accounts

Each participant's account was credited with Company contributions, participant's contributions, any forfeitures allocated to the participants, and Plan earnings, and charged with an allocation of administrative expenses. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account. All contributions made to these accounts were directed by the participant into the investments offered by the administrator and the allocations between investments could be changed at will.

Vesting

All participants currently employed as of December 6, 2021 became fully vested in their Company contributions in connection with the termination of the Plan.

Notes Receivable From Participants

Prior to termination, participants could borrow from their account. Loan terms were up to five years. The loans were secured by the balance in the participant's account and bore a reasonable interest rate. Principal and interest was paid ratably through bi-weekly or monthly payroll deductions. All loan balances were repaid in full or distributed to participants in 2022.

Distribution of Benefits

All employed participants at December 6, 2021 were effectively terminated from the Company. All balances have been distributed to participants directly or rolled over to a new plan at the discretion of the participant. Any non-responsive participants to the Plan's termination had their balances directed to an Empower IRA in the participant's name.

Rollovers

The Plan allowed direct rollovers from other qualified plans. Rollovers were maintained in a separate account for each participant and invested in accordance with the investment strategy selected by each individual participant. All amounts credited to an employee's rollover account were 100% vested and non-forfeitable.

1. DESCRIPTION OF PLAN (CONTINUED)

Forfeitures

Prior to December 6, 2021, if a participant terminated employment and received the vested portion of their account, the participant immediately forfeited the non-vested portion. Any forfeited amounts could be used to reduce the employer contributions or allocated to active participant accounts. Forfeited non-vested accounts totaled \$382 at December 31, 2021. The balance at termination was allocated to the participants.

Plan Amendments

Effective with the Plan's termination, the Plan adopted the provisions of the SECURE Act and CARES Act. The SECURE Act was effective January 1, 2020 and implemented key retirement legislation reform. The provisions in this Act did not have a material impact on the Plan. The CARES Act was signed into law on March 27, 2020 and included several temporary provisions available including changes in loan provisions for qualified participants that included an increase in loan limits to \$100,000 through September 2020, and an option to suspend loan payments through December 31, 2020. The CARES Act also suspended the required April 2021 minimum distribution payments.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statement of the Plan has been prepared on the liquidation basis of accounting in accordance with principles generally accepted in the United States of America (GAAP) as of June 30, 2022 and December 31, 2021, and for the six months ended June 30, 2022.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive contracts. Contract value was the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value was the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan. All investment values at December 31, 2021 are considered to approximate the liquidation basis of accounting.

Notes Receivable from Participants

Notes receivable from participants were reported at their unpaid principal balance plus any accrued but unpaid interest. Interest rates ranged from 4.25% to 5.50%. Related fees were charged directly to the borrowing participant's account. As of December 31, 2021, no allowance for credit losses was recorded. A loan was considered delinquent when no payments had been received for 90 days. The remaining loan balances at Plan termination were recorded as a deemed distribution to the participant based on the terms of the Plan document.

2. SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

The Plan's investments were recorded at fair market value (except for fully benefit-responsive investment contracts) based on quoted market prices on the last day of the Plan year as certified by the asset custodian, and, accordingly, the investment income includes unrealized gains and losses on investments held as of that date. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Payment of Benefits

Distribution of benefits to participants were recorded when paid.

Administrative Expenses

Administrative expenses were paid either by the Plan, the Company, or the participant as provided by the Plan document. Expenses paid by the Company are excluded from this financial statement. Expenses, including loan and distribution fees that relate to an individual participant, were charged against the participant's account. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. Most investment-related expenses are included in net depreciation of fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with the liquidation basis of accounting requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent Events

Subsequent events are events or transactions that occur after the Plan year end but before the financial statement is available to be issued. The Plan has evaluated these events through December 27, 2022.

3. UNAUDITED INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN OF THE PLAN

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian of the Plan has certified to the completeness and accuracy of the investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits at June 30, 2022 and December 31, 2021, and the related investment activity and interest from participant loans reflected on the statement of changes in net assets available for benefits for the six months ended June 30, 2022. The accompanying notes to the financial statement were prepared in part from information certified by the custodian.

4. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan had entered into a fully benefit-responsive investment contract with Great-West Life & Annuity Insurance Company. Great-West Trust Company LLC maintains the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Because the guaranteed investment contract was fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits. Contract value, as reported to the Plan by Great-West Life & Annuity Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Typically, certain events such as Plan termination limit the ability of the Plan to transact at contract value with the issuer. With the Plan termination, there have been no limitations placed on transactions nor has the Plan sustained any penalties for terminating the contract.

The interest crediting rate was reset quarterly. The guaranteed rate and actual yield was .90% at December 31, 2021. The contract value of the Guaranteed Portfolio Fund was \$471,176 at December 31, 2021.

5. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) No. 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The asset or liability's fair value measurement level within the fair value hierarchy were based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under FASB ASC No. 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

5. FAIR VALUE MEASUREMENTS (CONTINUED)

The following is a description of the valuation methodology used for assets measured at fair value:

*Investments - Mutual Funds* – Valued at quoted net asset value of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. PARTIES-IN-INTEREST

Parties-in-interest includes, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Accordingly, notes receivable from participants and the management of investments held by the custodian are considered parties-in-interest transactions. During 2022, administration fees paid to parties-in-interest amounted to \$44,231.

7. PLAN TERMINATION

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA, subject to the terms of the Plan as discussed in Note 1.

8. INCOME TAX STATUS

The Company had adopted a Prototype Defined Contribution Plan sponsored by Great-West Trust Company. The Plan received an opinion letter on March 31, 2014. The Plan had been amended since receiving the opinion letter, however, the Plan sponsor believes that the Plan was designed and operated in compliance with the applicable requirements of the IRC.

Accounting standards require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.
