### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2021 Financial Statements**

We have performed an audit of the financial statements of Jerry Damson, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of March 31, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period January 1, 2022 through March 31, 2022, and the related notes to the financial statements ("financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of and for the period ended March 31, 2021, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion on the Financial Statements**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution, including in their role as agent as directed custodian for certain assets of the Plan, agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## ***Basis for Opinion on the Financial Statements***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

As a result, the Plan has changed its basis of accounting from the going concern basis to the liquidation basis used in presenting the 2021 financial statements. ## **Notes to Financial Statements**

### **1. Description of Plan**

The following description of the Jerry Damson, Inc. (the "Company") 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan was a defined contribution plan established January 1, 1997, and available to substantially all employees of the Company and affiliated employers, Eleven, Inc., and Damson Park Enterprises Inc. To be eligible to participate in the Plan, an employee must have been 21 years old and have completed ninety days of service with the Company. To be eligible for employer matching contributions, the employee must have completed one year of service with the Company and have attained age twenty-one. Capital Bank and Trust Company (the "Trustee") serves as the trustee of the Plan. The plan administrator controls and manages the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The governing body of Jerry Damson, Inc. terminated the Plan effective December 31, 2021, and management determined liquidation is imminent. In accordance with the accounting principles generally accepted in the United States of America ("GAAP"), the Plan changed its basis of accounting used to value Plan assets from the going concern basis to the liquidation basis for the period ended March 31, 2022 and year ended December 31, 2021. All participant balances were distributed in March 2022.

#### ***Contributions***

Each year, participants could have contributed compensation, as defined by the Plan document, subject to certain Internal Revenue Code ("IRC") limitations. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants could have also contributed amounts representing distributions from other qualified defined benefit or defined contribution plans. Such transfers from other qualified plan were reported as rollover contributions. The Company may make matching contributions which were based upon a percentage of the participant elective deferral or discretionary profit-sharing contributions to the Plan as determined by its board of directors. The Company made no matching contributions for the period ended March 31, 2022.

#### ***Investment options***

Participants directed the investment of their accounts into various investment options offered by the Plan. The Plan offered various mutual funds as investment options for participants.

#### ***Participant accounts***

Each participant's account was credited with the participant's contribution and allocations of the Company's contributions, the Plan earnings, and charged with benefit payments, transaction fees related to distributions, and allocations of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

***Vesting***

Participants were immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon was based on years of service. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon was based on years of service as outlined below:

***Payment of benefits***

On termination of service, death, disability, hardship, or retirement, a participant could have elected to receive a lump-sum amount equal to the value of the participant's vested account or. A participant could have requested to withdraw his or her vested interest in the account for termination of services due to other reasons or has a financial hardship as stipulated in the Plan provisions.

***Forfeitures***

At March 31, 2022 and December 31, 2021, the Company had utilized substantially all previously forfeited funds. Forfeitures could have been made available to reinstate previously forfeited account balances of former participants, been used to satisfy any contribution that may be required or been used to pay any administrative expenses of the Plan. The remaining forfeitures could have been used to reduce the contribution of the Company for the Plan year in which such forfeitures occur. During 2022, forfeitures of \$4 were used to reduce employer contributions.

**2. Summary of Significant Accounting Policies**

***Basis of accounting***

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

***Investment valuation and income recognition***

The Plan's investments were stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on an accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of benefits***

Benefit payments were recorded when paid.

***Administrative expenses***

Certain administrative expenses have been paid by the Plan. Certain other administrative expenses, including legal and accounting fees, were paid by the Company.

***Subsequent events***

The Plan has evaluated subsequent events through January 24, 2023, the date the financial statements were available to be issued.

**3. Fair Value Measurements**

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1:** Observable inputs such as quoted prices in active markets.
- Level 2:** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3:** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

***Mutual funds***

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Exempt Party-In-Interest Transactions**

Certain plan investments were funds managed by American Funds, which is a subsidiary of the Trustee; therefore, these transactions qualified as exempt party-in-interest transactions. Fees during the year for accounting, actuarial and other services rendered by parties in interest were based on customary and reasonable rates for such services. Fees paid to the trustee by the Plan for administrative services were \$29,784 for the period ended March 31, 2022.

**6. Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (the "IRS") stating that the Plan was in compliance with the applicable requirement of the IRC. The Plan is relying on the IRS approval of the prototype plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated March 31, 2014 that the prototype plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 31, 2022 and December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
