Scope and Nature of the ERISA Section 103(a)(3)(C) Audits of the Financial Statements

We have performed audits of the financial statements of the Berger and Burrow Enterprises, Inc. D/B/A Dynamic Mobile Imaging 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets in liquidation available for benefits as of March 31, 2022 and December 31, 2021, and the related statements of changes in net assets in liquidation available for benefits for the period from January 1, 2022 to March 31, 2022 and for the year ended December 31, 2021, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of March 31, 2022 and December 31, 2021, and for the period from January 1, 2022 to March 31, 2022 and for the year ended December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current Plan instrument, including all Plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgement and maintain professional skepticism throughout the audits.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of the accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgement, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Emphasis of Matter – Plan Termination and Use of Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the Board of Directors of Berger and Burrow Enterprises, Inc. D/B/A Dynamic Mobile Imaging voted to terminate the Plan effective December 9, 2021, and management determined liquidation was imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2020 financial statements to the liquidation basis used in presenting the 2021 and 2022 financial statements. Our opinion is not modified with respect to this matter.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedules, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2021 and Schedule H, Line 4a – Schedule of Delinquent Participant Contributions as of March 31, 2022, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of

management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. 1. Description of Plan

The following description of the Berger & Burrow Enterprises, Inc. D/B/A Dynamic Mobile Imaging 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more detailed description of the Plan's provisions.

General

The Plan was a defined contribution plan covering substantially all eligible employees of Berger and Burrow Enterprises, Inc. (the Company) as defined in the Plan document. The following employees were excluded from participating in the Plan: employees covered under a collective bargaining agreement and non-resident aliens. All employees were eligible for participation after they completed one year of service and attained the age of 21. Eligible employees were able to enter the Plan on the first day of the Plan year or first day of 7th month of Plan year coinciding with or next following date the requirements were met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Termination

On December 9, 2021, the Company was acquired by True North Health Navigation, LLC (True North) and the Board of Directors of the Company adopted a resolution to terminate the Plan effective as of December 9, 2021 (the Termination Date), in accordance with the provisions of ERISA. Subsequent to the Termination Date, no contributions could be remitted to the Plan; however, participants could continue to change their investment elections and pay off their outstanding loan balances through payroll deductions. As a result of the termination, participants were provided with the option to rollover their balances into the 401(k) retirement plan sponsored by True North, if eligible, or receive cash or rollover distributions to another qualified plan or individual retirement account (IRA). On March 31, 2022, if a participant had not yet elected either option, the participant's balance was automatically converted to an individual IRA. Effective March 31, 2022, all assets have been distributed from the Plan and the Plan has been legally terminated.

In accordance with accounting principles generally accepted in the United States of America, the Plan changed its basis of accounting from the going concern basis to the liquidation basis at the Termination Date.

Contributions

Prior to the Termination Date, participants could elect to make pre-tax and/or Roth contributions of up to 100% of eligible compensation as defined by the Plan document, not to exceed a maximum of \$19,500 in 2021, plus up to an additional \$6,500 for participants who have reached

at least 50 years of age by December 31, 2021. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company, at its discretion, could make discretionary matching contributions equal to a percentage of a Participant's Elective Deferrals. During 2022 and 2021, there were no discretionary matching contributions paid by the Company.

Participant Accounts

Prior to the Termination Date, each participant's account was credited with the participant's contributions, rollovers, earnings and losses on the investments in their account, and were charged with administrative expenses and transaction fees for services received by individual participants. Upon enrollment in the Plan, a participant could direct contributions to any of the investment options offered by the Plan. Participants could change their investment options on a daily basis. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting

Prior to the Termination Date, participants were vested immediately in their contributions and rollover contributions, plus actual earnings and losses thereon. For discretionary matching contributions and earnings and losses thereon, participants vested 20% after two years of service and vesting was increased 20% each subsequent year and were fully vested after six years of service. All amounts became fully vested upon the participant's attainment of normal retirement age, disability or death. Upon the Termination Date, all participants became fully vested.

Notes Receivable from Participants

Prior to the Termination Date, participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. A participant could have one note outstanding at any time. The notes receivable were secured by the balance in the participant's account and bore a reasonable rate of interest. During 2022 and 2021, loans had fixed rates ranging from 5.25% to 6.75% for the term of the note, not to exceed 5 years unless used for the purchase of the participant's primary residence. Principal and interest were paid through payroll deductions.

Payment of Benefits

Prior to the Termination Date, upon death, disability, termination of employment, or retirement, a participant or their beneficiary could elect to receive a payment of the vested interest in their account in a lump sum distribution or installment payments. Participants were eligible to receive

hardship withdrawals when certain conditions were met. After attaining the age of 59½, participants were also eligible to make a withdrawal of all or any part of their vested account.

Forfeited Accounts

There were no forfeited non-vested account balances as of March 31, 2022 or December 31, 2021. These accounts could have been used to pay Plan administrative expenses or reduce future Company discretionary matching contributions. No forfeitures were used in 2022 and 2021.

Administrative Expenses

The Plan permitted for payment of operational and administrative expenses and were allocated proportionately based on the value of the account balances. Expenses relating to the acquisition and disposition of investments and specific participant transactions (i.e., loan setup, distribution request, etc.) were charged directly against the appropriate participant's account. These expenses were paid to service providers of the Plan and, therefore, qualify as party-in-interest transactions. The Company pays for certain administrative expenses not paid by the Plan which included the Plan's audit fee and certain recordkeeping expenses. The Company does not expect reimbursement from the Plan for payment of these administrative expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting. Effective December 9, 2021, the Plan's basis of accounting changed from the going concern basis to the liquidation basis of accounting and accordingly, the liquidation basis of accounting is used to present the financial statements.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Excess Contributions Payable

Contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with the corresponding reduction to contributions in the year in which the contributions were made. Refunds of excess contributions from prior periods are shown as distributions.

Contributions

Participant contributions were considered payable to the Plan upon the withholding of contributions from the participant's paycheck. There were no unfunded participant contributions as of March 31, 2022 and December 31, 2021.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net increase and decrease in fair value of investments includes interest, dividends, and realized and unrealized gains and losses on those investments. Interest income is recorded when received.

Notes Receivable from Participants

Notes receivable from participants were carried at their outstanding balance. Interest income was recognized when received. No allowance for credit losses has been recorded as of March 31, 2022 and December 31, 2021. If a participant ceased to make notes receivable repayments and the plan administrator deemed the participant notes receivable to be in default, the participant notes receivable balance was reduced and a benefit payment was recorded. Notes receivable from participants also qualified as party-in-interest transactions.

Payment of Benefits

Benefits were recorded when paid.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through January 13, 2023, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedules, including investments held and notes receivable from participants as of March 31, 2022 and December 31, 2021, and net change in fair value of investments and interest income for the periods then ended, was obtained or derived from information supplied to the plan administrator

and certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.) (John Hancock), the qualified institution.

4. Investments

Plan investments include shares of pooled separate accounts managed by John Hancock. John Hancock is a service provider of the Plan; therefore, transactions in these investments qualify as party-in-interest transactions.

Investments are exposed to various risks such as interest rate, currency, market, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cybersecurity attacks, or similar events.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2022 and December 31, 2021.

Fair value for pooled separate accounts is determined by prices published daily by the account manager, which is the net asset value (NAV) of the account (Level 1). Net asset value is determined by the fair value of the mutual funds, stocks, debt instruments and other securities in the accounts. Participants can trade the pooled separate accounts daily at the published NAV.

5. Income Tax Status

The Plan operated under a prototype plan offered by Ascensus LLC (Ascensus). The Internal Revenue Service determined and informed Ascensus by a letter dated June 30, 2020, that the Plan was designed in accordance with the applicable requirements of the Internal Revenue Code (IRC). The plan administrator believes that the Plan was designed and was operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and could change upon examination.
