Scope and nature of the ERISA Section 103(a)(3)(C) audit

We have performed audits of the financial statements of Revolution Retail Systems, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 1, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 through October 1, 2022, and the related notes to the financial statements.

Basis for opinion

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Revolution Retail Systems, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General and Eligibility

The Plan is a defined contribution plan established by Revolution Retail Systems, LLC (the “Company” “Plan Sponsor” or “Employer”) under the provisions of Section 401(a) of the United States Internal Revenue Code (the “IRC”), which includes a qualified cash or deferred arrangement as described in section 401(k) of the IRC, for the benefit of eligible employees of the Company. Fidelity Management Trust Company is the trustee and Fidelity Workplace Services LLC is the recordkeeper of the Plan.

Employees must be employed by the Company and satisfy certain age and service conditions under the Plan. Different minimum age and service requirements apply depending on the type of contributions made under the Plan. Participants that are at least 20½ years of age are immediately eligible to make deferrals and receive the employer match under the Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan was adopted January 1, 1997 to enable eligible employees to defer compensation and share in employer contributions, if any, and to save and invest funds for retirement.

Merger of Plan

Effective October 1, 2022, the Plan was merged into the Glory Global Solutions 401(k) Plan. All remaining assets of the Revolution Retail Systems, LLC 401(k) Plan were transferred to the Glory Global Solutions 401(k) Plan on October 3, 2022. The following information relates to the Plan prior to the merger.

Contributions

Participants direct the investment of their contributions into various investment options offered by the Plan and can contribute up to 100% of eligible compensation as defined by the plan, subject to Internal Revenue Service (“IRS”) limitations, which is \$20,500 for 2022. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions, subject to Internal Revenue Service (“IRS”) limitations, which was \$6,500 for 2022. Changes in elective deferral percentages may be made as of the beginning of each payroll during the Plan year. Participants may also rollover amounts representing distributions from other qualified benefit plans into the Plan. The Company matches contributions at a rate of 50% of each participant’s first 6% of compensation contributed as elective deferrals.

The Company may make additional profit-sharing contributions to the Plan each year at the sole discretion of the Company, within the limits of the IRC. Profit sharing contributions, if applicable, are made based on a flat percentage of each participant’s eligible compensation. Any eligible participant employed on the last day of the Plan year is eligible to receive an employer profit-sharing contribution. The Plan Sponsor made no profit-sharing contributions in 2022.

Payment of Benefits

Upon retirement, death, disability, or termination of service, a participant (or participant’s beneficiary in the event of death) may elect to receive a lump-sum distribution equal to the participant’s vested account balance. Unvested amounts are forfeited to the Plan.

A participant has the right to receive all or any portion of their vested account balance upon termination of service or attaining normal retirement age. Participants are allowed in-service and hardship withdrawals under certain conditions as specified by the Plan.

Vesting

Participants are immediately vested in their elective contributions and the earnings received on those contributions. Full and immediate vesting will also occur upon attainment of normal retirement age, death or disability. Participants who leave the Company before they are fully vested in the Company's contributions forfeit their non-vested portion. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 20% vested in the first year, 40% the second year, 60% the third year, 80% the fourth year, and becomes 100% vested after five years of continuous service.

Forfeited Accounts

Forfeitures are used at the discretion of the Company. For example, forfeitures may be used to pay Plan expenses. If any forfeitures are not used to pay Plan expenses, such forfeitures may be used to reduce employer contributions under the Plan. Forfeitures amounting to \$13,882 were used during 2022 to reduce employer contributions. Forfeitures were \$15,315 and \$2,182 for the period from January 1, 2022 through October 1, 2022 and for the year ended December 31, 2021.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, and an allocation of Plan earnings and losses. Allocations are based on account balances as defined. The participant determines both the amount to be invested and the allocation of the investment to one or more of the investment funds. The benefit to which a participant is entitled is limited to the amount of the participant's vested account balance.

Notes Receivable from Participants

Participants may borrow from their account the lesser of \$50,000 or 50% of their vested account balance, but not less than \$1,000. All loans are secured by the remaining balance of the participant's account and bear interest at a rate based on the prime interest rate plus 1% point determined at the time of loan origination. Any loan must be repaid within five years, unless such loan is for the purchase of a Participant's primary residence, in which case the repayment period may exceed five years. Participants may have one loan outstanding at a time. Principal and interest are paid ratably through bi-weekly payroll deductions.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

In preparing financial statements in conformity with U.S. GAAP, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan, and the remaining administrative expenses for recordkeeping are paid by the Company. The expenses paid by the Company are excluded from these financial statements. Administrative expenses paid by the Plan include loan issuance fees, loan maintenance fees, processing fees for remitting benefit payments to participants, and processing charges related to Qualified Domestic Relation Orders ("QDRO").

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2021 excess contributions to the applicable participants prior to April 15, 2022.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded for the period from January 1, 2022 through October 1, 2022 and for the year ended December 31, 2021. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

NOTE C - INFORMATION CERTIFIED BY THE TRUSTEES OF THE PLAN

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee has certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate:

- Investments at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits for the period from January 1, 2022 through October 1, 2022 and for the year ended December 31, 2021.
- Investment income (loss) and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the period from January 1, 2022 through October 1, 2022.

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 - Quoted prices in active markets for identical assets or liabilities. These are typically obtained from real-time quotes for transactions in active exchange markets involving identical assets.
- Level 2 - Quoted prices for similar assets and liabilities in active markets; quoted prices included for identical or similar assets and liabilities that are not active; and model-derived valuations in which all significant inputs and significant value drivers are observable in active markets. These are typically obtained from readily-available pricing sources for comparable instruments.
- Level 3 - Unobservable inputs, where there is little or no market activity for the asset or liability. These inputs reflect the Company's own beliefs about the assumptions that market participants would use in pricing the asset or liability, based on the best information available in the circumstances.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used for the period from January 1, 2022 through October 1, 2022 and for the year ended December 31, 2021.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trusts: Valued at NAV of the units of the collective trust. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities and is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in Fidelity funds, from which Fidelity generates investment management and other revenues. In addition, certain fees are paid by the Plan Sponsor to the trustees for administrative services provided to the Plan. These transactions qualify as exempt party-in-interest transactions.

The Plan has notes receivable from participants, which also qualify as exempt parties-in-interest transactions.

NOTE F - TERMINATION OF THE PLAN

Although it has not expressed any intention to do so, the Company has the right under the Plan agreement to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA and the IRC. In the event of Plan termination, participants will become 100% vested in their accounts and the assets of the Plan will be distributed to the participants in accordance with the Plan's provisions.

NOTE G - INCOME TAX STATUS

On June 30, 2020, the IRS stated the prototype adopted by the Plan, as then designed, qualified under Section 401(a) of the IRC. The Plan has been amended since receiving the opinion letter. However, the Company believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires the Company to evaluate tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not to be sustained upon examination by the IRS. The Company has analyzed the tax positions taken by the Plan, and has concluded that for the period from January 1, 2022 through October 1, 2022 and for the year ended December 31, 2021, there are no uncertain tax positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
