We have performed audits of the financial statements of the Health Decisions 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of April 7, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 to April 7, 2022, and the related notes to the financial statements.

## **NOTE 1: DESCRIPTION OF PLAN**

The following description of the Health Decisions 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a complete description of the Plan’s provisions.

### **General**

Health Decisions, Inc. (the “Company” or “Plan Sponsor”) established the Plan effective as of July 1, 1996. The Plan is a defined contribution plan covering substantially all employees of the Company who satisfy the Plan’s minimum age and service requirements. Employees who are age 21 or older are eligible to participate on the first day of the month following their employment date. The assets of the Plan are held by Great-West Trust Company, LLC (the “Trustee”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

In July 2021, the Company was acquired by Premier Research International LLC.

### **Plan Merger**

On March 1, 2022, an amendment to the Premier Research International LLC 401(k) Plan was signed, which authorized the merger of the Plan into the Premier Research International LLC 401(k) Plan. As of April 7, 2022, all account balances totaling \$6,384,196 were transferred from the Plan to the Premier Research International LLC 401(k) Plan.

### **Contributions**

Employees who have satisfied the service and eligibility requirements for Plan participation may elect to contribute up to 80% of their pretax compensation as defined by the Plan or the statutory limit defined by the Internal Revenue Code (“IRC”). The Plan also permits Roth contributions, and participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Rollover contributions from other qualified plans are allowed. Participants are automatically enrolled in the Plan at a deferral rate of 3% of compensation unless they opt out or opt for a different deferral amount. No employee contributions were made to the Plan for the period from January 1, 2022 to April 7, 2022.

The Company did not make any discretionary matching contributions for the period from January 1, 2022 to April 7, 2022.

## NOTE 1: DESCRIPTION OF PLAN (continued)

### Participants' Accounts

Each participant's account is credited with the participant's contribution, the Company's discretionary matching contribution, and allocations of Plan earnings and charged with an allocation of administrative expenses. Allocations are based on account balances, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants will automatically become 100% vested upon attainment of early retirement age (59½) or retirement due to disability or death.

Vesting in the Company's discretionary matching contributions for participants whose participation in the Plan was terminated prior to January 1, 2016, occurred according to the following schedule:

### **Forfeited Accounts**

Forfeitures represent nonvested discretionary matching contributions of participants who have terminated their employment with the Company. These forfeited amounts will be used to reduce employer matching contributions or pay Plan expenses. For the period from January 1, 2022 to April 7, 2022, no forfeited amounts were used. As of April 7, 2022, all remaining forfeiture balances totaling \$15,960 were transferred to the Premier Research International LLC 401(k) Plan. As of December 31, 2021, the forfeited nonvested amounts totaled \$11,400.

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loan term is up to five years for a general-purpose loan, but a longer term is permitted if the loan is for the purpose of purchasing a principal residence. The loan is secured by the balance in the participant's account and bears interest at the Prime rate plus 1%. A participant may have only one loan outstanding at any time. Principal and interest are paid ratably through payroll deductions.

### **Payment of Benefits**

On termination of service due to death, disability, retirement, or separation from service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan allows in-service distributions once a participant has attained age 59½. A terminated participant with a vested balance of \$5,000 or less may be automatically paid out by the Plan.

## **NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Benefits are recorded when paid.

## **NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (concluded)**

### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. The investment in the collective trust fund is valued using net asset value (“NAV”) as a practical expedient. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the plan document.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participants’ accounts and are included in administrative expenses. Investment-related expenses are included in the net depreciation in fair value of investments.

### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

### **NOTE 3: INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

All investment information disclosed in the accompanying financial statements, including investments held and notes receivable from participants as of December 31, 2021, net depreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants for the period from January 1, 2022 to April 7, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Trustee.

### **NOTE 4: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### NOTE 4: FAIR VALUE MEASUREMENTS (concluded)

Following is a description of the valuation methodology used for investments measured at fair value. All investments were liquidated as of April 7, 2022, and transferred to the Premier Research International LLC 401(k) Plan.

**Mutual funds** - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### Investments in Entities That Use NAV as a Practical Expedient

As of December 31, 2021, the fair value of the collective trust fund, valued at NAV, totaled \$878,689. The value of this fund is measured using NAV as a practical expedient and has been excluded from the fair value hierarchy. The collective trust fund has a daily redemption frequency and a redemption notice period of no longer than 12 months. There are no unfunded commitments. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that security liquidations will be carried out in an orderly, business manner. The collective trust fund was liquidated as of April 7, 2022, and transferred to the Premier Research International LLC 401(k) Plan.

### **NOTE 5: RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

The Plan invests in shares of mutual funds and a collective trust fund managed by the Trustee. Transactions in such investments qualify as party in interest transactions, which are allowable under ERISA.

Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing rather than a direct payment. The Plan made direct payments to the Trustee for recordkeeping services and contract administration fees of \$5,212, which were not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

### **NOTE 6: INCOME TAX STATUS**

The Plan Sponsor adopted the Great-West Trust Company Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan (the "Prototype Plan"). The Prototype Plan obtained its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the Prototype Plan, as then designed, was in compliance with the applicable requirements of the IRC. The plan administrator believes that the Plan was designed and was operated in compliance with the applicable requirements of the IRC through the date of the Plan merger. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by federal and state tax authorities.

### **NOTE 7: SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through January 24, 2023, the date these financial statements were available for issuance, and determined that no events have occurred that would require adjustment to or disclosure in these financial statements.


