We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Capital Pumping, LP 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan and Trust Agreement (Plan Document) for a more complete description of the Plan's provisions.

*General*

The Plan is a profit sharing plan, established January 1, 2002 and covers all eligible employees of Capital Pumping, LP (Plan Sponsor or Company). Employees are eligible to participate in the Plan once they have attained age twenty-one and completed sixty days of service. Plan entry date is the first day of the month coinciding with or next following satisfaction of eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Plan Merger*

During 2021, the Trustees of Capital Pumping, LP 401(k) Profit Sharing Plan approved the merger of this Plan, effective November 15, 2021. As of January 25, 2022, all account balances were transferred to the Brundage-Bone Concrete Pumping 401(k) Retirement Savings Plan.

*Contributions*

Participants may make voluntary salary reductions (participant contributions) up to the maximum amount allowed by the IRS. For 2022, this deferral limit was \$20,500. Participants may also rollover amounts from other qualified plans. Participants over the age of 50 are eligible for catch up contributions. Participants are automatically enrolled in the Plan upon satisfaction of eligibility requirements at a deferral rate of 3% of eligible gross compensation.

The Company may make discretionary matching contributions to the Plan, an amount determined by resolution of the owner or other governing authority of the Company. Such discretionary matching contributions will be allocated or divided among participants eligible to share in the contribution for the Plan year. In applying the matching contribution, participants' salary deferrals that exceed 7% of eligible compensation for such period will not be considered. Participants will always share in the matching contribution regardless of the amount of service they complete during the Plan Year. During 2022, the Company did not make discretionary matching contributions.

The Company may make profit sharing contributions to the Plan, an amount determined by resolution of the owner or other governing authority of the Company. Such profit sharing contributions will be allocated or divided among participants eligible to share in the contribution for the Plan year. Participants must complete one year of service during the Plan Year in order to share in the profit sharing contributions. During 2022, the Company did not make profit sharing contributions.

**NOTE 1 - DESCRIPTION OF THE PLAN, CONTINUED**

*Participant Accounts*

Individual accounts are maintained to record participant contributions, rollover contributions, discretionary matching contributions, profit sharing contributions, and earnings thereon for each participant. Discretionary matching and profit sharing contributions are referred to as Company contributions. The benefit to which a participant is entitled is the total benefit, which can be provided from the vested portion of these individual accounts.

*Vesting*

Upon entry into the Plan, participants are 100 percent vested in their salary deferral contributions, rollover contributions, safe harbor contributions, and earnings thereon. Vesting for Company contributions and earnings thereon is based on years of service as follows:

*Notes Receivable from Participants*

Participants may borrow from their accounts. The amounts borrowed are limited to the lesser of \$50,000 or one half of the participant's vested account balance and must be greater than \$1,000. Loans must bear a reasonable rate of interest and must be repaid within five years.

*Payment of Benefits*

On termination of service due to death, disability, or retirement, a participant may request a distribution of their fully vested account balance from the Plan Administrator. Participants may elect to withdraw all, or a portion from their fully vested account while still employed, upon attainment of age 59 1/2. Participants that have terminated employment and have a vested balance less than \$5,000 will receive a distribution as soon as administratively feasible. Benefits are recorded when paid.

*Forfeited Accounts*

Forfeited balances will be used to pay plan expenses first and then to offset Company contributions. Forfeitures as of and for the period ended January 25, 2022 and December 31, 2021 were approximately \$0, respectively. During 2022, no forfeitures were used to pay Plan expenses or reduce Company contributions.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Subsequent Event*

Management has evaluated subsequent events through January 17, 2023, the date the financial statements were available to be issued.

*Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

*Basis of Accounting*

The financial statements of the plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

*Investment Valuation and Income Recognition*

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

*Fair Value Measurements*

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

*Administrative Costs*

All expenses of maintaining the Plan are paid out of the Plan assets or by the Plan Sponsor. Investment-related expenses are included in net appreciation of fair value of investments.

*Market Risk*

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Furthermore, due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes, could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE 3 – INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. John Hancock Life Insurance Company (John Hancock), the custodian of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits for the period ended January 25, 2022 and the year ended December 31, 2021 and the statement of changes in net assets available for benefits for the period of January 1, 2022 through January 25, 2022.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobserved inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Pooled separate accounts* – Valued at the net asset value (NAV) of units held by the Plan at year end. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it was determined to be probable that the funds will sell the underlying investments for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

**NOTE 5 - TAX STATUS**

The Plan has received an opinion letter from the Internal Revenue Service dated March 31, 2014 stating that the written form of the underlying prototype plan document is qualified under Section 401(a) of the Internal Revenue Code (the Code), and that any employer adopting this form of the Plan will be considered to have a plan qualified under Section 401(a) of the Code. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

The IRS has determined and informed the Plan sponsor by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter dated March 31, 2014, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

John Hancock holds the Plan's assets and performs the record-keeping. Loren D. Stark Company performs the third party administration. Investment advising is performed by AssuredPartners. Therefore, any investment or administrative fees paid during the year to these parties qualify as party-in-interest transactions.

## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Capital Pumping, LP 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits for the period ended January 25, 2022 and the year ended December 31, 2021, the related statement of changes in net assets available for benefits for the period of January 1, 2022 through January 25, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Capital Pumping, LP 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the period ended January 25, 2022 and the year ended December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. ## **Responsibilities of Management for the Financial Statements**

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Capital Pumping, LP 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan and Trust Agreement (Plan Document) for a more complete description of the Plan's provisions.

*General*

The Plan is a profit sharing plan, established January 1, 2002 and covers all eligible employees of Capital Pumping, LP (Plan Sponsor or Company). Employees are eligible to participate in the Plan once they have attained age twenty-one and completed sixty days of service. Plan entry date is the first day of the month coinciding with or next following satisfaction of eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Plan Merger*

During 2021, the Trustees of Capital Pumping, LP 401(k) Profit Sharing Plan approved the merger of this Plan, effective November 15, 2021. As of January 25, 2022, all account balances were transferred to the Brundage-Bone Concrete Pumping 401(k) Retirement Savings Plan.

*Contributions*

Participants may make voluntary salary reductions (participant contributions) up to the maximum amount allowed by the IRS. For 2022, this deferral limit was \$20,500. Participants may also rollover amounts from other qualified plans. Participants over the age of 50 are eligible for catch up contributions. Participants are automatically enrolled in the Plan upon satisfaction of eligibility requirements at a deferral rate of 3% of eligible gross compensation.

The Company may make discretionary matching contributions to the Plan, an amount determined by resolution of the owner or other governing authority of the Company. Such discretionary matching contributions will be allocated or divided among participants eligible to share in the contribution for the Plan year. In applying the matching contribution, participants' salary deferrals that exceed 7% of eligible compensation for such period will not be considered. Participants will always share in the matching contribution regardless of the amount of service they complete during the Plan Year. During 2022, the Company did not make discretionary matching contributions.

The Company may make profit sharing contributions to the Plan, an amount determined by resolution of the owner or other governing authority of the Company. Such profit sharing contributions will be allocated or divided among participants eligible to share in the contribution for the Plan year. Participants must complete one year of service during the Plan Year in order to share in the profit sharing contributions. During 2022, the Company did not make profit sharing contributions.

**NOTE 1 - DESCRIPTION OF THE PLAN, CONTINUED**

*Participant Accounts*

Individual accounts are maintained to record participant contributions, rollover contributions, discretionary matching contributions, profit sharing contributions, and earnings thereon for each participant. Discretionary matching and profit sharing contributions are referred to as Company contributions. The benefit to which a participant is entitled is the total benefit, which can be provided from the vested portion of these individual accounts.

*Vesting*

Upon entry into the Plan, participants are 100 percent vested in their salary deferral contributions, rollover contributions, safe harbor contributions, and earnings thereon. Vesting for Company contributions and earnings thereon is based on years of service as follows:

6	100%

*Notes Receivable from Participants*

Participants may borrow from their accounts. The amounts borrowed are limited to the lesser of \$50,000 or one half of the participant's vested account balance and must be greater than \$1,000. Loans must bear a reasonable rate of interest and must be repaid within five years.

*Payment of Benefits*

On termination of service due to death, disability, or retirement, a participant may request a distribution of their fully vested account balance from the Plan Administrator. Participants may elect to withdraw all, or a portion from their fully vested account while still employed, upon attainment of age 59 1/2. Participants that have terminated employment and have a vested balance less than \$5,000 will receive a distribution as soon as administratively feasible. Benefits are recorded when paid.

*Forfeited Accounts*

Forfeited balances will be used to pay plan expenses first and then to offset Company contributions. Forfeitures as of and for the period ended January 25, 2022 and December 31, 2021 were approximately \$0, respectively. During 2022, no forfeitures were used to pay Plan expenses or reduce Company contributions.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Subsequent Event*

Management has evaluated subsequent events through January 17, 2023, the date the financial statements were available to be issued.

*Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

*Basis of Accounting*

The financial statements of the plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

*Investment Valuation and Income Recognition*

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

*Fair Value Measurements*

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, CONTINUED**

*Administrative Costs*

All expenses of maintaining the Plan are paid out of the Plan assets or by the Plan Sponsor. Investment-related expenses are included in net appreciation of fair value of investments.

*Market Risk*

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Furthermore, due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes, could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE 3 – INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. John Hancock Life Insurance Company (John Hancock), the custodian of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits for the period ended January 25, 2022 and the year ended December 31, 2021 and the statement of changes in net assets available for benefits for the period of January 1, 2022 through January 25, 2022.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobserved inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

**NOTE 4 – FAIR VALUE MEASUREMENTS, CONTINUED**

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Pooled separate accounts* – Valued at the net asset value (NAV) of units held by the Plan at year end. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it was determined to be probable that the funds will sell the underlying investments for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

**NOTE 5 - TAX STATUS**

The Plan has received an opinion letter from the Internal Revenue Service dated March 31, 2014 stating that the written form of the underlying prototype plan document is qualified under Section 401(a) of the Internal Revenue Code (the Code), and that any employer adopting this form of the Plan will be considered to have a plan qualified under Section 401(a) of the Code. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

The IRS has determined and informed the Plan sponsor by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter dated March 31, 2014, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

John Hancock holds the Plan's assets and performs the record-keeping. Loren D. Stark Company performs the third party administration. Investment advising is performed by AssuredPartners. Therefore, any investment or administrative fees paid during the year to these parties qualify as party-in-interest transactions.
