NOTE 1. DESCRIPTION OF PLAN

The following description of the Human Resource Training, Inc. 401(k) Profit Sharing Plan, (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established for participation on June 22, 1999 and restated on September 1, 2014, and has been amended from time to time since that date. It is a defined contribution plan covering all eligible employees at the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Reporting Period

The accompanying financial statements include the statements of net assets available for benefits as of May 31, 2022 and December 31, 2021, and the statement of changes in net assets for the period January 1, 2022 through May 31, 2022. Effective May 31, 2022, all of the Plan's net assets were transferred to the Pathways 401(k) Plan, following the acquisition of Human Resource Training, Inc. by Pathways Healthcare.

Eligibility

Under the provisions of the Plan, each employee shall be eligible to participate in the Plan upon completing one year of service.

Contributions

Each year, participants may elect to contribute to the Plan through tax-deferred salary deferrals, as defined by the Plan, up to a statutory maximum determined by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("rollover"). Participants direct the investments of all contributions into various investment options offered by the Plan.

Company Matching Contributions

Each year, the Company contributes a safe harbor contribution of 3% of the participant's salary. The safe harbor contributions totaled \$18,848 during the reporting period. The Company may also make qualified non-elective contributions at its discretion. For the reporting period, the Company elected not to make a qualified non-elective matching contribution.

Vesting

Participants are immediately vested in their contribution and the Company's safe harbor contributions plus actual earnings thereon. Vesting in the Company's qualified non-elective contributions is based on years of service. A participant is vested 50% a year beginning with two years of service and is fully vested after three years of credited service.

Hardship Withdrawal

In certain situations, as defined in the Plan agreement and with approval of the Plan Administrator, participants may make hardship withdrawals.

Participant Accounts

All investment options are participant directed. Each participant's account is credited with the participant's contributions and allocations of the Company's contributions, and Plan earnings, and reduced for any Plan losses and administrative expenses. The benefit to which a participant is entitled is the benefit from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms can be no longer than five years. However, at the Plan Administrator's discretion, for the purchase of a primary residence, loans can be repaid up to 15 years. The loans are collateralized by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates in accordance with the Plan's provisions. Principal and interest are paid ratably through payroll deductions. At May 31, 2022 there were no notes receivable outstanding.

Payment of Benefits

On termination of service due to death, disability, or retirement a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in their account, or annual installments over a 10-year period, in accordance with the provisions of the Plan. In the event that a participant dies before retirement, their beneficiary will receive the value of the participant's account balance in a lump-sum distribution, less the value of outstanding loans made to the participant. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump sum distribution.

Forfeitures

Forfeitures of Company contributions may be used to first restore forfeitures of participants reemployed under certain conditions, and then reduce any administrative expenses and Company's contributions. At May 31, 2022 and December 31, 2021, forfeited non-vested accounts totaled \$0 and \$1,878, respectively. During the reporting period plan expenses were reduced by \$1,878 from forfeited non-vested accounts.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Estimates

The financial statements of the Plan are being prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and reinvested interest and dividends.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Notes receivable from participants are secured by the participant's account, therefore no allowance for credit losses has been recorded as of May 31, 2022 and December 31, 2021.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Fees related to the administration of participants' activities are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

Concentration of Credit Risk and Financial Instruments

Financial instruments which potentially subject the Plan to concentrations of credit risk consist of deposits and securities held by a broker.

NOTE 3. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 1 and Level 3 inputs for the periods presented.

Level 2 Fair Value Measurements

The fair value of pooled separate accounts is based on the daily closing price of the underlying mutual fund in which the account is invested. The mutual funds are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. Pooled separate accounts held by the Plan are deemed to be actively traded.

NOTE 5. TAX STATUS OF THE PLAN

The IRS has determined and informed the Company in a letter dated March 31, 2014, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan Administrator

and Sponsor's management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believe the Plan is qualified and is tax-exempt.

During the reporting period, it was determined that the fidelity bond held by the Plan was insufficient to be in full compliance with ERISA requirements.

The Plan follows the provisions of ASC 740, *Income Taxes* of the FASB Accounting Standards Codification. The Plan believes it has no uncertain tax positions that qualify for either recognition or disclosure. As of May 31, 2022, due to statutes of limitations, the Plan is no longer subject to examination of its Form 5500 by the IRS for years prior to 2018.

NOTE 6. TERMINATION OF THE PLAN

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, including interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

In early 2020, the United States was adversely impacted by the outbreak of Novel Coronavirus ("COVID-19"). The virus was declared a Pandemic and a public health emergency. As a result, the Pandemic adversely impacted global commercial activity and contributed to significant volatility in financial markets domestically and globally. The outbreak may continue to adversely impact global commercial activity and financial markets for an indeterminate period of time.

NOTE 8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan investments consist of pooled separate accounts managed by Great-West Life & Annuity Insurance Company on behalf of Talcott Resolution Life Insurance Company ("Great-West"). Great-West is the Custodian and Campbell Pension Services ("Campbell") is the third-party administrator as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Fees paid by the Plan to Great-West and Campbell during the reporting period. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 9. SEPARATED PARTICIPANTS

At May 31, 2022 and December 31, 2021, there were no amounts allocated to accounts of persons who had elected to withdraw from the Plan but have not yet been paid.

NOTE 10. SUBSEQUENT EVENTS

Subsequent events have been evaluated through January 13, 2023, which is the date the financial statements were available to be issued.



