Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Maxair Mechanical 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of March 1, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 through March 1, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of March 1, 2022 and December 31, 2021, and for the period from January 1, 2022 through March 1, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Emphasis of Matter – Plan Merger

As discussed in Note 1 to the financial statements, the Plan merged into the Service Logic 401(k) Plan effective March 1, 2022. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

1. Plan Description

The following brief description of the Maxair Mechanical 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan was a defined contribution plan established January 1, 2008 and most recently amended and restated effective May 1, 2015, covering substantially all employees of Maxair Mechanical, LLC (the “Company”). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Plan Merger

Effective January 1, 2022, the Company became a participating employer in the Service Logic 401(k) Plan (the “SL Plan”) and as a result, the Plan was frozen to new participants and future contributions. Effective March 1, 2022, assets of approximately \$5.4 million, including notes receivable from participants, were merged through a direct trust-to-trust transfer from the Plan to the SL Plan. To facilitate the transition, participants of the Plan were not able to direct or diversify investments to their accounts, obtain a loan or distribution or perform certain other administrative changes from February 15, 2022 through April 3, 2022.

Issuer, Recordkeeper and Administration of the Plan

The recordkeeper of the Plan was Securian, and the issuer of the insurance contracts held by the Plan was Minnesota Life Insurance Company (“Issuer” or “Minnesota Life”). The trustee of the Plan was an officer of the Company. The administrator of the Plan was the Company. Minnesota Life held all assets of the Plan in accordance with the provisions of the agreement with the Company. The Company determined the appropriateness of the Plan’s investment offerings and monitored performance.

Participant’s Accounts and Investment Options

Each participant’s account was credited with an allocation of the Plan earnings or losses. Each participant’s account was charged with withdrawals and expenses. Participants were charged an administrative fee for participant requested transactions. Earnings or losses from investment funds were allocated to each participant’s account in the proportion that the balance of each participant’s account bore to the total balance of all participants in each fund.

Participants could direct the investment of their account balances into various pooled separate account investment options offered by the Plan. Participants could make investment election changes at any time. The benefit to which a participant was entitled was the benefit that could be provided from the participant’s vested balance.

Eligibility

An employee of the Company was eligible to participate in the Plan on the first day of the plan year quarter coinciding with the date eligibility requirements were satisfied. An employee was eligible to participate in the Plan after attainment of age 21 years and completion of six months of service with at least 1,000 hours.

Non-resident aliens who received no earned income within the United States and union employees, except for employees represented by UA Local 72 and SMART Local 85, were not eligible to make elective deferral contributions.

Non-resident aliens who received no earned income within the United States and union employees, regardless of union representation, were not eligible to receive the safe harbor contribution and discretionary-profit sharing contribution.

Contributions

Participants could contribute on a pre-tax basis or after-tax Roth basis up to 100 percent of their eligible compensation, subject to certain Internal Revenue Code (“IRC”) limitations. Participants who had attained the age of 50 by the last day of the plan year could elect to make catch-up contributions, as defined by the Plan, subject to IRC limitations. Participants could terminate or change their salary deferral agreements according to procedures and limitations as determined by the Plan Document.

The Plan included an automatic-enrollment provision whereby eligible employees would be automatically enrolled in the Plan at a 3 percent pre-tax deferral rate on their date of plan entry, as defined in the Plan Document. Participants could affirmatively elect a different percentage or elect not to contribute to the Plan. Participants who were governed by a collective bargaining agreement were required to affirmatively elect to participate in Plan to ensure compliance with their respective collective bargaining agreement.

The Company could make an annual safe harbor employer contribution equal to at least 3% of a participant’s eligible compensation, in order to maintain its safe harbor status. For the year ended December 31, 2021, the Company made a safe harbor contribution equal to 3% of participant’s eligible compensation. As of December 31, 2021, safe harbor contributions, net of forfeitures used, of \$172,100, was due to the Plan.

The Company could make an employer discretionary profit-sharing contribution to eligible participants who were employed on the last day of the Plan year. The Company did not make a discretionary employer profit-sharing contribution for the year ended December 31, 2021.

Rollover contributions transferred from other qualified retirement plans or from Individual Retirement Accounts (“IRA”) were accepted as permitted by the Plan Document.

Notes Receivable from Participants

Participants could borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested interest in the Plan. Participants could have two notes outstanding at any given time. Notes bore a reasonable rate of interest as determined by the Plan Administrator by reviewing the interest rates charged for similar types of loans by other lenders. The interest rate remained fixed throughout the duration of the note. All notes were repaid over a five-year period unless it was for the purchase of a principal residence in which case the Plan Administrator may have permitted a longer repayment period. The notes were subject to certain restrictions, as defined by the Plan Document, and applicable restrictions under the IRC. Notes were considered delinquent 90 days after due. Outstanding notes receivable of approximately \$104,000, were transferred from the Plan to the SL Plan on March 1, 2022.

Vesting

Participants pre-tax, after-tax Roth, catch-up and rollover contributions were 100 percent vested at all times. The Company's employer safe harbor contributions were 100 percent vested at all times. The Company's employer discretionary profit-sharing contributions vested as follows:

Participants became fully vested upon death, disability, or termination of the Plan.

Forfeitures

Forfeitures could be first be used to reduce administrative expenses paid by the Plan. Any remaining balance could be used to reduce future employer contributions payable under the Plan. The forfeitures account had a balance of \$0 and \$15,758 at March 1, 2022 and December 31, 2021, respectively. For the period from January 1, 2022 through March 1, 2022, the Plan used \$15,747 to offset the 2021 employer contribution due.

Benefit Payments

A participant's vested interest in the Plan was payable upon termination of service due to death, disability, normal retirement (age 62), early retirement (age 55), or termination of employment. Upon termination of service, a participant could elect to (1) receive a lump-sum amount equal to the vested value of the participant's account; (2) rollover the amount to another qualified retirement plan or an IRA; or (3) leave the account in the Plan up to age 72, at which time one of the above distribution options had to be selected, if no longer employed.

For terminated participants whose account balance was less than \$5,000, the account balance would be rolled over into an IRA in the name of the participant, if the participant did not elect another form of distribution.

Hardship withdrawals and certain other in-service withdrawals at age 59½ were also allowed by the Plan, if certain criteria were met.

Plan Termination

The Company had the right under the Plan Document to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. See *Plan Merger* above for discussion regarding the Plan merger into the SL Plan in 2022.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan’s investments were stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). The Company determined the Plan’s valuation policies utilizing information provided by the Minnesota Life Insurance Company. See Note 4, *Fair Value Measurements* for a discussion of fair value measurements.

Purchases and sales were recorded on a trade-date basis. Dividend income was recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments included the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance. Any accrued but unpaid interest was de minimis. If a participant ceased to make loan repayments and the plan administrator deemed the participant loan to be in default, the participant loan balance was reduced, and a benefit payment was recorded.

Contributions

Participant deferral contributions were recognized in the plan year during which the Company made the respective payroll deduction from the participant's compensation. Safe harbor contributions and discretionary-profit sharing contributions were recognized in the plan year during which the participant earned the eligible compensation used in the calculation.

Benefit Payments

Benefit payments to participants were recorded when paid. As of March 1, 2022 and December 31, 2021, there were no pending distributions.

Administrative Expenses

Certain fees (primarily loan and distribution) were charged directly to the participant's account and were included in administrative expenses. Investment related expenses (in the form of an expense ratio) were included in net appreciation (depreciation) of fair value of investments. All other expenses of the Plan for the period from January 1, 2022 through March 1, 2022 were paid by the Company and are excluded from these financial statements.

3. Certified Investment Information

The Plan Administrator elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C), pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulation for Reporting and Disclosure under ERISA. Accordingly, Minnesota Life, a qualified institution, has certified that the following data included in the accompanying financial statements is complete and accurate:

- Investments as reported in the Statements of Net Assets Available for Benefits as of December 31, 2021;
- Investment income as reported in the Statement of Changes in Net Assets Available for Benefits for the period from January 1, 2022 through March 1, 2022;
- Investment information included in the Notes to Financial Statements.

At the request of the Plan Administrator, the Plan's independent auditors did not perform any auditing procedures with respect to this certified information, except for comparing such information to the related information included in the financial statements, reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

4. Fair Value Measurements

Accounting Standards Codification (“ASC”) 820, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Insurance Company Pooled Separate Accounts (PSAs): Valued based on publicly quoted pricing input which is used in determining the net asset value (“NAV”) of the pooled separate account, which is not publicly quoted. The value of each pooled separate account is determined at the close of each business day based on the fair value of the underlying assets, which can consist of a single mutual fund or multiple securities. The NAV, as provided by Minnesota Life, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the PSA will sell the investment for an amount different from the reported net asset value. These PSAs are direct filing entities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with Subtopic 820-10, investments that were measured at NAV per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy.

5. Income Tax Status

Effective May 1, 2015, the Plan adopted a Volume Submitter Profit Sharing Plan with CODA (“Volume Submitter”). The Volume Submitter received an advisory letter from the Internal Revenue Service (“IRS”) dated March 31, 2014 indicating that the form of the Volume Submitter was designed in accordance with applicable sections of the IRC. The Plan Administrator believes that the Plan, as amended and restated, was designed and operated in compliance with the applicable provisions of the IRC and the Plan and related trust was tax-exempt; therefore, no provision for income taxes have been included in the accompanying financial statement.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Related Party and Party-In-Interest Transactions

Plan investments were units of pooled separate accounts issued by Minnesota Life, an affiliated company of Securian. Administrative fees of \$420 were paid from the Plan to Minnesota Life during the period from January 1, 2022 through March 1, 2022. Minnesota Life also received other indirect fees net with the earnings of the pooled separate accounts. The Plan also issued loans to participants which were secured by the vested balance of the participants’ accounts. The above transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

7. Concentrations, Risks and Uncertainties

The Plan provided for various investments in pooled separate accounts. Investments, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. As further discussion in Note 1, *Plan Merger*, the Plans assets were liquidated and transferred to the SL Plan on March 1, 2022.
