Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We are required to be independent of VariQ Corporation 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As described in Note 1 to the financial statements, VariQ Corporation was acquired by Capgemini Government Solutions and the Plan was terminated on November 29, 2021, and management determined liquidation to be imminent. As a result, the Plan used the liquidation basis in presenting the financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about VariQ Corporation 401(k) Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of VariQ Corporation 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about VariQ Corporation 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

1. Description of Plan

The following description of the VariQ Corporation 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering substantially all employees of VariQ Corporation (the Company) who had reached 21 years of age and had worked 240 hours within the first three months of employment. An employee was enrolled in the Plan on the first day of the quarter after meeting service requirements. Management of the Company controlled and managed the operation and administration of the Plan. Great-West Trust Company, LLC and Great-West Life & Annuity Insurance Company (Great-West) served as the custodians of the Plan. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan termination

In 2021, the Company was acquired by Capgemini Government Solutions. As a result, the Board of Directors of the Company, resolved to terminate the Plan during 2021. All participants became 100% vested in their accounts at that time. The plan administrator resolved to terminate the Plan effective November 29, 2021, during which, all participants were notified. The plan assets were fully distributed from the plan on May 2, 2022. Active participants became eligible to participate in Capgemini retirement plans.

Plan Merger

In 2020, Rivet Logic 401(K) Profit Share net assets available for benefits were merged into the Plan. The Company acquired Rivet Logic Corporation and elected to merge Rivet Logic 401(K) Profit Share for administrative purposes.

Contributions

Each year prior to plan termination, participants may have contributed up to 100% of annual compensation, as defined in the Plan, subject to Internal Revenue Code (IRC) limitations. Participant salary deferrals may have been traditional 401(k) (pre-tax) or Roth 401(k) (after-tax). Employees were automatically enrolled to contribute unless an affirmative election was made for another amount. The automatic deferral was 3% of compensation for each payroll period, and the automatic deferral was increased by 1% of compensation each year beginning in the participant's third year, up to a maximum of 6%. Participants who have attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants were able to contribute amounts representing distributions from other qualified plans and certain individual retirement accounts. The Company provided a safe harbor matching contribution of 100% of each participant's contributions up to 3% of annual compensation, and 50% of each participant's contributions on the next 1% of annual compensation. Additional discretionary amounts and profit-sharing contributions were available to be made at the discretion of the Company. No additional Company contributions or profit-sharing contributions were made in 2022 and 2021. Contributions are subject to certain limitations.

Investment options

Participants directed the investments of their accounts into various investment options offered by the Plan. The Plan offered mutual funds and an investment contract with an insurance company as investment options for participants.

Participant accounts

Each participant's account was credited with the participant's contribution and allocations of the Company's contributions, and plan earnings (losses), and charged with benefit payments, transaction fees related to notes receivable from participants, distributions, and allocations of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled is the benefit that could have been provided from the participant's vested account.

Vesting

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts was based on years of service, as defined by the Plan. Participants became vested in nondiscretionary employer contributions after two years of service.

Notes receivable from participants

Participants were able to borrow from their fund accounts at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account and bore interest at rates which were commensurate with the local prevailing rates as determined by the plan administrator. At December 31, 2021, outstanding loans bore interest rates ranging from 4.25% to 6.5%. Principal and interest were paid ratably through payroll deductions.

Payment of benefits

On termination of service, a participant may have elected to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or installment options as provided by the Plan. Hardship distributions were available from participant deferral accounts with demonstration of financial hardship. In-service distributions were available from fully vested sources once a participant reached age 59½.

Forfeitures

At May 2, 2022 and December 31, 2021, forfeited nonvested accounts were \$0. During the period from January 1, 2022 to May 2, 2022, and the year ended December 31, 2021, forfeitures of \$0 and \$87,597, respectively, were used to reduce Company contributions.

2. Summary of Significant Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Due to the Plan termination, liquidation was determined to be imminent before the end of the 2021 plan year. Accordingly, the Plan's financial statements have been prepared using the liquidation basis of accounting in accordance with FASB ASC 205-30. The liquidation basis requires the Plan to accrue and separately present the costs that it expects to incur and the income (loss) that it expects to earn during the expected duration of the liquidation, including any costs associated with sale or settlement of those assets and liabilities. For the year ended December 31, 2021, the following income and expense were accrued:

Use of estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and assumptions.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodians. See Note 3 for discussion of fair value measurements.

Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance, plus interest accrued thereon. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of benefits

Benefits are recorded upon distribution.

Administrative expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (notes receivable from participants and distributions) are charged directly to the participant's account. Expenses relating to investment advisory and account maintenance services are allocated ratably to participants.

Subsequent events

The Plan has evaluated subsequent events through January 25, 2023, the date the financial statements were available to be issued.

3. Fair Value Measurements

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

Level 1: Observable inputs such as quoted prices in active markets.

Level 2: Inputs other than quoted prices in active markets that are directly or indirectly observable.

Level 3: Unobservable inputs about which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in methodologies used at May 2, 2022 and December 31, 2021. Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The differences between the certified balance above and the amounts reported on the accompanying financial statements are due to the accrual of income (loss) and expenses related to the liquidation basis of accounting. See Note 2.

5. Investment Contract with Insurance Company

The Plan held a traditional investment contract. This contract met the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer was contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rate was based on a formula agreed upon with the issuers, but it may not have been less than zero.

The Plan's ability to have received amounts due in accordance with the fully benefit-responsive investment contracts was dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limited the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the plan document (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) premature termination of the contracts, (4) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (5) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator did not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, before termination date.

In addition, certain events allowed the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material representation or (4) a material amendment to the agreements without the consent of the issuer.

6. Exempt Party-in-Interest Transactions

Certain plan assets were invested in funds managed by Great-West Trust Company, LLC, Great-West Life & Annuity Insurance Company (Great-West) or its affiliates. These transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid to the custodians and investment advisors by the Plan for participant-initiated transactions were \$38,291 and \$12,312 for the period of January 1, 2022 to May 2, 2022, and \$55,535 and \$33,476 for the year ended December 31, 2021, respectively.

7. Tax Status

The Plan has not obtained a determination letter from the Internal Revenue Service (IRS) stating that the Plan was in compliance with the applicable requirements of the IRC. The Plan is relying on the IRS approval of the non-standardized prototype plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated June 6, 2020, that the prototype plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of May 2, 2022 and December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
