## Independent Auditors' Report

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of the Cobham Orchard Park Defined Contribution Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## *Notes to Financial Statements*

### 1. Description of Plan

The following description of the Cobham Orchard Park Defined Contribution Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** – The Plan is a defined contribution plan established on January 1, 2004, and is sponsored by Cobham Mission Systems Orchard Park Inc. (the “Plan Sponsor”). The Plan was restated as of January 1, 2012. The Plan covers substantially all employees of the Plan Sponsor who began employment after January 1, 2004, and have completed one month of service and are at least 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective June 14, 2012, the Plan was amended to provide that no employee of Cobham Management Services Inc. (“CMSI”) is eligible to become a participant after June 14, 2012, and the participation of an employee of CMSI hired on or after January 1, 2011 will be frozen effective June 30, 2012. Effective January 1, 2019, the Plan was amended to allow employees not already participating in the Plan, who are employed by the Plan Sponsor as of January 1, 2019, and were participants of the Cobham Orchard Park Defined Benefit Plan (formally known as the Carleton Technologies Inc. Employees’ Retirement Plan) as of December 31, 2018, to become eligible participants in the Plan.

The Plan Sponsor was acquired by Eaton Corporation in June 2021. On January 24, 2022, the Plan Sponsor formally approved to merge the assets of the Plan into the Eaton Savings Plan, with an effective merger date of April 15, 2022, with the Eaton Savings Plan being the surviving plan (the “Eaton Plan”). All assets (\$9,359,752) from the Plan were transferred to the Eaton Plan on April 18, 2022. The interest of each participant in the Plan is governed by the provisions of the Eaton Plan as of the April 15, 2022 effective date of merger.

**Contributions** – The Plan is funded with Plan Sponsor contributions which are invested in the trust fund in accordance with the provisions of this Plan and the trust agreement. Plan Sponsor contributions are calculated based on a participant’s years of service and also the age of the participant. Rollover contributions are accepted with the prior approval of the Plan Sponsor.

The Plan Sponsor will contribute to accounts of eligible participants, an amount based on the participant’s age as of January 1 of the applicable Plan year. The percentage is increased for each year of age of the participant, starting at .03% of a participant’s covered compensation at age 21, up to a maximum amount of 6.5% of covered compensation at age 65 and older.

### 1. Description of Plan (continued)

During each applicable Plan year, the Plan Sponsor will also contribute to each qualified participant an amount determined using the following schedule:

There were no Plan Sponsor contributions made during the period ended April 30, 2022.

**Participant Accounts** – Individual accounts are maintained for each Plan participant. Participant accounts are increased by Plan Sponsor contributions and the participant’s share of Plan earnings. Participant accounts are decreased by benefits paid to participants and the participant’s share of Plan expenses and losses. The allocation of earnings and losses to participant accounts is based upon the value of an individual account in relation to the total assets of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting** – Participants vest in Plan Sponsor contributions at 25% for each year of service and become fully vested after four years of service. Participants also become fully vested at age 65 or upon disability or death.

**Forfeitures** – Forfeitures of non-vested benefits are used to reduce future Plan Sponsor contributions or are used to pay administrative expenses. Forfeitures in the amount of \$15,721 were used to reduce Plan expenses during the period ended April 30, 2022. Forfeitures in the amount of \$127,807 were used to reduce Plan Sponsor contributions during the year ended December 31, 2021. Total forfeitures available as of April 30, 2022 and December 31, 2021 were \$0 and \$2,746, respectively.

**Payment of Benefits** – Plan assets allocated to a participant’s account will be distributed upon termination of employment or death. A participant may not withdraw any part of the balance during the participant’s employment with the Plan Sponsor or an affiliated employer. Minimum distributions will begin on the participant’s date of retirement. Distributions will be calculated based on the participant’s account balance and the distribution period set forth in the Uniform Lifetime Table set forth in Section 1.401 (a)(9)-9 of the Treasury Department regulations.

### 1. Description of Plan (continued)

***Loans to Participants*** – In accordance with Plan provisions, no loan may be made to a participant from the participant’s account.

***Tax Status*** – The Plan was restated as of January 1, 2012. The Plan obtained its latest determination letter on July 9, 2014, in which the Internal Revenue Service (“IRS”) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the “Code”). The Plan has been amended subsequent to the determination letter. However, the Plan Administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the accompanying financial statements.

***Plan Termination*** – As discussed above, effective April 15, 2022, the Plan Sponsor merged with the Eaton Savings Plan. Each participant in the Plan shall be entitled to receive future benefits from the Eaton Savings Plan.

### 2. Summary of Significant Accounting Policies

***Basis of Accounting*** – The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

***Investment Valuation and Income Recognition*** – Plan investments were stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on an accrual basis and dividends are recorded on an ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes both realized gains and losses and unrealized appreciation (depreciation) in the fair value of investments. Realized gains and losses on disposition of investments are based upon actual costs and selling prices.

***Benefit Payments*** – Benefits are recorded when paid.

***Administrative Expenses*** – All accounting and administrative expenses related to the administration, operation and maintenance of the Plan, including, without limitation, any expense relating to the preservation of the qualification of the Plan under Section 401(a) of the Code, may be paid from the Plan assets. At the discretion of the Plan Sponsor, any such expenses, disbursements, or charges, may be paid by the Plan Sponsor.

### 2. Summary of Significant Accounting Policies (continued)

**Party in Interest Transactions** – Certain Plan investments were cash reserves held by Fidelity. Fidelity is the Trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

**Use of Estimates** – The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Subsequent Events** – The Plan Administrator has evaluated the effects of all subsequent events, for recognition or disclosure, through January 16, 2023, the date the accompanying financial statements were available to be issued.

### 3. Information Certified by the Trustee (Unaudited)

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Personal Trust Company, FSB (“Fidelity” or the “Trustee”) has certified that the following data included in the accompanying financial statements and supplementary information is complete and accurate:

### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- **Level 2** – Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability. There were no assets of the Plan that were valued using Level 2 inputs at April 30, 2022 and December 31, 2021.

- **Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement. There were no assets of the Plan that were valued using Level 3 inputs at April 30, 2022 and December 31, 2021.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Interest Bearing Cash* – Stated at cost, which approximates fair value.

*Exchange Traded Funds* – Valued at the closing price reported on the respective exchange.

*Mutual Funds* – Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end.
