1. DESCRIPTION OF THE PLAN

The following description of the CEDAR Document Technologies, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the official Plan document for a more complete description of the Plan's provisions.

Effective April 1, 2022, the Plan merged into the Precisely Software Incorporated 401(k) Plan. As such the transfer is reflected within the statement of changes in plan benefits for the period January 1, 2022 to April 30, 2022.

The following notes reflect financial and key provisions prior to the Plan merger.

General

The Plan is a defined contribution plan covering substantially all employees of CEDAR Document Technologies, Inc. (the Sponsor), except those covered under collective bargaining agreements and hourly paid employees, following the date on which an employee is at least 21 years old. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and Section 401(k) of the Internal Revenue Code (IRC) of 1986, as amended.

Contributions

Each year, participants may contribute up to 90% of annual compensation, as defined in the Plan, not to exceed certain IRC limits. Participants may designate all or a portion of their salary deferral as Roth elective deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Sponsor may make a discretionary match or nonelective contribution to the Plan. The Sponsor did not make a nonelective contribution during the period January 1, 2022 to April 30, 2022 or the year ended December 31, 2021. The Sponsor made a discretionary matching contribution of 2% of each participant's salary up to a maximum of \$1,000 during the period from January 1, 2022 to April 30, 2022 and during the year ended December 31, 2021. Participants must be employed at year-end to receive the Sponsor matching contribution unless terminated due to death, disability or attainment of age 65.

Effective January 1, 2020 the Plan was amended to include automatic enrollment after 45 days of employment. The automatic contribution was set to 3% pre-tax deduction.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Sponsor's contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary and rollover contributions and earnings thereon. Participants are vested in Sponsor contributions and related earnings as follows:

Less than 1 year	0%
At least 1 year, but less than 2 years	33%
At least 2 years, but less than 3 years	66%
At least 3 years	100%

Forfeitures

Forfeited accounts will be used to reduce future Sponsor contributions or to pay Plan expenses. At April 30, 2022, December 31, 2021 and 2020 forfeited nonvested accounts totaled \$0, \$571 and \$984, respectively. No forfeitures were used during the period January 1, 2022 to April 30, 2022. During 2021 forfeitures of \$413 were used to reduce Sponsor contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts upon approval of application for up to 50% of the participant's vested balance or a maximum of \$50,000 and a minimum of \$500. Notes bear a reasonable rate of interest as provided in the Plan document and are repaid through payroll deductions over periods ranging up to 60 months unless the loan is used to purchase a primary residence which requires repayment within 30 years.

Payment of Benefits

On termination of service due to death, disability, retirement, or separation from service, a participant, or his or her beneficiary, may receive their vested balance in either a single lump-sum distribution, or a direct rollover into a qualified retirement plan or individual retirement account. If the vested account balance is greater than \$5,000, then in addition to either a lump sum or direct rollover, the participant may choose to receive monthly installments or defer receiving payments until age 72. Terminated participants with a vested balance less than \$5,000 that have not elected payment will be automatically rolled over to an Individual Retirement Account (IRA) or cashed out if less than \$1,000.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in fair value of investments includes the Plan's realized gains and losses on investments bought and sold and unrealized appreciation and depreciation on investments held during the period.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of April 30, 2022, December 31, 2021 or 2020.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

Subsequent Events

Management has evaluated subsequent events through January 20, 2023, which is the date the financial statements were available to be issued and require disclosure under Financial Accounting Standards Board (FASB) issued Accounting Standards Codification (ASC) 855, *Subsequent Events*.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurements*, are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

4. FAIR VALUE MEASUREMENTS – CONTINUED

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2021 and 2020.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage account: Consists of common stocks and interest-bearing cash. Common stock is valued at the closing price reported on the active market on which the security is traded. Interest-bearing cash is valued at cost, which approximates fair value.

5. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

During the period January 1, 2022 to April 30, 2022 and the year ended December 31, 2021, the Plan paid \$11,031 and \$24,146, respectively, to parties-in-interest for investment advisory, recordkeeping and securities brokerage services. The Sponsor pays directly any other fees related to the Plan's operations.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Sponsor contributions.

7. TAX STATUS

The Plan operates under a standardized prototype plan document. The underlying prototype plan has received an opinion letter dated July 8, 2014, stating that the form of the prototype plan is qualified under Section 401(a) of the IRC, and therefore is tax-exempt. In accordance with Revenue Procedures 2010-6 and 2006-16, the Plan administrator has determined that it is eligible to and has chosen to rely on the current Internal Revenue Service (IRS) prototype opinion letter. Once qualified, the Plan is required to operate in conjunction with the IRC to maintain its qualified status.

The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt. Therefore, no provisions for income taxes have been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management believes there are no uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
