We have performed audits of the financial statements of the Spirit of Texas Bank 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 7, 2022 (in liquidation) and December 31, 2021 (ongoing), and the related statement of changes in net assets available for benefits for the period ended September 7, 2022 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Spirit of Texas Bank 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 7, 2022 and December 31, 2021, and for the period ended September 7, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Spirit of Texas Bank 401(k) Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Terminating Plan and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, the Board of Directors of the Spirit Bank of Texas, the Plan's Sponsor, voted on February 24, 2022 to terminate the Plan and management determined liquidation is imminent. As a result, the Spirit of Texas Bank 401(k) Retirement Plan changed its basis of accounting from the going concern basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Spirit of Texas Bank 401(k) Retirement Plan's ability to continue as a going concern through the termination date of April 7, 2022.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Auditor's Responsibilities for the Audits of the Financial Statements (Continued)

In performing audits in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audits.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Spirit of Texas Bank 401(k) Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Spirit of Texas Bank 401(k) Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Note 1 - Description of the Plan

General

The Spirit of Texas Bank 401(k) Retirement Plan (the Plan) is a defined contribution plan established by Spirit of Texas Bank SSB (the Bank). The Plan qualifies as a tax-exempt plan under the provisions of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following description of the Spirit of Texas Bank 401(k) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

Plan Termination

By action, the Board of Directors of the Spirit Bank of Texas, the Plan's Sponsor, voted on February 24, 2022 to terminate the Plan and management determined liquidation is imminent. The Plan was terminated as a result of the Plan Sponsor being acquired by another bank during 2022. The acquisition was finalized on April 8, 2022 and the Plan was terminated effective April 7, 2022. As a result of the imminent liquidation, the 2022 financial statements have been presented on the liquidation basis of accounting. This had no impact on the values of the assets reported in the financial statements. No liabilities were recognized in connection with the termination. Participants balances were 100% vested as of the effective date of the plan termination. Participants had the option of withdrawing their balances from the Plan as a cash distribution or a rollover into an individual retirement plan. The distributions related to the plan termination were fully disbursed as of September 7, 2022.

Liquidation Basis of Accounting

In accordance with accounting principles generally accepted in the United States of America (GAAP), the Plan changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Accordingly, the statement of net assets available for benefits as of September 7, 2022 and the statement of changes in net assets available for benefits for the period then ended, have been prepared on the liquidation basis of accounting and the statement of net assets available for benefits as of December 31, 2021 is presented on the accrual basis of accounting.

Administration

The Plan Sponsor and named Plan Administrator is the Bank. The Plan's two Trustees are officers of the Bank. The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator has formed a committee made up of Bank officers and members of the human resources department. The committee determines the appropriateness of the Plan's investment offerings and monitors investment performance and fees. The Plan's investment Custodian is Voya Retirement Insurance and Annuity Company. The investment Custodian holds all of the Plan's assets and executes all of the Plan's transactions. The Voya Retirement Insurance and Annuity Company also performs participant recordkeeping services.

Eligibility

The Plan covers all employees employed by the Bank, who have been credited with 30 days of service, except for nonresident aliens, union employees and leased employees.

Contributions to the Plan

Prior to the plan termination, which is effective April 7, 2022, participants may elect to contribute up to 100% of their annual compensation on a pre-tax or after-tax (Roth) basis, as defined in the plan agreement. Participants who have attained age 50 before the end of the plan year are eligible to make 'catch-up' contributions. Participants may also contribute amounts representing distributions from other defined benefit or defined contribution plans (rollovers).

The Plan contains a safe harbor matching contribution feature. The formula for the safe harbor matching contribution is equal to 100% of the participant's elective deferral, limited to 4% of that participant's eligible compensation, as defined by the Plan. The Bank made safe harbor matching contributions totaling \$222,914 for the period ended September 7, 2022.

The Plan also provides for discretionary employer matching and employer profit sharing contributions for active participants once 1,000 hours of service have been met. However, the Bank made no such contributions for the period ended September 7, 2022.

Participants direct the investment of both their individual contributions plus their share of employer contributions into the various investment options offered by the Plan. The Bank's contributions are allocated in the same manner as that of the participant's elective contributions.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and applicable employer contributions. Funds contributed by participants are invested at percentages as directed by participants in any one or more of several investment alternatives. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions. The investment fund income, gain or losses are allocated daily to the applicable participants' accounts in that fund based on the previously reported account balances, adjusted for current period contributions and withdrawals. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Notes Receivable

Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as participant-directed investments. Loan terms range from one to five years. Loan terms may exceed five years only in the event the loan proceeds are used to purchase or construct the participant's principal residence. Loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing prime rates plus 2%. Principal and interest is paid ratably through payroll deductions. Loan refinancing is permitted.

Payment of Benefits

On termination of service due to death, disability or retirement or other reasons, a participant may elect to receive payment in the form of partial distributions or a lump-sum amount equal to the value of the participant's vested interest in his or her account.

The Plan also allows for in-service distributions, as defined in the plan document.

Vesting

The balance in each participant's salary deferral, safe harbor matching and rollover accounts is 100% vested at all times. Participants also become 100% vested upon death, disability or attainment of normal retirement age.

Prior to the plan termination effective April 7, 2022, employer discretionary contributions were subject to a graded vesting schedule based on years of service. A participant was 100% vested after six years of credited service. Participants balances were 100% vested as of the effective date of the plan termination.

Note 2 - Summary of Significant Accounting Policies

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's committee determines the Plan's valuation policies utilizing information provided by the investment Custodian and investment advisers. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is accrued on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Participant Notes Receivable

Participant notes receivable are valued at their unpaid principal plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 7, 2022 or December 31, 2021. Delinquent participant notes receivable are reclassified as distributions based upon the terms of the plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Fees and Expenses

The Plan's administrative expenses, including salaries, accounting, and legal, are paid directly by the Plan Sponsor and are excluded from these financial statements. For the period ended September 7, 2022, the settlor fees relating to the termination of the Plan are paid by the Plan Sponsor. Fees related to the administration of loans and benefit payments are charged directly to the participant's accounts and are included in administration expenses. Direct fees for custodian and recordkeeping services are paid by the Plan and are also included in administration expenses. Investment related expenses are included in the net depreciation in fair value of investments.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including February 3, 2023, which is the date the financial statements were available to be issued.

Note 3 - Unaudited Investment Information Certified by the Custodian

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following information has been certified by Voya Retirement Insurance and Annuity Company as to its completeness and accuracy and was not subjected to any auditing procedures performed by the Plan's independent auditors:

1. All investment balances reflected in the accompanying statements of net assets available for plan benefits as of September 7, 2022 and December 31, 2021,
2. All investment activity reflected in the statement of changes in net assets available for plan benefits for the period ended September 7, 2022, and
3. Notes receivable from participant as of September 7, 2022 and December 31, 2021 and the related income on notes receivable from participant for the period ended September 7, 2022.

Note 4 - Fair Value Measurements

The Plan's investments in pooled separate accounts are valued at fair value based on the fair value of the underlying assets of the pooled separate accounts, using net asset value as the practical expedient.

The following table sets forth additional disclosures for the fair value measurement of investments in certain entities that calculate net asset value (or its equivalent) as of September 7, 2022 and December 31, 2021:

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. No changes in methodologies were made at September 7, 2022 and December 31, 2021. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Fully Benefit-Responsive Investment Contract

The Plan has entered into a fully benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company (Voya) with regard to the Voya Fixed Account (4062). This contract meets the fully benefit-responsive investment contract criteria and therefore, is reported at contract value. Contract value is the relevant measure for a fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. The Fixed Account is a group annuity product, whereby amounts contributed to the contract are deposited into Voya's general account. Payment obligations and the fulfillment of any guarantees specified in the group annuity contracts are insurance claims supported by the full faith and credit of Voya. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administration expenses. The contract value of the Fixed Account at September 7, 2022 and December 31, 2021 was \$-0- and \$1,550,423, respectively.

Voya guarantees the Plan a return of principal and interest under the terms of the contract. The interest crediting rate is updated quarterly monthly based upon contract provisions, and it may not be less than 1%. Voya's general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include plan termination, plan merger, premature contract termination initiated by the Bank, and certain other Bank-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which the Issuer may terminate the contract. Examples of circumstances which would allow Voya to terminate the contract include the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, Voya could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

Note 6 - Plan Amendment and Tax Status

The Plan has adopted a volume submitter plan document sponsored by Nova 401(k) Associates. That document has received an opinion letter dated June 30, 2020 from the IRS as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by the Plan. The Plan has been amended since receiving the prototype plan opinion letter; however, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

The Plan was restated as of July 12, 2020.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of September 7, 2022, the Plan Administrator believes that the Plan has no uncertain tax positions that qualify for either recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, the Plan is currently not being examined. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2019.

Note 7 - Related Party and Party-in-Interest Transactions

Certain plan investments are managed by Voya Retirement Insurance and Annuity Company, who is the Investment Custodian. During the period ended September 7, 2022, the Plan paid direct compensation to the investment Custodian for services rendered. Indirect compensation (that is netted against investment income on the statement of changes in net assets available for benefits) is paid to the investment Custodian from total annual operating expenses charged on the balance of fund investments, depending on the particular fund. Transactions involving these investments are considered party-in-interest transactions; however, these transactions are not considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

Certain accounting and administrative functions are performed by officers or employees of the Bank. No such officer or employee received compensation from the Plan.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - Plan Termination

Effective April 7, 2022, the Plan was terminated and frozen until liquidation was complete. Plan assets were distributed as cash disbursements or rolled over into an individual retirement plan. The liquidation process was completed September 7, 2022.
