Note 1. Plan Description

The Aptera Software Inc. 401(k) Plan (the Plan) is a defined contribution plan covering employees of Aptera Software, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The provisions of the Plan are included in the official Plan document, which legally governs the operations of the Plan and is available for more detailed information.

Eligibility

All employees, except union employees, leased employees and non-residential aliens, were eligible to participate in the Plan following three months of service.

Contributions

Participants may have elected to contribute between 1% and 100% of eligible pre-tax compensation up to the statutory dollar limit established by the Internal Revenue Code. Participants may also have elected to make Roth deferral contributions. The Company match contribution was discretionary by the board of directors annually. There was also a discretionary Company profit share contribution allowed. There were no contributions in 2022.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants have the option of investing in a variety of pooled separate accounts, a stable value fund and a money market fund offered through Voya Retirement Insurance and Annuity Company. All amounts in participant accounts are participant-directed; however, if a participant does not choose an investment allocation, the Plan provides for a default investment option.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution plus earnings thereon is based on years of continuous service. A participant is 100% vested after five years of credited service.

Note 1. Plan Description (Continued)

Benefit Payments

Benefits under the Plan are payable in the form of a lump sum. Benefits are payable when a participant retires, dies, or otherwise ceases to be an employee. Participants who are still active may also receive lump sum benefit payments upon attaining age 59 1/2 or for hardships. Additionally, rollover contributions are available for distribution at any time.

Forfeitures

If a participant terminates employment before being fully vested, a portion of the Company contributions will be forfeited. Forfeitures are used to pay Plan expenses or reduce future Company contributions. At February 1, 2022 and December 31, 2021, approximately \$0 and \$1,500 of forfeitures were available to pay Plan expenses or reduce future Company contributions, respectively. During the period ended February 1, 2022, no forfeitures were used to pay Plan expenses or reduce Company contributions.

Note 2. Significant Accounting Policies

Basis of Financial Statements

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Stable value funds held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. However, these funds qualify for measuring fair value using the net asset value (NAV) practical expedient. This NAV represents the Plan's fair value since this is the NAV at which the Plan transacts with the fund.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Payment of benefits to participants are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent Events

The plan administrator has evaluated events and transactions for possible recognition or disclosure through January 28, 2023, the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, and are determined by either the principal market or the most advantageous market.

Inputs used in the valuation techniques to derive fair values are classified based on a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below with Level 1 measurements having the highest priority and Level 3 measurements having the lowest priority.

- Level 1: Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2: Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3: Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable.

The asset's or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 3. Fair Value Measurements (Continued)

Pooled separate accounts (PSA's): Valued at the net asset value (NAV) of the fund shares, which is calculated based on the valuation of the funds' underlying investments at fair value at the end of the year. The investments are public investment vehicles, which are valued using the NAV provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, excluding transaction costs, minus its liabilities, and then divided by the number of shares outstanding. The NAV of a PSA is not a publicly quoted price in an active market; therefore, the NAV is used as a practical expedient to estimate fair value. The Plan's PSA investments have a daily redemption frequency, do not require a redemption notice period, and have no unfunded commitments as of December 31, 2021, respectively.

Money market fund: Valued at quoted market prices, which represent the net asset values (NAV) of shares held by the Plan at year end.

Stable value fund: Composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities' liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Transactions with Parties-In-Interest

The Company provides certain accounting, recordkeeping, and administrative services for the Plan for which it receives no compensation. Administrative expenses for accounting and other services are rendered by parties-in-interest and are paid by the Company. The Plan invests in a money market fund, a stable value fund and pooled separate accounts affiliated with Voya Retirement Insurance and Annuity Company. Investment related expenses are included in net appreciation of fair value of investments.

Note 6. Income Tax Status

The Plan obtained its latest determination letter on March 31, 2014, from the Internal Revenue Service, stating that the Plan is a qualified plan under Section 401 of the Internal Revenue Code. The Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has since been amended. However, the Plan sponsor and Plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income tax has been included in the Plan's financial statements. The Plan sponsor and Plan administrator are not aware of any course of action or series of events that have occurred that would adversely affect the qualified status of the Plan.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of February 1, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

Note 7. Risks and Uncertainties

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8. Plan Termination

The Plan Sponsor was acquired by Core BTS, Inc. during 2021. As a result, during December 2021, the Plan Trustees approved a merger of the Plan assets into the Core BTS 401(k) Retirement Plan, effective February 1, 2022. As a result, the Plan terminated and all assets were transferred.

Note 9. Reconciliation of Financial Statements to Form 5500

In accordance with the Form 5500 instructions, management has recorded the plan activity and merger of assets through the date of distribution of Plan assets. The financial statements have been prepared in accordance with generally accepted accounting principles, and accordingly, the plan activity and merger of Plan assets were recorded through the legal merger date.
