## Independent Auditors' Report

### To the Trustees of J5 Infrastructure Partners 401(k) Plan

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for 2021 Financial Statements

We have performed an audit of the financial statements of the J5 Infrastructure Partners 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of May 31, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the period from January 1, 2022 to May 31, 2022 and the year ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from Great-West Trust Company LLC, the custodian of the Plan as of May 31, 2022 and December 31, 2021 and for the period from January 1, 2022 to May 31, 2022 and year ended December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### Opinion on the Financial Statements

## Notes to the Financial Statements

### For the period from January 1, 2022 to May 31, 2022 and the year ended December 31, 2021

#### 1. Description of Plan Provisions

The following description of the J5 Infrastructure Partners 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### **General and Eligibility**

The Plan was established effective January 1, 2017 and amended and restated effective January 17, 2020.

The Plan is a Safe Harbor defined contribution plan covering all employees of J5 Infrastructure Partners, LLC (the "Company"), except for union employees, nonresident aliens, leased employees who have completed 3 months and 250 hours of service, and part-time, temporary, or seasonal employees, as defined as employees whose regularly schedule service is less than 1000 hours of service in the period and employed less than 1 year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Effective December 2021, the Company was acquired by Centerline Communications LLC and effective May 31, 2022, the Plan was merged into the Centerline Communications LLC 401(k) Profit Sharing Plan and Trust.

##### **Contributions**

Eligible participants can elect to make pre-tax contributions to the Plan by means of a salary deferral agreement up to maximum amounts permitted by the Internal Revenue Code ("IRC"). Participants who have attained age 50 or older before the end of the plan year are eligible to make catch-up contributions. Participants may also make rollover contributions from other qualified plans.

The Company is required to make Safe Harbor matching contributions for eligible participants equal to 100% of the participant's pre-tax deferral contributions that do not exceed 3% of the participant's eligible compensation and 50% of the participant's pre-tax deferral contributions that exceed 3% of the participant's eligible compensation not to exceed 5%.

The Company, at its discretion, may make matching contributions for eligible participants who have attained one year of service and are employed on the last day of the plan year, as further defined in the plan document. For the period from January 1, 2022 to May 31, 2022 and year ended December 31, 2021, no discretionary matching contributions were made.

The Company, at its discretion, may make profit sharing contributions for eligible employees, as further defined in the plan document. For the period from January 1, 2022 to May 31, 2022 and year ended December 31, 2021, no discretionary profit sharing contributions were made.

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Company's contributions, Plan earnings/losses based on the participant's investment elections and charged with withdrawals and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are immediately vested in their contributions and all of the Company's contributions, plus actual earnings thereon.

### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Participants may borrow up to 100 percent of their full vested balance or \$100,000, whichever is lesser. Participants may only have one loan outstanding at a time. Loan terms range from 1 to 5 years or longer if the proceeds are used for the

purchase of a primary residence. The loans are collateralized by the balance in the participant's account and bear interest at a commercially reasonable rate of interest at the time the loan is made. Loans are measured at their unpaid principal balance plus any accrued, but unpaid interest. As of December 31, 2021, the interest rates and maturity on the outstanding loans ranged from 4.25% to 7.00% per annum and from 2023 to 2025, respectively. Principal and interest are paid ratably through payroll deductions.

### Withdrawals

In the event of retirement (as defined), death, permanent disability, termination of employment, or financial hardship (as defined), the vested balances in a participant's account may be distributed to the participant or the participant's beneficiaries in a lump sum or through payments in such other forms as may be available under the Plan. The amount of hardship distributions may not be in excess of the amount of a participant's financial hardship, as defined in the plan document.

## 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Payment of Benefits

Benefits are recorded when paid.

### Administrative Fees

Certain expenses to maintain the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### Subsequent Events

The Plan has evaluated subsequent events through October 17, 2022, which is the date the financial statements were available to be issued.

## 3. Information Certified by the Custodian

The following is a summary of the Plan's investment information included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by custodian Great-West Trust Company, LLC and furnished to the plan administrator. The plan administrator has obtained certifications from the custodian that such information is complete and accurate.

#### 4. Fair Value Measurements

The Financial Accounting Standards Board's Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2021:

- Mutual funds: Mutual funds are stated at fair value based on quoted prices in an active market for each share held by the Plan.
- Common collective trust fund: The common collective trust fund is stated at net asset value of the shares determined by the underlying securities held by the Plan at year end. The net asset value is used as a practical expedient to estimate fair value. The common collective trust funds invest primarily in guaranteed investment contracts. The common collective trust fund does not have any unfunded commitments relating to its investments, or any significant restrictions or redemptions. There are no participant redemption restrictions for this investment.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Plan Termination

The Company reserves the right to amend, alter or terminate the Plan subject to the provisions of ERISA. The Plan merged into the Centerline Communications LLC 401(k) Profit Sharing Plan and Trust effective May 31, 2022.

### 6. Party-in-Interest Transactions

Empower Retirement, LLC ("Empower") performs administrative and recordkeeping services for the Plan. The administrative expenses paid to Empower were \$40,620 for the year ended December 31, 2021 and \$23,618 for the period from January 1, 2022 to May 31, 2022.

The custodian received revenue from certain investments in the Plan. The custodians and the Plan Sponsor have agreed that the custodians shall provide excesses each quarter to be available to the Plan to pay other ERISA qualified administrative expenses. The remaining amount of the revenue credit is allocated to participants as soon as administratively feasible after the excesses are provided. As of May 31, 2022 and December 31, 2021, there were \$0 and \$39,754 in revenue credits available to pay eligible plan expenses or be allocated to participants, respectively. For the year ended December 31, 2021, \$43,850 of revenue credits were made available to the Plan, of which \$11,287 was used to pay eligible plan expenses. For the period from January 1, 2022 to May 31, 2022, \$19,463 of revenue credits were made available to the Plan, of which \$520 was used to pay eligible plan expenses. The remaining balance was transferred to the successor plan.

### 7. Tax Status

On June 30, 2020, the Internal Revenue Service ("IRS") stated that the non-standardized pre-approved Plan Description adopted by the Plan, as then designed, qualifies under Section 401(a) of the IRC. The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

## **J5 Infrastructure Partners 401(k) Plan**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of May 31, 2022 and December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's management believes it is no longer subject to income tax examinations for years prior to 2018.

### **8. Risks and Uncertainties**

The Plan invests in various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the financial statements.
