### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements*

We have performed an audit of the financial statements of Precor, Incorporated Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of February 1, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 to February 1, 2022, and the related notes to the financial statements (financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). ### 1. Description of the Plan

The following brief description of the Precor, Incorporated Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

#### *General*

The Plan, originally effective as of November 1, 2002, was a defined contribution plan and was sponsored by Precor, Incorporated (the Company) and was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective January 1, 2022, the Plan was restated. The percentage of compensation eligible employees may have elected to contribute, on a pretax basis, increased from 50% to 90% of their eligible compensation to the Plan, not to exceed the limit in Section 402(g) under the IRC. No other significant changes were made to the provisions of the Plan as a result of the restatement.

Effective January 1, 2022, all Company employees became Peloton Interactive, Inc. employees and were no longer eligible to participate in the Plan. Additionally, effective February 1, 2022, the Plan merged with the Peloton Interactive, Inc. Retirement Plan. Accordingly, assets of \$98,081,653 were transferred out of the Plan.

#### *Eligibility*

All employees, excluding nonresident aliens, leased employees, and residents of Puerto Rico, were eligible for participation upon attainment of age 18 with 6 months of service. Enrollment was allowed on the date the above conditions were met.

#### *Contributions*

Each year, eligible employees may have elected to contribute up to 90% of their eligible compensation to the Plan, not to exceed the limit in Section 402(g) under the Internal Revenue Code (IRC). Eligible employees who had attained age 50 before the close of the Plan year were allowed to make catch-up contributions up to the maximum allowed by the IRC. Contributions were subject to certain limitations. Eligible employees were automatically enrolled at 3% of their eligible compensation, with automatic increases of 1% on the first day of each Plan year until the maximum of 10% is reached. Participants could also have contributed amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants directed the investment of their contributions into various investment options offered by the Plan.

In addition, the Company had elected to make a Company safe harbor matching contribution of 100% of the participant's deferrals that did not exceed 3% of compensation, plus 50% of the participant's deferrals that exceed 3% but not 6% of compensation. The Company could also make discretionary profit-sharing contributions on an annual basis. To receive an allocation of such contributions, a participant generally must have been employed on the last day of the Plan year. There were no discretionary profit-sharing contributions for the period from January 1, 2022 through February 1, 2022.

#### *Participant Accounts*

Each participant's account was credited with the participant's salary deferral contributions, allocations of any Company safe harbor matching contributions and any discretionary profit-sharing contributions (collectively, Company contributions), and his/her share of the Plan's income (loss). The Plan's income, with respect to each investment fund, was allocated based on the proportion that each participant's account balance invested in such fund compared to the total of all participants' account balances invested in such fund.

### 1. Description of the Plan (cont.)

#### *Notes Receivable from Participants*

Participants could have borrowed, from their fund accounts, a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes receivable from participants were secured by the balance in the participant's account and carried a rate of interest equal to the prime rate. Principal and interest payments occurred ratably through regular payroll deductions over a period not to exceed five years. Participants were only allowed to have two loans outstanding at a time.

#### *Vesting*

Participants were immediately vested in the value of their salary deferrals, Company safe harbor matching contributions, and rollovers, plus related investment earnings. Discretionary profit-sharing contributions were subject to a vesting schedule; however, no discretionary profit-sharing contributions were subject to vesting at the time of the merger.

#### *Payment of Benefits*

Participant accounts could have been withdrawn upon retirement, death, disability, or termination of employment. Participants elected to have distributions paid in a lump-sum, in substantially equal installments or partial withdrawals, and were either paid directly to the participant or rolled over to another qualified retirement plan. The Plan also allowed for in-service withdrawals at age 59½, along with withdrawals in the event of a financial hardship.

#### *Plan Expenses*

Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account. Fees related to administration of distributions were taken out of the gross distribution to the participant. Investment related expenses were included in net appreciation (depreciation) in fair value of investments.

#### *Forfeitures*

Forfeited accounts totaled \$0 and \$31,674 at February 1, 2022 and December 31, 2021, respectively. Forfeited funds could have been used to pay any administrative expenses or to reduce any Company contributions. During the period from January 1, 2022 to February 1, 2022, \$2,000 of forfeited funds were used to pay administrative expenses. The remaining forfeiture balance was included as part of the transfer to the Peloton Interactive, Inc. Retirement Plan on February 1, 2022.

#### *Basis of Accounting*

The financial statements of the Plan were prepared using the accrual basis of accounting. The Plan follows accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (GAAP).

#### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

### 2. Summary of Significant Accounting Policies

#### *Investment Valuation and Income Recognition*

The investments of the Plan were reported at fair value, except for fully-benefit responsive investment contracts, which was reported at contract value at December 31, 2021. Contract value was the relevant measurement for that portion of the net assets available for benefits because contract value was the amount participants normally would have received if they initiated permitted transactions under the terms of the Plan.

The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price).

Purchases and sales were recorded on a trade-date-basis. Dividends were recorded on the ex-dividend date. Investment income was recorded on the accrual basis. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Notes Receivable*

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses has been recorded as of February 1, 2022 and December 31, 2021. If a participant ceased to make loan repayments and the Plan administrator deemed the participant loan to be in default, the participant loan balance was reduced, and a benefit payment was recorded.

#### *Payment Benefits*

Benefit payments to participants were recorded upon distribution.

### 3. Certified Information

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, The Standard Insurance Company (The Standard) has provided a certification that the financial information included in the financial statements as of February 1, 2022 and December 31, 2021, and for the period from January 1, 2022 to February 1, 2022, provided to the Plan is complete and accurate. The information as to investment assets and transactions therein, and investment income (loss) included in the accompanying financial statements as of February 1, 2022 and December 31, 2021, and for the period from January 1, 2022 to February 1, 2022, is covered by such certification.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

### 4. Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements).

The three levels of the fair value hierarchy under GAAP are described below:

### 4. Fair Value Measurements (cont.)

#### *Basis of Fair Value Measurement*

*Level 1* - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

*Level 2* - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

*Level 3* - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at February 1, 2022, and December 31, 2021.

*Pooled Separate Account* - The fair value of the pooled separate account was based on the net asset value (NAV) of the account calculated based on the NAV of the underlying investments. The NAV was used as a practical expedient to estimate fair value.

The methodology described above may have produced a fair value calculation that may not have been indicative of net realizable value or reflective of future fair values. Furthermore, while management believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

The Plan's investments at fair value as of December 31, 2021 were made up entirely of a pooled separate account, which was measured at the NAV as a practical expedient. In accordance with Subtopic 820-10, certain investments that were measured as such are not classified in the fair value hierarchy. The Plan has no assets as February 1, 2022. The Plan has no assets at December 31, 2021 that are classified in the fair value hierarchy.

### 5. Guaranteed Interest Fund with The Standard

The Plan had a fully benefit-responsive guaranteed interest contract with The Standard. Because the contract was benefit responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the respective contract. Contract value represented contributions made, less withdrawals and administrative expenses, plus interest credited. Net deposits invested in The Standard Stable Asset A became part of The Standard's general account, and there were no particular segregated or identifiable assets ascribed to the Plan's investment. Net deposits and interest credited became liabilities against The Standard on the Plan's behalf. Daily liquidity was available for participant contributions and withdrawals at contract value regardless of market conditions. Contract value was guaranteed by the full faith and credit of The Standard; there were no wrap contracts supporting the liquidity of the fund. The fund was neither a mutual fund nor a bank product. The Standard's obligations were not insured by the FDIC or any other federal government agency.

Quarterly, The Standard declared a crediting rate for all assets in the fund during the coming quarter. This crediting rate takes into account yield forecasts from The Standard's assets advisory group and the margins required for business. The crediting rate was declared in advance and was reset quarterly. The fund's declared crediting rate will never be below 1% annually. Management approval was required for all crediting rates. The fund's NAV increased with the daily equivalent of the crediting rate and the Plan's unit value increased along with the fund's NAV offset by the Plan's asset management fees. Past crediting rates were not indicative of future rates. The crediting rate was 2.21% for the period from January 1, 2022 to February 1, 2022, and for the year ended December 31, 2021.

Certain events may have limited the ability of the Plan to transact at contract value. Such events included termination of the contract, spin-offs, divestiture, layoffs, corporate relocation, partial or total Plan termination, retirement incentive programs, and the liberalization of Plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may have applied. The Plan sponsor may have chosen to pay the market value adjustment directly, if applicable, so that participants' contract values were not affected.

The Plan sponsor did not view the occurrence of any of these events to limit the Plan's ability to transact at contract value, as of the date these financial statements were available to be issued.

### 6. Tax Status

The Plan was based on the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA for Standard Retirement Services Inc (Pre-Approved Plan), which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the Pre-Approved Plan was designed in accordance with the provisions of the IRC. Although the Plan has been restated since the date of the opinion letter, the Plan administrator believed that the Plan was designed, and was being operated, in compliance with the applicable requirements of the IRC and therefore, believed that the Plan was qualified, and the related trust was tax exempt.

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **7. Party-In-Interest Transactions**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any part rendering service to the Plan, the Company, and certain others. Certain administrative functions were performed by officers or employees of the Company. No such officer or employee received compensation from the Plan. Some administrative expenses were paid directly by the Company. Notes receivable from participants are defined by ERISA as party-in-interest transactions. Such transactions were exempt from the prohibited transaction rules.

### **8. Risk and Uncertainties**

The Plan's investments were exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term could have materially affected participants' account balances and amounts reported in the statements of net assets available for benefits.

In January 2020, the World Health Organization declared the outbreak of a novel coronavirus (COVID-19) as a "Public Health Emergency of International Concern," which continues to spread throughout the world and has adversely impacted global commercial activity and contributed to volatility in financial markets. The coronavirus outbreak and government responses are creating disruption in global supply chains and adversely impacting many industries and financial market conditions. The outbreak and corresponding government responses and supply chain issues could have a continued impact on economic and market conditions. The rapid development and fluidity of this situation precludes any prediction as to the ultimate impact of the coronavirus outbreak. Nevertheless, the outbreak presents uncertainty and risk with respect to the Plan, its investment performance, and overall financial results.

### **9. Subsequent Events**

The Plan has evaluated subsequent events through January 19, 2023, which is the date the financial statements were available to be issued and has determined that no significant events occurred after February 1, 2022, but prior to issuance of these financial statements, that would have a material impact on its financial statements.
