We have performed audits of the accompanying financial statements of

NOTE A - Description of Plan

Termination - The Plan sponsor elected to terminate the Plan on January 15, 2022. All participants were notified of the termination and the Plan was formally terminated May 6, 2022. Participants were 100% vested in their account balances.

The following description of the Second Samuel Transport Inc 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all eligible employees of the Company who have one month of service and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator oversees governance of the Plan. Plan's management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions - Individual participants may elect to contribute 1% to 90% of annual eligible compensation, as defined in the Plan, and designate those contributions as either pre-tax or Roth. Participants who have attained age 50 before the end of the plan years may also make catch-up contributions. Catch-up contributions are not subject to any other contribution limits or the nondiscrimination rules. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investments of their contributions into various investment options offered by the Plan. The Plan currently offers many mutual funds and insurance annuity contracts as investment options for participants

Participants' accounts - Each participant's account is credited with the participant's contributions as well as allocations of and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants became 100% vested when the decision to terminate the Plan was made.

Vesting - Participants are vested immediately in their contributions, employer safe harbor matching contributions, plus earnings thereon. Vesting in the employer non-elective contribution portion of their accounts is based on years of service.

Forfeited accounts - Forfeited nonvested accounts may be used to pay plan expenses or reduce employer contributions. For the period ended May 6, 2022 and the year ended December 21 2021, no forfeitures were used and there were no unallocated forfeitures.

Notes receivable from participants - Participants may borrow from their accounts up to the lesser of \$50,000 or 50% of their account balance. Loans shall provide for level amortization with payments not to exceed five years. However, loans used to purchase a primary residence may exceed five years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through weekly payroll deductions. Notes receivable from participants are valued at amortized cost, which approximates fair value.

Payment of benefits - On termination of service due to death, disability or retirement, participants may elect to receive an amount equal to the value of the vested interest in their accounts in either a lump-sum amount or in installments, depending on the size of the participant's account balance at the time of termination. Participants with a vested account balance of less than or equal to \$1,000 must take a lump-sum distribution. Participants that have a vested account balance less than or equal to \$5,000, but greater than \$1,000, will have their vested balance rolled into an IRA. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account in a lump-sum distribution.

In-service distributions are allowed when a participant reaches age 59½. Rollover contributions may be withdrawn at any time. The Company may authorize certain withdrawals from a participant's account in the event of proven financial hardship. Hardship withdrawals are subject to specific statutory and regulatory requirements.

NOTE B - Summary of Significant Accounting Policies

Basis of accounting - The financial statements of the Plan have been prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than U.S. generally accepted accounting principles. The modified cash basis of accounting is an acceptable alternative method of reporting under regulations issued by the Department of Labor. Income on securities is recorded on an accrual basis and investments are recorded at fair value as stated below. All other transactions are recorded on a cash basis.

Expenses - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses and charged directly to the participant's account.

Use of estimates - The preparation of financial statements on the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The reported value of the common collective trust fund is at the net asset value ("NAV"), which is calculated by the fund based on net assets. The NAV represents the Plan's fair value since this is the amount at which the Plan transacts with the fund. See Note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE B - Summary of Significant Accounting Policies (continued)

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of May 6, 2022 or December 31, 2021. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the Plan has authority to take all reasonable actions to collect the loan balance including the participant loan balance may be reduced and a benefit payment recorded.

Payment of benefits - Benefits are recorded when paid. There were no benefits due as of May 6, 2022 or December 31, 2021.

NOTE C - Tax Status

The Plan is a prototype plan for which the Internal Revenue Service has issued an advisory opinion dated June 30, 2020, stating that while they do not issue a determination as to whether a specific employer's plan is qualified, any employer who adopts this plan document will be considered to have a plan qualified under code section 401(a) provided all the terms are not more favorable for officers, owners, or highly compensated employees than for other employees. Although the Plan has been amended since receiving the advisory opinion, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

The modified cash basis method of accounting requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE D - Investment Information and Information Certified by the Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under this election, no audit procedures have been performed with respect to information certified as complete and accurate by the trustee of the Plan, Great-West Trust Company LLC, which held the Plan's investment assets and executed investment transactions from January 1, 2021 to May 6, 2022. The unaudited information included in the accompanying financial statements and supplemental schedule is summarized below.

NOTE E - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2: Inputs to the valuation methodology include the following:
 - Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 6, 2022 and December 31, 2021.

- *Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Common/Collective Trust Fund:* The investments underlying the common/collective trust fund investments generally include shares of common stock and fixed investments whose values are determined on the basis of quoted prices in an active market. The Plan's common/collective trust fund investments are valued on NAV per share as a practical expedient as reported by the fund manager multiplied by the number of shares or units held as of the measurement date. Accordingly, the NAV based investments have been excluded from the fair value hierarchy.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE G - Related-Party Transactions

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. Certain Plan investments are shares of common/collective trusts managed by Great-West Insurance Company LLC. Great-West Insurance Company LLC is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for services are included in administrative expenses and amounted to \$20,123 and \$33,098 for the period ended May 6, 2022 and year ended December 31, 2021, respectively.

NOTE H - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE I – Operational Errors

Participants were considered eligible to enroll into the plan on the first day of the month after their hire date, though the Plan documents have a one-month service requirement. Participants were also deferring amounts that did not agree to the election or change forms available. Documentation of election and change forms was not maintained to support the deferrals being made. The effects of these errors to the Plan are not known.

The Plan maintained ERISA bond coverage from January 1, 2020 through September 30, 2020. There was no ERISA bond coverage from October 1, 2020 through May 6, 2022.

Amounts withheld from participants for contribution to the Plan and for loan repayment are required to be transferred at the earliest date on which such contributions can reasonably be segregated from the employer's general assets. The employer was delinquent in transmitting some of these contributions. This total includes late contributions of \$20,373 for 2021 and \$40,849 for 2020. The Plan sponsor corrected this non-compliance in December 2022 by calculating lost contributions and earnings and making payments directly to the affected participants.

Subsequent events - The Plan has evaluated subsequent events through the date of the auditors' report, the date the financial statements were available to be issued.
