### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Generate Life Sciences Inc. Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of April 13, 2022 and December 31, 2021, (liquidation basis) and the related statement of changes in net assets (in liquidation) available for benefits for the period January 1, 2022 to April 13, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matter—Plan Termination**

As further described in Note 5 to the financial statements, the plan sponsor authorized the termination of the plan effective December 16, 2021. In accordance with accounting principles generally accepted in the United States of America, the Plan changed its basis of accounting effective December 16, 2021, from the ongoing basis to the liquidation basis. Our opinion is not modified with respect to this matter.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The Generate Life Sciences Inc. Profit Sharing Plan (the “Plan”), effective January 1, 1997, is a defined contribution plan established to provide retirement benefits to eligible employees of the Plan's sponsor, California Cryobank, LLC (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

THE PLAN DOCUMENT INCLUDES DETAILED RULES FOR EACH SITUATION. PARTICIPANTS AND OTHER INTERESTED PARTIES SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

**A. Eligibility**

Employees become eligible to participate in the Plan after one month of service.

**B. Distributions and Withdrawals**

A participant becomes eligible for retirement benefits coincident with or following the attainment of age 59½. A distribution of benefits may be made in the case of death, disability, hardship or termination of employment.

Benefits are recorded when paid.

**C. Vesting**

A participant is fully vested immediately as to voluntary contributions, rollover contributions and related earnings. All Company contributions made on January 1, 2019 and thereafter are 100% vested. The Company’s matching contributions and discretionary contributions, prior to January 1, 2019, are vested as follows:

**D. Contributions**

As noted in Note 5, the Plan was terminated effective December 16, 2021 and no further contributions were accepted into the Plan. Previously, the Plan allowed participants to make pre-tax and Roth contributions to the Plan subject to applicable Internal Revenue Service Code (the “Code”) limits.

**E. Notes Receivable from Participants**

The maximum amount of any loan shall be the lesser of \$50,000 or 50% of the participant’s vested account balance. The minimum amount of any loan shall be \$1,000. Loans are secured by the balances in the participants’ accounts and bear interest at the prime rate plus 1%. Loans must be repaid within five years, except loans for the purchase of a principal residence may be repaid over 30 years. There were no notes receivable from participants as of April 13, 2022.

**F. Forfeitures**

Any portion of a participant's account that is not vested shall be forfeited upon distribution of the vested portion. Forfeitures may be used to reduce administrative expenses of the Plan or to reduce Company contributions. During 2022, there were \$250 of forfeitures; \$106,410 were used to offset administrative expenses.

**G. Administrative Expenses**

Administrative expenses are paid by the Plan, unless paid by the Company.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The Financial Accounting Standards Board (FASB) issued authoritative guidance that requires an entity to prepare its financial statements using the liquidation basis of accounting when liquidation is imminent. The guidance requires measurement and presentation of assets at the amount of expected cash proceeds from liquidation. An entity includes in its presentation of assets any items it had not previously recognized under accounting principles generally accepted in the United States ("U.S. GAAP") but that it expects to use in settling liabilities. The April 13, 2022 and December 31, 2021, financial statements are prepared on the liquidation basis of accounting in accordance with U.S. GAAP.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**C. Investment Valuation and Income Recognition**

Investments held by an employee benefit plan are required to be reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value represents contributions made under a contract, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net (depreciation) includes gains and losses on investments bought and sold as well as held during the year.

**D. Fair Value Measurements**

Accounting guidance establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market:

**D. Fair Value Measurements (Continued)**

Level 1 – Inputs are quoted prices in an active market.

Level 2 – Inputs are based on quoted prices for similar instruments and model based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Level 1 investments include mutual funds valued at their quoted market prices. The Level 2 investment consists of a money market fund valued using matrices of trades in similar securities.

**E. Risks and Uncertainties**

Investments are exposed to various risks such as interest rate, market fluctuations and credit risks. Due to the risk associated with investment securities, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and statement of changes in net assets available for benefits.

**NOTE 3 - INCOME TAX STATUS**

The Plan was designed under a volume submitter program, which has received a favorable opinion letter issued by the Internal Revenue Service stating that it is acceptable under Section 401(a) of the Code. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting guidance requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 4 - FIXED INCOME GUARANTEED OPTION**

The Plan maintains a fully benefit-responsive group annuity contract with Voya Retirement Insurance and Annuity Company ("Voya") through the Voya Fixed Account ("Unallocated Insurance Contract"). Contributions to the Unallocated Insurance Contract are maintained in an insurance Company

general account and credited for interest and charged for participant withdrawals and administrative expenses. Voya is contractually obligated to repay principal and a specified rate of interest that is guaranteed to the Plan. The Unallocated Insurance Contract meets fully benefit-responsive investment contract criteria and is reported at contract value.

The crediting rate is based on a formula established by Voya but may not be less than 1.0%. The crediting rate is reviewed monthly for resetting. The crediting rate for December 31, 2021 was 1.15%.

The Plan's ability to receive amounts due is dependent on Voya's ability to meet its financial obligations. There are no reserves against contract value for credit loss. Certain events might limit the ability of the Plan to transact at contract value including premature termination of Plan investments in the Unallocated Insurance Contract. The plan administrator does not believe that any events limiting the Plan's ability to transact at contract value are probable of occurring.

**NOTE 5 - PLAN TERMINATION**

Effective December 16, 2021, the Plan was terminated in connection with The Cooper Companies acquisition of Generate Life Sciences, Inc. Participants were directed to select a method of distribution to either the existing Cooper Companies Plan or the participant's own Plan. All Plan assets were liquidated by April 13, 2022.

**NOTE 6 - FINANCIAL INFORMATION CERTIFIED BY THE CUSTODIAN**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at April 13, 2022 and December 31, 2021, and investment (loss) for the period January 1, 2022 to April 13, 2022 that is disclosed in the accompanying financial statements, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Voya Retirement Insurance and Annuity Company, the custodian of the Plan.

**NOTE 7 - RELATED PARTY TRANSACTIONS**

Certain plan investments are managed by the custodian or its affiliate. Any purchases and sales of these investments, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibitions of party-in-interest transactions under ERISA.

**NOTE 8 - PLAN AMENDMENT**

Effective March 23, 2021, the Plan changed its name from the California Cryobank, LLC Profit Sharing Plan to the Generate Life Sciences Inc. Profit Sharing Plan.

**NOTE 9 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through January 27, 2023, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
