Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2021 Financial Statements

We have performed the audit of the financial statements of Environmental Pest Service, LLC 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2021, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2021 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2021 Financial Statements

Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that the 2021 financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2021 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2021, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Other Matter - Auditors' Report on the 2020 Financial Statements

We were engaged to audit the 2020 financial statements of the Plan. As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed us not to perform and we did not perform any auditing procedures with respect to the information certified by the qualified institution. In our report dated October 8, 2021, we indicated that (a) because of the significance of the information that we did not audit, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion and accordingly, we did not express an opinion on the 2020 financial statements; and (b) the form and content of the information included in the 2020 financial statements other than that derived from the certified information were presented in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

December 31, 2021 and 2020

(1) Description of the Plan

The following description of the Environmental Pest Service, LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

(a) General

The Plan is a defined contribution plan which was initially adopted on March 1, 2015 covering employees of Environmental Pest Service, LLC and its affiliates (the “Plan Sponsor”). The Plan covers substantially all employees who are age eighteen or older and have completed six months of service (“participants”). Eligible employees can begin participating in the Plan on the first day of the month following when the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan Sponsor has adopted a volume submitter plan sponsored by Great-West Trust Company. Upon execution of the Adoption Agreement, the Plan Sponsor established a retirement plan and trust under the Great-West Trust Company Defined Contribution Prototype Plan and Trust. The Plan also has a group annuity contract with Great-West Life & Annuity Insurance Company (“GWL&A”) for a guaranteed interest account.

The Plan Sponsor was acquired by Rentokil USA in 2021. Effective December 31, 2021, substantially all of the Plan’s assets were transferred into the Rentokil Initial USA 401(k) Plan (the “Rentokil Plan”). The guaranteed interest contract was liquidated and transferred to the Rentokil Plan in February 2022 after the provisions of the contract for termination and liquidation were satisfied.

(b) Contributions

Participants may voluntarily make qualified retirement contributions to the Plan which are deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code or may be made after-tax in the form of a Roth 401(k) contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan Sponsor makes a safe harbor match which was equal to 100% of the first 3% as well as 50% of the next 2% of each participant’s salary deferral for 2021.

The Plan also provides that the Plan Sponsor may contribute each year an additional discretionary profit sharing contribution; however, an additional discretionary contribution by the Plan Sponsor is not required. No additional discretionary profit sharing contributions were made by the Plan Sponsor during 2021.

Plan Sponsor and participant contributions may not exceed the maximum amount allowable for federal income tax purposes.

(1) Description of the Plan - Continued

(c) Participant Accounts

Each participant's account is credited (charged) with the participant's contributions, allocations of Plan Sponsor contributions, investment earnings (losses) and administrative expenses. Allocations are based on participant compensation or account balances as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

(d) Vesting

Participants are immediately vested in their elective salary deferral contributions plus actual earnings (losses) thereon as well as in the Plan Sponsor's matching and discretionary profit-sharing contributions.

(e) Notes Receivable from Participants

Each participant may borrow from his or her fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of his or her account balance. A participant may have only one loan outstanding. The notes are secured by the balances in the respective participants' accounts and bear interest at Prime plus 1%, which is determined at the time of the borrowing by the plan administrator. Principal and interest are collected through payroll deductions.

Effective March 27, 2020, the Coronavirus Aid, Relief, and Economic Security ("CARES") Act was signed into law, which provided several relief provisions to tax-qualified retirement plans and their participants. The Plan Sponsor operationally amended the Plan in 2020 to implement the relief provisions under the CARES Act which, among other things, allowed for increased available loan amounts as described to the lesser of \$100,000 or 100% of the participant's vested account balance and extended the period for loan repayments, if applicable, up to one year for loans issued through September 22, 2020. The Plan was formally amended for these provisions effective June 30, 2021.

(f) Payment of Benefits

On termination of service due to death, permanent disability, or retirement (age 65), a participant may elect to receive a lump-sum payment equal to his or her entire account. Withdrawals by a participant while employed are limited to those requested due to events of financial hardship as defined by the plan document and to those participants that have attained age 59 ½. For termination of service due to other reasons, a participant will be entitled to receive only the vested interest in his or her account as a lump-sum distribution. Account balances which are less than \$1,000 do not require participant consent and will be automatically rolled into an IRA.

(f) Payment of Benefits - Continued

In December 2019, the Setting Every Community Up for Retirement Enhancement (“SECURE”) Act was signed into law. Provisions relating to required minimum distributions and the limitation of life-time or stretch distributions to remain compliant under the applicable laws and regulations are effective beginning January 1, 2020. The Plan was formally amended for these provisions effective June 30, 2021.

(g) In-Service Withdrawals

The Plan allows for in-service withdrawals for participants in the form of lump-sums and partial withdrawals. Partial withdrawals are only permitted for participants or beneficiaries who must receive required minimum distributions under Code 401(a)(9). The Plan also allows for distributions at any time from a participant’s rollover account.

The Plan Sponsor operationally amended the Plan in 2020 to implement the relief provision under the CARES Act which allowed for special coronavirus-related distribution up to \$100,000. In June 2020, the Internal Revenue Service issued Notice 2020- 50, which expanded eligibility for special coronavirus-related distributions under the CARES Act and allowed for repayment of these distributions provided the repayment occurs within three years of receipt of the distribution.

(h) Hardship Withdrawals

The Plan permits distributions in the event of a hardship, as defined in the plan document. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount. Hardship withdrawals are allowed from the participant’s vested account balance. The minimum hardship distribution is \$1,000 and a participant may not take more than one hardship distribution during the plan year.

(i) Administrative Fees and Expenses

Certain fees and expenses related to maintaining the Plan are paid directly by the Plan. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments. Fees related to the administration of notes receivable from participants are charged directly to the applicable participants’ accounts and are included in administrative expenses.

(j) Plan Termination

As described in Note 1(a), the Plan merged with the Rentokil Plan, with substantially all plan assets transferring to the Rentokil Plan effective December 31, 2021.

(k) Investment Options

The Plan permits participants to direct investment of their elective deferrals and Plan Sponsor contributions into various investments offered by the Plan.

(2) Summary of Significant Accounting Policies

(a) Basis of Presentation

The financial statements of the Plan are prepared using the accrual basis of accounting.

(b) Investment Valuation and Income Recognition

Investments are reported at fair value, except for the guaranteed interest contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Mutual funds are valued using quoted market prices in active markets. The valuation of the guaranteed interest contract is further described in Note 5.

Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The collective trust funds are valued at the net asset value as determined by Putnam Fiduciary Trust Company, which is based on the investments in which each collective trust fund invests. The collective trust funds are valued daily and participants may buy and sell collective trust funds daily. There are no unfunded commitments.

(c) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document. No allowance was recorded as of December 31, 2021 or 2020.

(d) Payment of Benefits

Benefits are recorded when paid.

(2) Summary of Significant Accounting Policies

(e) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(3) Information Certified by the Custodian and Trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, GWL&A, the custodian, and Great-West, the trustee, have certified that the following data included in the accompanying financial statements is complete and accurate:

- Total investments and notes receivable from participants as of December 31, 2021 and 2020, as shown in the statements of net assets available for benefits;
- Total investment income and related investment activity for the year ended December 31, 2021 as shown in the statement of changes in net assets available for benefits;
- Assets held for investment purposes as of December 31, 2021, as shown in the supplemental schedule.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in these financial statements and supplemental schedule.

(4) Fair Value Measurement

The Plan applies the provisions provided by Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurement*, in measuring fair value. ASC Topic 820 establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value as follows:

Level 1: Observable inputs such as quoted prices in active markets;

Level 2: Inputs, other than quoted prices in active markets, that are observable either directly or indirectly;

Level 3: Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

(5) Fully Benefit-Responsive Investment Contract

The Plan entered into a fully benefit-responsive guaranteed interest contract in a group annuity contract with GWL&A. GWL&A maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed interest contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero. The guaranteed interest contract permits termination of the contract 75 days after written notice is provided.

Because the guaranteed interest contract is fully benefit-responsive, contract value is the relevant measurement. Contract value, as reported to the Plan by GWL&A, represents contributions made under the contract, plus interest credited, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the plan document (including complete or partial termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options; (3) Plan Sponsor initiated events such as spin-off, sale, or merger that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants.

(6) Tax Status

The Plan has adopted a prototype plan sponsored by Great-West which obtained a favorable opinion letter dated June 30, 2020. The Plan is required to operate in conformity with the Internal Revenue Code to maintain its qualification. The Plan has been amended and restated since receiving the opinion letter. However, the plan administrator believes that the Plan is designed, as amended, and is currently being operated, in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Party-In-Interest Transactions

Plan investments consist of a guaranteed interest contract held by GWL&A, the custodian, and mutual funds held by Great-West, the trustee, and therefore, these transactions qualify as party-in-interest transactions. Administrative expenses of approximately \$44,000 and \$23,000, respectively, were paid to the custodian in 2021 and 2020. The Plan holds notes receivable from participants which also qualify as party-in-interest transactions. These transactions are exempted from the prohibited transactions rules.

(8) Risks and Uncertainties

The Plan provides for various investment options in any combination of investment securities as stated in the plan agreement. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(9) Subsequent Events

The Plan's management has evaluated events and transactions that occurred for possible recognition or disclosure in the financial statements through October 17, 2022, the date the financial statements were available to be issued.
