## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Trustee and Plan Administrator of  
Regents Park, Inc. 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Regents Park, Inc. 401(k) Plan. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits in liquidation as of April 29, 2022 (date of Plan termination) and December 31, 2021, and the related statement of changes in net assets available for benefits in liquidation for the period January 1, 2022 through April 29, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from the qualified institution as of April 29, 2022 and December 31, 2021, and for the period of January 1, 2022 through April 29, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter – Basis of Accounting**

As discussed in Note 1 to the financial statements, the governing body of the Plan approved a plan of liquidation on November 1, 2021, and the Plan was formally liquidated on April 29, 2022. As a result, the Plan's basis of accounting uses the liquidation basis in presenting the April 29, 2022 and December 31, 2021 financial statements. Our opinion is not modified with respect to that matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## NOTES TO FINANCIAL STATEMENTS

For the Period January 1, 2022 through April 29, 2022 (Date of Plan Termination)

### NOTE 1 - PLAN DESCRIPTION

#### General

The following description of Regents Park, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

The Plan, which was originally adopted effective October 8, 1991, and subsequently amended, under the legal name of Health Quest Corp. 401(k) Plan, was classified as a defined contribution plan. Effective January 1, 1997, Regents Park, Inc. (the “Plan Sponsor”) assumed the sponsorship and changed the name to Regents Park, Inc. 401(k) Plan. The employees of the Plan Sponsor and related-party employers of Regents Park at Aventura, Inc., CHR Associates, Inc. d/b/a Claridge House, and Stirling LTC Corp. (collectively, the “Company”), who are not covered by a collective bargaining agreement, were eligible to participate in the Plan after they had completed one year of service with at least 1,000 hours of service during the Plan year and had attained the age of 21. The primary purpose of the Plan was to provide employees of the Company with financial benefits upon retirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

In November 2021, participants of the Plan became employees of a new company and began participating in a different plan. No additional employee contributions were made into the Plan after November 16, 2021.

#### Plan Termination

On November 1, 2021, the Plan Sponsor approved the termination of the Plan and commenced liquidation on April 11, 2022. Participants in the Plan became 100% vested as of November 16, 2021. Participants had the option for a direct distribution or a rollover to a qualified benefit plan or individual retirement account. For participants who did not request a distribution of their account, their accounts were closed and distributed according to Internal Revenue Code (“IRC”) rules and limitations. As of April 29, 2022, all Plan assets were either distributed to the participants or rolled over to a qualified benefit plan or individual retirement account. The Plan Sponsor had the right, under the Plan, to terminate the Plan subject to the provisions of the ERISA.

**NOTE 1 - PLAN DESCRIPTION (Continued)**

**Contributions**

Each year participants could have contributed a flat dollar amount or a percentage of their annual gross compensation in increments of 1%. Participants' deductions were made through a salary reduction agreement and may be pre-tax or Roth (after tax) contributions. The Plan Sponsor, at its discretion, could have elected to match a percentage of employee contributions. No matching contributions were made during the period January 1, 2022 through April 29, 2022.

The Plan Sponsor made a contribution to the Plan of \$12,500 during the period January 1, 2022 through April 29, 2022, in order to assist with administrative costs incurred by participants relating to the Plan termination.

**Participant Accounts**

Under the Plan, a separate account was maintained for each participant. Each participant's account was credited with the participant's contribution and allocations of Plan earnings and charged with an allocation of administrative fees, if any. Participant contributions were allocated, at the participant's election, to several investment vehicles in registered investment companies and a group variable funding contract held at the Ascensus (the "Plan Custodian"). Plan earnings were allocated based on the actual earnings of the respective participant's investments. Participants could have changed their investment options at any time with certain exceptions.

**Notes Receivable from Participants**

Participants could have borrowed from their accounts a minimum of \$1,000 up to a maximum of the lesser of 50% of their respective vested balances or \$50,000 by executing a note in accordance with the Plan's provisions. Participants could only have one loan outstanding at any point in time. The notes were collateralized by the balance in the participant's account. Principal and interest were paid ratably through payroll deductions.

**Vesting**

Participants were immediately vested in their voluntary contributions plus actual earnings thereon. Prior to the termination of the Plan (see Note 1), vesting in the employer-contributed portion of their accounts was based on years of continuous service as follows:

**Payment of Benefits**

Upon the death, permanent disability, or retirement of participants, distributions of benefits were made in lump-sum payments or annuities, as elected by the participant. Hardship withdrawals were also permitted under the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The following is a summary of significant accounting policies followed in the preparation of these financial statements, which have been prepared in accordance with accounting principles generally accepted in the United States of America.

**Basis of Accounting**

In 2021, as a result of the Company's election to terminate the Plan, the Plan changed its basis of accounting from the ongoing plan basis to the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America. The change in the basis of accounting did not have a material effect on the financial statements.

**Forfeitures**

Forfeitures of terminated participants were used to reduce employer contributions or pay Plan administrative expenses. There were no unallocated forfeitures as of April 29, 2022 or December 31, 2021. There were no forfeitures used during the period January 1, 2022 through April 29, 2022.

**Investment Valuation and Income Recognition**

Investments in registered investment company fund vehicles were valued at net asset value ("NAV") calculated daily by the fund administrator, based upon the quoted market prices of the underlying securities held by the fund, less unpaid expenses. The registered investment companies held by the Plan were deemed to be actively traded.

The Plan Custodian offered a fully benefit-responsive investment contract ("FBRIC"), which had the MetLife Group Annuity Contract Series 25053 Class 0 (the "MetLife GAC") as the only underlying investment option. Because the MetLife GAC contract was fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to FBRIC because contract value was the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan (see Note 4).

The preceding methods described may produce a fair value or contract value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**Investment Valuation and Income Recognition (Continued)**

Purchases and sales of marketable securities were reflected on a trade-date basis, and interest income was recorded as earned on an accrual basis. Dividends were recorded on the ex-dividend date.

In accordance with the Plan's policy of stating marketable securities at fair value, the appreciation or depreciation for each year is reflected in the statement of changes in net assets in liquidation available for benefits as net appreciation/depreciation in fair value of investments.

**Notes Receivable from Participants**

Notes receivable from participants were recorded at their unpaid principal balance, plus accrued but unpaid interest.

**Corrective Distributions**

Corrective distributions may have been required in the event that employee contributions exceed contribution limitations of the Plan. These amounts were recorded as a liability of the Plan and also reflected on the statement of changes in net assets in liquidation available for benefits as an offset to contributions.

**Contributions**

Contributions to the Plan were recorded in the period in which they became obligations of the Plan Sponsor.

**Payment of Benefits**

Participant benefits were recorded when paid. As of April 29, 2022 (date of Plan termination) and December 31, 2021, there were no amounts allocated to accounts of participants who elected to withdraw from the Plan but had not yet been paid.

**Plan Expenses**

During the year ended December 31, 2022, administrative costs of approximately \$11,000 were charged by the Plan Custodian directly to the Plan. Certain investment fees, commissions, and reporting expenses are included in net depreciation in fair value of investments. The Plan Sponsor incurred administrative expenses on behalf of the Plan of approximately \$18,000 for the period January 1, 2022 through April 29, 2022.

**Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles and with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results may differ from those estimates.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**Subsequent Events**

The Plan Sponsor has evaluated subsequent events for recognition and disclosure through February 13, 2023, which is the date the financial statements were available to be issued.

**NOTE 3 - PLAN CERTIFICATION**

The Plan Custodian held the Plan's investments and executed all investment transactions. All investment information disclosed in the accompanying financial statements, including investments and notes receivable from participants at April 29, 2022 and December 31, 2021, net depreciation in fair value of investments, and dividends and interest for the period of January 1, 2022 through April 29, 2022 was obtained or derived from information supplied to the Plan administrators and certified as complete and accurate by the Plan Custodian.

**NOTE 4 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS**

The Plan had a Collective Investment Trust Agreement of Participation (the "CIT") with Reliance Trust Company where the contract is deemed fully benefit-responsive. The MetLife GAC was the only available investment option in the CIT. MetLife deposited the Plan's contributions in the MetLife GAC, which invests in certain MetLife separate accounts that provided competitive total returns relative to the respective benchmarks, which were based on the Barclays Capital U.S. Aggregate Bond Index and the Barclays Capital U.S. 1 to 3 Year Bond Index.

The MetLife GAC simulated the performance of a guaranteed investment contract through the guarantee of a specific interest rate and a portfolio of financial instruments that are owned by MetLife. The Plan's assets were the unit ownership interests in the MetLife GAC. The separate account investments were owned by MetLife. The MetLife GAC provided that the transactions were executed at contract value. MetLife guaranteed the contract value, which represents contributions, plus interest, less participant-initiated withdrawals or transfers. This is the MetLife GAC's guaranteed value. The Plan's ability to receive amounts due in accordance with the fully benefit-responsive contract was dependent upon the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could have been affected by future economic and regulatory developments. There were no events that limited the ability of the Plan to transact at contract value with the contract issuer that would have also limited the ability of the Plan to transact at contract value.

The CIT provided a fixed interest rate that was reset every quarter, as determined by MetLife. MetLife guaranteed that the rate would never be less than zero.

## NOTE 5 - FAIR VALUE MEASUREMENTS

The fair value of financial instruments was presented based upon a hierarchy of levels that prioritize the inputs of valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

**Level 1** Unadjusted quoted prices in active markets for identical assets or liabilities the Plan has the ability to access at the measurement date.

**Level 2** Inputs to the valuation methodology that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Significant, unobservable inputs used for valuing the asset or liability in which little or no market data exists.

A financial instrument's level, within the fair value hierarchy, is based on the lowest level of input that is significant to the fair value measurement in its entirety.

There were no transfers between any levels during the period January 1, 2022 and April 29, 2022, or the year ended December 31, 2021.

**NOTE 6 - RISKS AND UNCERTAINTIES**

The Plan's investments were not insured and were subject to credit and market risks. Financial information relating to those investments is included in these financial statements based on information provided by the Plan Custodian.

**NOTE 7 - INCOME TAX STATUS**

The original plan was a prototype plan prepared and maintained by a third party. The prototype plan obtained its latest determination letter on December 21, 2018, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. The adopted Plan has been amended since receiving the determination letter; however, the Plan administrator believes that the Plan was designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.
