Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Volta LLC 401(K) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of February 15, 2022 (date of liquidation) and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 through February 15, 2022 (date of liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Volta LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of February 15, 2022 (date of liquidation) and December 31, 2021 and for the period January 1, 2022 through February 15, 2022 (date of liquidation), stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

Basis for Opinion

Volta LLC 401(k) Plan Notes to the Financial Statements

Note 1: DESCRIPTION OF THE PLAN

The following description of the Volta LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to Plan documents for a more complete description of the Plan provisions.

General

The Plan was adopted effective January 1, 2017, and is a defined contribution plan covering substantially all employees of Volta LLC (the “Company” or “Plan Sponsor”). The Plan is subject to the provisions of the Department of Labor’s (DOL’s) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Plan’s management determines the appropriateness of the Plan’s investment offerings, and monitors investment performance.

Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are held and managed by Massachusetts Mutual Life Insurance Company (“Mass Mutual” or the “Trustee”), which invests contributions and Plan earnings, makes investment transactions as directed by Plan management. Empower Retirement, LLC (“Empower”) performs certain recordkeeping services on behalf of the Plan. Loren D. Stark Company acts as the third-party administrator for the Plan, which performs certain plan administration and annual ERISA compliance testing.

In February 2022, the Plan was merged into their parent company’s 401(k) plan, the Blue Wind 401(k) Plan. The Plan’s net assets were transferred into the Blue Wind 401(k) Plan and were recognized in the accounts of the Blue Wind 401(k) Plan as of February 15, 2022 (date of liquidation). The Company became a participating employer of the Blue Wind 401(k) Plan effective January 2022.

Coronavirus Aid, Relief, and Economic Security Act of 2020

On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security Act of 2020 (the “CARES Act”) was passed by Congress. The CARES Act, among other things, includes several temporary relief provisions available to tax qualified retirement plans and their participants. Plan management evaluated the impact of the CARES Act on the Plan and approved changes to the Plan in 2020 to temporarily add (i) add Coronavirus related distributions (“CRDs”) of up to \$100,000 for eligible participants, (ii) permit employees to repay CRDs within three years of the date of distribution as a rollover contribution, (iii) increase the limit on Plan loans for eligible participants to the maximum permitted under the CARES Act, (iv) suspend payments on Plan loans otherwise due in 2020 for eligible participants, and (v) suspend required minimum distributions for 2020.

Volta LLC 401(k) Plan Notes to the Financial Statements

Note 1: DESCRIPTION OF THE PLAN (Continued)

Eligibility

Employees may become a participant of the Plan when they have reached three months of service and are age twenty-one or older. An eligible employee may enter the Plan on the first day of the month following the date requirements are met.

Contributions

Each year, participants may contribute up to 100% of their annual pre-tax compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Plan includes a safe harbor employer matching contribution provision whereby the Company will match 100% of the participants' contributions up to 4% of compensation. The Company may also make discretionary matching contributions based upon a uniform percentage of compensation or participant contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Upon enrollment in the Plan, participants may direct the investment of their individual accounts among various investment funds provided under the Plan. Participants may change their investment elections at any time, as well as transfer existing balances between investment funds.

For the period January 1 through February 15, 2022 (date of liquidation), the Company made safe harbor matching contributions of \$5,611. There were no discretionary matching contributions to the Plan in 2022. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Contributions ceased effective December 31, 2021 as a result of the merger of the Plan into the Blue Wind 401(k) Plan as described in Note 1. The contributions reported in the accompanying financial statements were December 2021 contributions deposited into the Plan in January 2022.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company's matching contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, the Company's safe harbor and discretionary matching contributions, plus actual earnings thereon.

Volta LLC 401(k) Plan Notes to the Financial Statements

Note 1: DESCRIPTION OF PLAN (Continued)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. The loans are secured by the balance in the participant's account. The loan interest rate is set by the Plan Administrator and is generally equal to the prime rate. Participants are allowed to have two loans outstanding at any time. Principal and interest are paid ratably through monthly payroll deductions.

Plan management approved changes related to the CARES Act in 2020, increasing the limit on Plan loans for eligible participants to the lesser of \$100,000 or 100% of the participant's vested account balances in 2020 and permitting eligible participants to suspend payments on Plan loans otherwise due in 2020.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested portion of the amount credited to their account. A withdrawal can be made at the age of 59½ or upon normal retirement on all or a portion of the participants' vested account. At the age of 70½, a participant is required to receive minimum required distributions from their account annually. Partial or total withdrawals from employee rollovers can be made at any time.

Plan management approved changes related to the CARES Act in 2020, permitting eligible participants to take CRDs of up to \$100,000 without a 10% early withdrawal penalty in 2020 and suspend required minimum distributions for 2020.

Hardship Withdrawals

As permitted by the Internal Revenue Code (IRC), a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The participant must meet the condition that they cannot relieve the amount of the need by stopping the elective contributions to the Plan. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

Participants also have the option to take hardship distributions prior to taking a loan from the Plan.

Volta LLC 401(k) Plan Notes to the Financial Statements

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Use of Estimates

The preparation U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments generally are reported at fair value, but may also be reported at contract value or net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 4 and 5 for further discussion of fair value measurements, contract value, and NAV. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2021. There was no outstanding loan balance at February 15, 2022 (date of liquidation) as all loans were transferred to the Blue Wind 401(k) Plan in conjunction with the merger of the Plan.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Administrative Expenses

Expenses attributable to the general Plan administration were paid by the Plan and allocated among the accounts of all participants, in proportion to their account balances, unless paid by the Company. During the period January 1, 2022 through February 15, 2022 (date of liquidation), expenses of \$626 were paid by the Plan and allocated to participant accounts.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, credit risks and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect amount reported in the Plan's financial statements.

Subsequent Events

Management has evaluated subsequent events through the date that the financial statements were available to be issued, January 31, 2023. See Note 9 for relevant disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

Note 3: INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements has been derived from information certified to be complete and accurate by the Trustee under such regulation:

- a) Total investments, at fair value and contract value, included in the statements of net available for benefits at February 15, 2022 (date of liquidation) and December 31, 2021;
- b) Notes receivable from participants included in the statements of net assets available for benefits at February 15, 2022 (date of liquidation) and December 31, 2021;
- c) Investment income and interest income on notes receivable from participants information included in the statement of changes in net assets available for benefits for the period January 1, 2022 through February 15, 2022 (date of liquidation);
- d) All amounts included in Note 4, *Fair Value Measurements (Unaudited)*; and
- e) All amounts included in Note 5, *Investment Reported at Contract Value (Unaudited)*.

Note 4: FAIR VALUE MEASUREMENTS (UNAUDITED)

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

Level 1 - Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2 - Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
 - observable; or
 - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. The methodologies used are consistent for February 15, 2022 (date of liquidation) and December 31, 2021.

Pooled Separate Accounts: Variable annuities valued at NAV per share as determined by the issuer based on market quotations of the underlying investments or price obtained from independent sources who may employ various pricing methods to value the underlying securities. The pooled separate accounts balance as of February 15, 2022 (date of liquidation) and December 31, 2021 of \$0 and \$8,815,751, respectively are measured at fair value using the NAV per share (or its equivalent practical expedient); therefore, they have not been classified in the fair value hierarchy, in accordance with ASU 2015-07.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: INVESTMENT REPORTED AT CONTRACT VALUE (UNAUDITED)

In 2017, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Mass Mutual totaling \$0 as of February 15, 2022 and \$280,954 as of December 31, 2021. Mass Mutual maintained the contributions in a fixed account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but may not be less than 1%. The crediting rate was reviewed on a quarterly basis for resetting. The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value was the relevant measure for fully benefit-responsive investment contracts because this was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Mass Mutual, represented contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

Note 6: TAX STATUS

The Plan adopted Mass Mutual's Volume Submitter Profit Sharing Plan. Mass Mutual received an opinion letter from the IRS, dated March 31, 2014, which stated that this prototype plan satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, the Plan is qualified and the related trust is tax-exempt.

Tax positions are recognized only if it is "more likely than not" that the tax position be sustained in a tax examination, with a tax examination presumed to occur. The amount recognized is the largest amount that is greater than 50% likely of being realized on examination. For tax positions not meeting the "more likely than not" test, no tax position is recorded. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments include notes receivable from participants. As a result, these receivables and all transactions relating to these receivables were with parties-in-interest. These transactions are exempt from being prohibited transactions by ERISA.

Additionally, the Plan invests in investments offered by the Trustee, as approved by the Plan's management. These investments are considered party-in-interest transactions. These transactions are exempt from being prohibited transactions by ERISA.

The Plan incurs expenses related to general administration and recordkeeping with Empower which qualify as party-in-interest transactions and are exempt from being prohibited transactions by ERISA.

Note 8: PLAN TERMINATION

Prior to the merger of the Plan discussed in Note 1, the Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 9: SUBSEQUENT EVENTS

Management of the Plan evaluated all events or transactions that occurred after February 15, 2022 through January 31, 2023, the date of the Plan's financial statements were available to be issued. The following item was noted:

The Department of Labor (DOL Regulation 2580.412-11) requires an employer to segregate participant contributions and loan repayments from its general assets as soon as practicable, but in no event later than the 15th business day following the end of the month in which amounts are contributed by participants or withheld from their wages. During 2021, the Company failed to segregate contributions totaling \$6,097 in a timely manner. As required by the Department of Labor, the late remittances continue to be reported as late through the year the lost earnings are contributed. The Company calculated lost earnings pursuant to guidelines established by the DOL. The lost earnings are immaterial to the financial statements. Hence, they are not recorded in the accompanying financial statements. The Company remitted the delinquent contributions and related lost earnings and interest, filed Internal Revenue Service Form 5330, and paid all applicable excise taxes on December 14, 2022.
