Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Valley Packaging Supply Co., Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Our opinion has not been modified with respect to this matter.

Note 1 - Plan Description

The following description of Valley Packaging Supply Co., Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of Valley Packaging Supply Co., Inc. (the "Company") who have completed two months of service and are age 21 or older. Prior to January 1, 2022, employees were required to complete six months of service and be age 21 or older prior to becoming eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan also allows participants to make Roth contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Prior to January 1, 2022, the Plan included an automatic enrollment provision where all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 6 percent of eligible compensation and their contributions invested in the appropriate target retirement account in accordance with the qualified default investment alternatives established under the Plan until changed by the participant.

Effective January 1, 2022, the Company's safe harbor contribution is equal to 100 percent of participant deferrals up to 3 percent of each participating employee's elective deferral, plus 50 percent of the next 2 percent of the participant's deferrals. Prior to January 1, 2022, the Company's safe harbor contribution was equal to 100 percent of participant deferrals up to 1 percent of each participating employee's compensation, plus 50 percent of each participant's elective deferrals in excess of 1 percent, not to exceed 6 percent of the participating employee's compensation.

The Company has the option to make nonelective discretionary contributions to the Plan. No nonelective discretionary contributions were made during 2022.

Vesting

Participants are immediately vested in their contributions, rollover contributions, safe harbor contributions, and employer nonelective discretionary contributions, plus actual earnings thereon. Prior to January 1, 2022, vesting in the Company's safe harbor matching contribution portion of their accounts was based on years of service. Participants were 0 percent vested in the Company's safe harbor matching contribution until they had completed two years of credited service. After the two-year vesting period, participants became fully vested in the Company's safe harbor matching contribution.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Sentry Life Insurance Company or its affiliates. Sentry Life Insurance Company is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Note 1 - Plan Description (Continued)

Termination

As discussed in Note 3, the Plan was terminated effective April 1, 2022. All assets of the Plan were transferred into a plan sponsored by an affiliate of the Company prior to termination; therefore, participants did not become 100 percent vested in their account balances at the date of termination.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Benefit Payments

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount or installment payments equal to the vested balance of a participant's account. In-service distributions from a participant's account are available to employees over the age of 59½. Effective January 1, 2022, hardship distributions can be taken from a participant's elective contribution portion of their account subject to plan requirements.

Participant Notes Receivable

Effective January 1, 2022, participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the Internal Revenue Code. Notes receivable bear interest at a market rate. There were no participant loans outstanding at December 31, 2021 or April 1, 2022.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value except as noted below. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants measured at the measurement date. The fully benefit-responsive unallocated contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The pooled separate accounts are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. See Note 5 for additional information.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Note 2 - Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including February 10, 2023, which is the date the financial statements were available to be issued.

Note 3 - Plan Merger

On April 1, 2022, the Plan merged with a plan sponsored by an affiliate of Valley Packaging Supply Co., Inc. Accordingly, participants, their account balances, and all assets of the Plan were transferred to the other plan on April 1, 2022. Once the assets were transferred, the Plan was terminated.

Note 4 - Unaudited Information

Sentry Life Insurance Company (the "Custodian") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements are based solely on information certified by the Custodian.

Note 5 - Fair Value Measurements

Investments measured at NAV at April 1, 2022 and December 31, 2021 were as follows:

There were no unfunded commitments or redemption restrictions on the investments described above.

Note 6 - Unallocated Contract

The Plan has a benefit-responsive investment contract with Sentry Life Insurance Company (Sentry Life). Sentry Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Deposited amounts and accumulated interest are held in Sentry Life's general account. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. To the extent Sentry Life's actual investment results exceed the guaranteed interest rate, Sentry Life retains the excess investment income as revenue.

Note 6 - Unallocated Contract (Continued)

The guaranteed interest rate is based on a formula agreed upon with the issuer, which is reviewed and reset annually. During 2022, the guaranteed interest rate was 1.75 percent. The interest rate generally is guaranteed for 12 months, and new rates are communicated by Sentry Life to employers and contract holders at least 30 days before they take effect. The rate could be influenced by the performance of the underlying investments held by Sentry Life. Corporate bond yields and the return on other possible investments supporting the guaranteed fund are subject to forces in the economy.

No transfers are allowed into the fund for 30 days following a transfer out. Upon termination, the Plan and its participants are not subject to a surrender charge as a result of terminating the contract. A market value adjustment may be assessed if the contract is terminated or if more than 20 percent of the fund assets is withdrawn or transferred to another investment during any 12-month period. The plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable.

Note 7 - Tax Status

The Plan is a prototype plan. The prototype plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.
