Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Spinnaker 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 27, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the plan period of January 1, 2022 to July 27, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Spinnaker Holding Inc. was sold and the Plan was terminated on January 31, 2022, with plan assets being fully distributed as of July 27, 2022.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE A – DESCRIPTION OF PLAN

The following description of the Spinnaker 401(k) Plan (the “Plan”) is provided for general information purposes. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

On January 31, 2022, Spinnaker Coating, LLC was acquired by Morgan Adhesives Company, LLC, a Lintec company. In conjunction with the closing of this transaction, Spinnaker Holding Inc. terminated the Plan, and there were no additional employee or employer contributions made to the Plan. As a result, all participant accounts in the Plan became 100% vested.

General Information

The Plan is a voluntary, defined contribution plan covering all eligible employees of Spinnaker Holding Inc. (“the Company”), formerly Spinnaker Coating, LLC. The Plan, formerly known as the Spinnaker Coating, LLC 401(k) Plan, changed its name to the Spinnaker 401(k) Plan in 2012 upon a change in name of the plan sponsor. Employees who are not covered by a collective bargaining agreement and who are age 18 or older are eligible to participate in the Plan. Eligible participants may enter the Plan upon satisfaction of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is qualified under the Internal Revenue Code.

Contributions

Each year, participants could contribute up to the maximum dollar allowed by the Internal Revenue Service of their eligible annual compensation, as defined by the plan document. Participants who attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined contribution, governmental deferred compensation, or tax-sheltered annuities and Individual Retirement Account plans. Participants could direct investment of their account balances into various investment options offered by the Plan. The Plan offered 30 funds as investment options for participants.

As of October 1, 2018, the Plan was amended to add automatic enrollment for employees meeting eligibility requirements after October 1, 2018 and who do not make an affirmative election. The automatic deferral election was initially 3% of their compensation for year one and increased by 1% in years two through eight to a maximum of 10%.

The Company could contribute to the Plan a portion of net profits at its discretion. The Company elected to forego contributions in both 2022 and 2021.

Participant Accounts

Each participant's account was credited with the participant's contributions and withdrawals, as applicable, and an allocation of the Company's contributions, if any, and plan earnings, and charged with an allocation of asset management fees and transaction-based fees, as applicable. Allocations were based on participant earnings or account balances, as defined. Allocations of employer profit sharing contributions, if any, were made only to participants who were credited with 1,000 hours of service during the plan year and were employed on the last day of the plan year. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their voluntary contributions (including catch up contributions) and rollovers, plus the related earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts, plus actual earnings thereon, was based on years of service. A participant is 100% vested evenly over five years of credited service.

Participant Loans

Participants could borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. If a participant had a loan balance in the most recent prior period, the maximum loan amount was \$50,000 or 50% of their vested balance less the highest loan balance in the prior period. Loan terms range from 1-5 years. The loans were secured by the balance in the participants' account. The rate of interest to be paid by the participant must be commensurate with the rate of interest charged on similar commercial loans by persons or institutions in the business of lending money in the same geographic area as the Company. There were no outstanding loans as of July 27, 2022.

Distributions

Upon termination of service due to death, disability, or retirement, a participant could elect to receive his or her vested account balance as either a lump-sum amount or installments over a period of not more than his or her assumed life expectancy. Hardship withdrawals could be authorized for the following reasons: (a) purchase of primary residence, (b) tuition expense for post-secondary education, (c) medical expenses, (d) prevention of foreclosure on a primary residence, (e) funeral or burial expenses for parents, spouse, children, or dependents, and (f) repair damage expenses to primary home that would be tax deductible. In-service withdrawals were also allowed upon attainment of age 59 ½.

Forfeitures

Forfeitures resulting from the non-vested portion of participants' accounts who terminated prior to being fully vested were generally used first to pay the administrative expenses of the Plan, and any remaining amounts used to reduce future Company contributions. At July 27, 2022 and December 31, 2021, forfeitures totaled \$0 and \$3, respectively. During the period of January 1, 2022 to July 27, 2022, there were no forfeitures used to reduce administrative expenses.

Plan Termination

The Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination, participants will become 100% vested in the employer portion of contributions. As noted in Note A, the Plan was terminated on January 31, 2022, and all participants became 100% vested.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Administrative Expenses

Some expenses for the administration of the Plan are paid by the Company. Administrative expenses paid by the Plan were \$39,208 for the period of January 1, 2022 to July 27, 2022.

Investment Valuation and Income Recognition

Investments are reported at fair value (see Note D). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. The Plan presents in the accompanying statement of changes in net assets available for benefits the net appreciation or depreciation in the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Payment of Benefits

Benefit payments are recorded when approved. There were no approved but unpaid distribution requests as of July 27, 2022 or December 31, 2021.

NOTE C – INVESTMENTS (INFORMATION CERTIFIED BY THE PLAN TRUSTEE)

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, all investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at July 27, 2022 and December 31, 2021, net depreciation in fair value of investments, dividends and interest for the period of January 1, 2022 to July 27, 2022, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Trust Company, the plan trustee.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE D – FAIR VALUE MEASUREMENTS

Accounting Standards Codification Topic 820, *Fair Value Measurements* (ASC Topic 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 27, 2022 and December 31, 2021.

Collective investment trusts - measured at net asset value: made up of investments in a collective investment trust which invests in a collective trust fund as well as a variety of separate accounts and mutual funds. The fair value of the collective investment trust and the separate accounts are not publicly quoted pricing inputs. The fair value of mutual funds are publicly quoted pricing inputs. The fair value of the underlying investments are used in determining the Net Asset Value ("NAV") of the collective investment trust. When NAV is used as an estimate of fair value, the investments shall not be categorized within the fair value hierarchy.

Pooled separate accounts – measured at net asset value: Investments in pooled separate accounts are valued using the unadjusted NAV as of the reporting date, which is the basis for current transactions. The NAV is used as a practical expedient to estimate fair value. Pooled separate accounts are valued based on the underlying investments (i.e., common stock, mutual funds, and short-term securities) in the separate account as reported by Principal Life Insurance Company (“Principal Life”). While the majority of the underlying assets values are based on quoted prices, NAV of the pooled separate accounts are not publicly quoted. The NAV is reported by Principal Life as of the financial statement date based on recent transaction prices. The pooled separate accounts held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date.

Mutual Funds: stated at fair value as determined by observable Level 1 quoted market pricing inputs.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of July 27, 2022:

NOTE F – TAX STATUS

The plan sponsor obtained its latest determination letter on March 31, 2008, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that are more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in process. The plan administrator believes it is no longer subject to income tax examinations for plan years prior to 2019.

NOTE G – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participants' individual account balances.

NOTE H – PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan and employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments were shares of collective investment trusts and pooled separate accounts managed by Principal Trust Company, a member of Principal Financial Group, is the trustee, as defined by the Plan, and qualifies as a party-in-interest. Fees for custodian services paid by the Plan to the trustee were \$38,633 for the period of January 1, 2022 to July 27, 2022.

The Plan also issued loans to participants, which were secured by the balances in the participants' accounts. Certain administrative services were provided by the Company at no cost to the Plan and certain administrative expenses of the Plan were paid by the Company.

NOTE I – CORRECTIVE DISTRIBUTIONS

The Plan failed to pass the Average Deferral Percentage Test for the plan period from January 1, 2022 to January 31, 2022 (date of Plan termination) and for the plan year ended December 31, 2021.

The accompanying statements of net assets available for benefits included a liability of \$34,226 as of December 31, 2021, related to the excess contributions payable to the participants. The Plan distributed these corrective distribution amounts to the participants within three months after the Plan's year end. Corrective distributions due to participants for the period from January 1, 2022 to January 31, 2022 were paid in full prior to July 27, 2022.

NOTE J – SUBSEQUENT EVENTS

In connection with the preparation of the Plan's financial statements as of July 27, 2022, events and transactions subsequent to July 27, 2022 through February 9, 2023 have been evaluated by the plan administrator for possible adjustment and/or disclosure. As the Company was sold and the plan was terminated on January 31, 2022, with Plan assets being fully distributed by July 27, 2022, no other subsequent events requiring financial statement adjustment and/or disclosure have been identified.
