We have performed audits of the financial statements of the Segrest, Inc. 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of January 10, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period ended January 10, 2022, and the related notes to the financial statements.

### 1. Plan Description

The following description of the Segrest, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions. Effective January 1, 2022, the Plan merged into the Central Garden & Pet Investment Growth Plan. The assets were transferred from the Plan on January 10, 2022. Assets transferred include total investments of \$3,270,214 and notes receivable from participants of \$52,598.

#### *General*

The Plan was adopted effective January 1, 2006, and most recently restated January 1, 2016 by Segrest, Inc. (Plan Sponsor) and affiliated employers (the Company). The Plan is a defined contribution plan covering substantially all eligible employees of the Company, as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The trustee of the Plan is Great-West Life & Annuity Insurance Company (Great-West or Trustee). The administrator of the Plan is the Company. The Trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The Plan administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Eligibility*

Participants become eligible to make elective salary deferrals on the first day of the calendar month following the completion of a minimum of 500 hours of service within a six-month period commencing on the employment date, and attainment of 21 years of age. In order for participants to become eligible to receive Company non-elective contributions, they must complete one year of eligibility service, as defined by the Plan. Notwithstanding the foregoing, the service requirement is met when a participant completes 1,000 hours of service in the eligibility computation period, as defined by the Plan. In order for participants to become eligible to receive Company discretionary profit-sharing and matching contributions, they must be employed by the Company on the last day of the Plan year and have completed 1,000 hours of service.

#### *Contributions*

Each year, participants may contribute an amount up to 75% of annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Company may make discretionary profit-sharing, matching, or qualified non-elective contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Effective January 1, 2022, the Plan was frozen and no contributions were made during the period ended January 10, 2022.

#### *Participant Accounts*

Each participant's account is credited with the participant's and Company's contributions, and allocations of the Plan's earnings, and charged with benefits payments and an allocation of the Plan's losses and administrative expenses. Plan earnings and losses are allocated based on account balances, while contributions are credited based upon elective deferrals and compensation, as

defined. Administrative expenses are charged directly to the accounts of the participants who incur those fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

All participant contributions and Company qualified non-elective contributions, and the related earnings thereon, are at all times fully vested. Vesting in the Company's matching and profit-sharing contributions, plus actual earnings thereon, is determined under the following schedule:

A participant will become fully vested in Company contributions upon attainment of normal retirement age while an employee of the Company.

### ***Payment of Benefits***

Upon termination of employment, retirement, disability, or death, if the participant's vested account balance does not exceed \$5,000, the participant may elect to receive the vested account balance in a single lump-sum payment or roll over the distribution to an individual retirement account (IRA) or another retirement plan. If the vested account balance is more than \$1,000 and less than \$5,000, and the participant does not make an election, the Plan automatically will roll over the distribution to an IRA designated by the Plan administrator. If the vested balance is less than \$1,000, it will be distributed to the participant in a single lump-sum payment. If the vested balance exceeds \$5,000, the participant may elect to receive the vested account balance in a single lump-sum payment, roll over the distribution to an IRA or another retirement plan, receive installments, or defer receiving payments until the age of 70½. Hardship withdrawals may be requested from elective deferrals and rollover contributions and are paid in one lump sum upon approval. In-service distributions may be made to participants who have attained age 59½. Effective January 1, 2022, the Plan was frozen and no distributions were made during the period ended January 10, 2022.

### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum amount of \$1,000 and a maximum amount equal to the lesser of (a) \$50,000, less the excess of the highest outstanding balance of any loan outstanding during the one-year period ending on the day before the loan is made, over the outstanding balance of any loan on the date the loan is made; or (b) 50% of the participant's nonforfeitable account balance. Participants may only have one loan outstanding at any given time. The loans are secured by the balance of the participant's account. Interest rates are determined by the Plan administrator based on rates of similar commercial loans and are set at prime plus 1%. Loan repayments are made ratably through payroll deductions over a period not to exceed five years. These loans are subject to certain restrictions as defined by the Plan document and applicable restrictions under the Internal Revenue Code (IRC).

### *Forfeitures*

Forfeitures may be used to pay administrative expenses or to reduce Company contributions. There were no unallocated forfeitures as of January 10, 2022. There was \$28 in unallocated forfeitures as of December 31, 2021. During the period ended January 10, 2022, \$28 of forfeitures were transferred to another qualified plan.

## **2. Summary of Accounting Policies**

### *Basis of Accounting*

The financial statements of the Plan have been prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received primarily through payroll deductions, and the notes are collateralized by the participants' account balances. Delinquent notes receivable from participants are recorded as distributions based on terms of the Plan document.

### *Investment Valuation and Income Recognition*

The Plan's investments in pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Administrative Expenses*

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid by the Company are excluded from these financial statements. Certain transaction fees for loan issuances and distributions are charged directly to the accounts of the participants who incur those fees. Any costs associated with the investment of a participant's account are charged to that participant.

### *Subsequent Events*

The Plan has evaluated subsequent events through and including February 15, 2023, which is the date the financial statements are available to be issued. No material events have occurred since January 10, 2022, that require recognition or disclosure in the financial statements.

### **3. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2022 and 2021.

*Pooled Separate Accounts (PSAs)* - These accounts invest directly in designated actively traded mutual funds, which are valued daily at their net asset values (NAV). The NAV is used as a practical

expedient to estimate fair value. The Plan holds units of participation in the separate accounts, which are valued daily at their accumulation unit value. Accumulation unit value is determined based on the NAV of the shares of the underlying mutual funds, the funds' dividends, and the contract's separate account charges. There are no redemption restrictions or unfunded commitments on these investments. The underlying mutual funds include the following:

(a) *Large Cap* - This seeks primarily long-term growth of capital and income and invests in common stocks and other equity securities of large-capitalization companies.

(b) *Asset Allocation/Balanced* - This seeks to provide capital appreciation and income consistent with asset allocation and invests in various U.S. and foreign stocks and bonds and is primarily intended for investors' target retirement dates.

(c) *Bond* - This seeks a high level of current income and invests in high-yield, fixed-income securities, and U.S. and foreign debt securities, including those in emerging markets.

(d) *International/Global* - This seeks capital growth and invests primarily in securities of companies located outside the United States.

(e) *Mid Cap* - This seeks primarily long-term growth of capital and invests in a diversified portfolio of equity securities of mid-capitalization companies.

(f) *Small Cap* - This seeks primarily long-term total return and invests in small-capitalization companies.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As the Plan's PSAs are measured at fair value using the NAV per share (or its equivalent) practical expedient, they have been excluded from the fair value hierarchy. The Plan does not have any Level 1, 2, or 3 financial instruments.

#### 4. Group Annuity Contract

The Plan entered into a fully benefit-responsive group variable funding agreement with Talcott Resolution Life Insurance Company (TRLIC). Under the terms of this agreement, a crediting rate is established for amounts invested in the fixed account. The declared interest rate at January 10, 2022 and December 31, 2021 was 3.0%. TRLIC maintains the contributions in a general account guaranteed by the insurance company's claims-paying ability. The insurance company's general account is primarily invested in investment-grade fixed-income securities.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measurement attribute for that portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus credited interest, less participant withdrawals and fees. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value. If the contract is fully or partially terminated, amounts invested in the fixed account may be subject to a market value adjustment based upon a formula contained in the contract. The Plan administrator has not expressed any intention to fully or partially terminate the contract.

### 5. Information Certified by Qualifying Institutions

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Great-West, a qualified institution, has certified that the following investment information included in the accompanying financial statements is complete and accurate:

At the request of the Plan administrator, the Plan's independent accountants did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

### 6. Plan Termination

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their account balances.

As described in Note 1, the Plan was merged into the Central Garden & Pet Investment Growth Plan effective January 1, 2022.

### 7. Tax Status

The Plan is based on a Volume Submitter 401(k) Profit Sharing Plan (the Volume Submitter Plan). The IRS ruled on March 31, 2014 that the Volume Submitter Plan qualifies under Section 401(a) of

the IRC under the volume submitter program, and the related trust is, therefore, not subject to tax under the present income tax law. The Plan has been amended since receiving the ruling. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the financial statements.

GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. Party-in-Interest and Related Party Transactions

Certain Plan investments are held and managed by TRLIC. The Plan also pays investment management fees and administrative service fees to TRLIC and Great-West. These transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as exempt party-in-interest transactions.

### 9. Risks and Uncertainties

The Plan merged into the Central Garden & Pet Investment Growth Plan effective January 1, 2022. As the Plan had no investments as of January 10, 2022, the Plan was not exposed to any risks and uncertainties relating to investments.
