The financial statements comprise the statements of net assets available for benefits as of April 21, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the period from January 1, 2022 to April 21, 2022 and the year ended December 31, 2021, and the related notes to the financial statements.

**NOTES TO FINANCIAL STATEMENTS
APRIL 21, 2022 AND 2021**

1. DESCRIPTION OF PLAN

The following description of Herkimer County Chapter of NYSARC, Inc., d/b/a Arc Herkimer, Pension Plan Number 002 (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a single-employer, defined contribution 401(k) pension plan covering substantially all employees of Herkimer County Chapter of NYSARC, Inc., d/b/a Arc Herkimer (the Company) who have at least one year of service in which 1,000 hours were worked and are at least 20½ years of age. The Plan was amended effective January 1, 2018 to only require 3 months of service prior to becoming eligible to begin participant deferrals. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In July 2020, The Arc New York Board of Governors approved a resolution to create a single retirement plan for all NYSARC Chapters (NYSARC Plan). On February 28, 2022, the Company adopted a resolution to transfer all Plan assets to the NYSARC Plan effective April 21, 2022. Assets totaling approximately \$10.9 million were transferred to the NYSARC Plan on April 21, 2022.

Administration

The Company administers the Plan. A portion of the administrative expenses of the Plan are paid by participants. Benefit Plans Administrative Services (BPAS) is the third-party administrator and Hand Benefits & Trust Company (HBTC) is the custodian of the Plan's assets.

Contributions

The Company contributes a discretionary amount of each eligible participant's compensation to the Plan on an annual basis. Participants may contribute up to 75% of their annual compensation, as defined in the Plan document, up to the maximum allowed by the Internal Revenue Code. There were no Company contributions in 2022. The Company contributed 2% plus an additional match of participant contributions up to 3% for the Plan year ending December 31, 2021.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contributions plus earnings thereon is based on years of service. Participants are 20% vested in the Company's contribution after two years of service. Vesting increases in increments of 20% for each additional year of service thereafter until 100% vesting occurs after six years. Employees are automatically vested if they are at least 65 years of age.

Rollover Contributions

The Plan accepts direct rollover contributions from a qualified plan, as defined by the Plan.

1. DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account was credited with the participant's contributions, the Company's contributions, an allocation of the Plan earnings/losses on all contributions and an allocation of administrative expenses. Allocations were based on participant earnings/losses or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow an amount up to the lesser of 50% of the amount of their vested balance or \$50,000. The loan amount cannot exceed the maximum amount imposed by the Internal Revenue Code. A participant may borrow a minimum of \$1,000. Loans are repayable over not more than five years, except in the case of a loan for the purchase of a primary residence. Participants must make loan payments through payroll deduction. All loans bear interest at prime plus 1% at the date of the loan.

Benefit Payments

Upon termination of service due to death, disability or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, an annuity or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution, deferred annuity or plan-to-plan transfer. Participants are entitled to receive an in-service distribution if certain requirements are met in accordance with the Plan document.

Hardship Withdrawals

The Plan allows for hardship withdrawals in accordance with the Internal Revenue Service regulations as specified within the Plan document. Benefit payments are recorded when paid.

Forfeitures

The non-vested portion of terminated participant account balances is subject to forfeiture. The forfeiture will remain in an interest-bearing suspense account unless employment with the Company is resumed within the same plan year. The balance of the forfeiture account is applied to reduce the Company's contribution to the Plan. Forfeitures of approximately \$0 and \$29,000 were applied to reduce the Company's contribution to the Plan for the period from January 1, 2022 to April 21, 2022 and year ending December 31, 2021, respectively. The total forfeited non-vested balances at April 21, 2022 and December 31, 2021 were \$0 and \$41,060, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan document, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Plan Administrative Costs

The Company pays certain administrative costs of the Plan and certain costs were passed through to participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investments

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both realized and unrealized gains and losses on those investments. All investments are participant directed.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of April 21, 2022 and December 31, 2021.

Fair Value Measurement

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under GAAP are described below:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurement (Continued)

The following is a description of the valuation methodology used for assets measured at fair value:

Mutual funds: Valued at the net asset value of shares held at year-end based on quoted prices in active markets.

There were no changes in the valuation methodologies used during 2022 or 2021.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Payment of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that may affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

3. INVESTMENT CONTRACT

The MetLife Stable Value Fund is a benefit-responsive guaranteed investment contract issued by Metropolitan Life Insurance Company (MetLife). MetLife provides participants with guaranteed interest earnings of at least 1.5% for both 2022 and 2021, while reducing investment risk. The account is credited with earnings on the underlying investments and charged for participant withdrawals.

The investment is included in the financial statements at contract value. Contract value represents contributions made, plus investment income, less funds used to pay retirement benefits. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

MetLife will reset the rate by amortizing the difference between the market value of the portfolio and the guaranteed value over the weighted average duration of the Fund's investments. Participants will receive the principal and accrued earnings credited to their accounts on withdrawal for allowed events. These events include transfers to other Plan investment options, and payments because of retirement, termination of employment, disability, death and in-service withdrawals as permitted by the Plan. Generally, there are not any events that could limit the ability of the Plan to transact at contract value. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

4. FAIR VALUE MEASUREMENTS

6. INCOME TAXES

BPAS obtained a determination letter for the Plan prototype on March 31, 2008, in which the Internal Revenue Service stated that the Plan prototype and related trust were, at that time, designed in accordance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. PARTY-IN-INTEREST TRANSACTIONS

BPAS is the trustee and HBTC is the custodian of the Plan's assets. As such, transactions between BPAS, HBTC and the Plan qualify as party-in-interest transactions. Additionally, notes receivable from participants are party-in-interest transactions.

8. RECONCILIATION TO FORM 5500

The classification of changes in net assets available for benefits for the period January 1, 2022 to April 21, 2022 and year ended December 31, 2021 differs between these financial statements and Form 5500. However, the total change in net assets available for benefits for the period January 1, 2022 to April 21, 2022 and the year ended December 31, 2021 agrees between these financial statements and Form 5500.

9. SUBSEQUENT EVENTS

Subsequent events have been evaluated through February 14, 2023, which is the date the financial statements were available to be issued.
