Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The HealthAlliance Hospital-Broadway Campus 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits (liquidation basis) as of April 7, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits (liquidation basis) for the period from January 1, 2022 to April 7, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (a qualified institution).

Management has obtained a certification from the qualified institution as of April 7, 2022 and December 31, 2021 and for the period from January 1, 2022 to April 7, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

As discussed in Note 1 to the financial statements, liquidation of the Plan was approved effective December 31, 2021, and the Plan ceased to exist on April 7, 2022. As a result, the Plan has changed its basis of accounting from the ongoing basis to the liquidation basis as of that date. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. 1. Description of Plan

The following description of The HealthAlliance Hospital-Broadway Campus 401(k) Savings Plan (f/k/a The Kingston Hospital 401(k) Savings Plan) (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The HealthAlliance Hospital - Broadway Campus was part of the HealthAlliance of the Hudson Valley, and on March 30, 2016, Westchester County Health Care Corp., through its newly created wholly-owned subsidiary, WMC Health Network - Ulster, Inc. (“WMC Health”), became the sole corporate member of HealthAlliance of the Hudson Valley. WMC Health oversaw operations at HealthAlliance Hospital - Broadway Campus and Mary’s Ave Campus and Margaretville Memorial Hospital and its Affiliate Mountainside Residential Care Center. This transaction did not have a significant impact on the Plan.

The Plan was a defined contribution plan covering substantially all full-time employees of the HealthAlliance Hospital - Broadway Campus (f/k/a The Kingston Hospital) (the “Hospital”) who had one year of service and were 21 years of age or older. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Empower Retirement provided investment advisory and recordkeeping services to the Plan. Great-West Trust Company, LLC was the trustee of the Plan.

Effective December 31, 2021, the Plan was approved for termination. All participants’ became fully vested in their account balances as of December 31, 2021. All active participants became eligible participants of the HealthAlliance 403(b) Plan and these participants had the option to rollover their balance to the HealthAlliance 403(b) Plan. All terminated participants fully vested account balance less notes receivable and accrued interest through April 7, 2022 were distributed their full account balances from the Plan. As of April 7, 2022, the date of the final plan distribution, the Plan ceased to exist. Accordingly the financial statements as of April 7, 2022 and December 31, 2021 and for the period January 1, 2022 to April 7, 2022, are presented on the liquidation basis of accounting.

Eligibility

Employees were eligible to participate in the Plan upon their date of hire.

1. Description of the Plan (continued)

Contributions

Each year, participants could contribute pretax annual compensation, as defined in the plan document, up to the maximum allowed by the Internal Revenue Code ("IRC"). Participants who reached age 50 before the end of the Plan year were eligible to make additional catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan. The Hospital made a matching contribution of 50% of the first 5% of base compensation that a participant contributed to the Plan. Additional profit-sharing amounts could be contributed at the option of the Hospital's Board of Directors. For the period January 1, 2022 to April 7, 2022, there was no contributions made to the Plan as a result of the Plan termination

Participant Accounts

Each participant's account was credited with the participant's contributions and allocations of (a) Hospital's contributions and (b) Plan earnings (losses) thereon. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account. All investments were participant directed.

Vesting

Participants were vested immediately in their contributions plus actual earnings thereon. Effective December 31, 2021, all participants became 100% vested in the employer contribution portion of their Plan accounts as a result of the Plan termination.

Forfeitures

In accordance with the plan document, forfeitures could first be used to pay Plan administrative expenses and then to reduce the Hospital's contributions. At April 7, 2022 and December 31, 2021, forfeited non-vested accounts totaled \$0 and \$28,080. Forfeitures during 2022 resulted from Plan corrections. During 2022, \$4,691 of forfeitures was used to reduce Plan administrative expenses, \$20,069 was used to reduce employer contributions and \$4,341 was reallocated back to participants.

Plan Expense Account

A Plan Expense Account, which was a non-participant-directed account, was established within the Plan whereby Empower credits the account monthly in accordance with the Plan's fee agreement. Funds in the Plan Expense account could be used to pay Plan expenses. The Plan Expense Account balance was \$0 and \$178 at April 7, 2022 and December 31, 2021. During 2022, \$5,253 from the Plan Expense Account was used to pay Plan expenses and \$2,003 was reallocated to participants.

1. Description of the Plan (continued)

Payment of Benefits

Upon termination of service due to death, disability, retirement or separation from service, a participant could elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Withdrawals from the Plan could also be granted based upon circumstances of financial hardship or after attaining age 59 1/2, in accordance with provisions specified in the Plan.

Notes Receivable from Participants

Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The notes were secured by the balance in the participant's account and bore interest at the prime rate in effect at the time of issuance. Outstanding loans with interest rates greater than prime, were issued prior to the Plan being amended and the interest rate was stated in the plan document as a reasonable rate. Principal and interest were repaid via automated clearing house ("ACH") by the participant directly to Empower over a term ranging from one to five years. However, notes used to acquire a principal residence could be paid over a term that exceeds five years.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

As a result of the decision to terminate the Plan effective December 31, 2021, and in accordance with U.S. generally accepted accounting principles ("U.S. GAAP"), the Plan's financial statements are presented using the liquidation basis of accounting. Under the liquidation basis of accounting, assets are stated at their estimated net realizable cash value and liabilities are stated at their anticipated settlement amounts. The preparation of financial statements in conformity with U.S. GAAP requires the Plan sponsor or plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. These estimates are based on information available at the time the estimates are made. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on fair value measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2021, all of the Plan's investments were valued using level 1 inputs. As a result of the distribution of all Plan assets, no investments were held by the Plan at April 7, 2022.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

All of the Plan's investments were stated at fair. Mutual funds were valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that are registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value and to transact at that price.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation in fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits were recorded when paid.

Expenses

Certain expenses for maintaining the Plan were paid by the Hospital and were excluded from these financial statements. Administrative fees for transaction charges were paid by the Plan. Investment related expenses were included in net depreciation in fair value of investments on the statement of changes in net assets available for benefits.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is February 15, 2023.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements (liquidation basis), including investments and notes receivable from participants held at April 7, 2022 and December 31, 2021, and net depreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the period from January 1, 2022 to April 7, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Great-West Trust Company, LLC, a qualified institution.

4. Party-in-Interest Transactions

Participants who were active employees could borrow from their accounts and such loans qualified as exempt party-in-interest transactions under ERISA. These loans were recorded as notes receivable from participants in the statements of net assets available for benefits.

5. Tax Status

The Plan was formed using a prototype plan which the Internal Revenue Service (“IRS”) has determined and informed the applicant by letter dated June 30, 2020 that the prototype plan and related trust are designed in accordance with applicable sections of the IRC. The Plan was terminated after receiving the letter. Plan management believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.
