Basis for Opinion

Our opinion is not modified with respect to this matter.

Notes to Financial Statements

Note 1. Description of the Plan

The following description of the Pioneer Energy Services Corp. 401(k) Plan (the Plan) provides only general information. Participants should refer to the *Plan document* for a more complete description of the Plan's provisions, which is available from Plan management.

General

The Plan is a defined contribution plan that covers all employees of Pioneer Energy Services Corp. and affiliated companies (collectively, the Company) who have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company includes Pioneer Energy Services Corp. and certain wholly owned subsidiaries, including Pioneer Drilling Services, Pioneer Production Services, Pioneer Well Services, Pioneer Wireline Services and Pioneer Coiled Tubing Services. The 401(k) Plan Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

On December 31, 2022, Clearwell Dynamics, LLC (Clearwell) acquired Pioneer Well Service Rig and Pioneer Wireline Services from Patterson-UTI Energy, Inc. Participants had the option to transfer to Clearwell's 401(K) Plan or move their accounts out of the Plan.

Acquisition of Employer and Plan Termination

On October 1, 2021, Patterson- UTI Energy, Inc. ("Patterson") acquired the Company. The Plan and all participants' plan eligibility were terminated on the close of the acquisition, and all impacted participants became fully vested in the Employees' discretionary portion of their account balances. The financial statements have been prepared on a liquidation basis. There are no significant differences between the two basis of accounting due to the nature of the Plan and the fair market value reporting of its investments.

Employees of the Company hired by Patterson were permitted to roll over their account and loan balances to Patterson's retirement plan. Other remaining employees of the Company were terminated and were instructed to withdraw or roll over their account balances. The Plan began liquidating effective October 1, 2021 and all assets of the Plan were distributed to participants prior to April 11, 2022.

Eligibility

All employees are eligible to participate in the Plan on the first of each month following completion of three consecutive months of service. Leased employees are excluded from participation in the Plan.

Contributions

Each year, participants may elect to contribute up to 90% of eligible compensation, as defined in the Plan, on a before-tax or after-tax basis up to the maximum contribution permitted by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant, with an automatic elective deferral increase of 1% each year, not to exceed 10% of eligible compensation, unless the employee makes a different request.

Notes to Financial Statements

The Company may contribute a discretionary matching amount to the Plan. Additional profit sharing amounts may be contributed at the option of the Company's board of directors. As of April 11, 2022 and December 31, 2021, the Company did not make any discretionary matching or profit sharing contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Company matching and profit sharing contributions have a three-year graded vesting period as follows:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance in the previous 12-month period or 50% of their vested account balance. Participants may only have one note outstanding at a time. Note terms range from one to five years, or up to 10 years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest, as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service, permanent disability, death or retirement, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. Any balance under \$1,000 is automatically paid out as soon as administratively possible and is paid directly to the participant in the form of a cash, lump-sum distribution. In the absence of an election by the participant within the time period specified by the Plan Administrator, any balance that exceeds \$1,000, but does not exceed \$5,000, is paid as a direct rollover to an individual retirement account designated by the Plan Administrator. The Plan also allows for in-service distributions upon reaching the age of 59½ or proven financial hardship, as defined. Hardship withdrawals are also available subject to certain limitations.

Forfeited Accounts

At April 11, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$319 and \$0, respectively. Unvested account balances are forfeited upon termination and may be used to reduce employer matching contributions or pay administrative expenses. During 2022 and 2021, the Company contributions were reduced by \$0 and \$140,243, respectively, from forfeited nonvested accounts and \$319 and \$113,523 to pay administrative expenses.

Plan Termination

The Company's Board of Directors has the right under the Plan to discontinue employer contributions at any time and terminate the Plan subject to the provisions of ERISA. This action does not deprive any participant or beneficiary under the Plan of any vested right. By action of the Board of Directors, the Plan was terminated effective April 11, 2022. The management of the Company believes the Plan termination was a tax-exempt transaction under the applicable provisions of the Internal Revenue Code and therefore, is not subject to federal income taxes.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

For the period ended April 11, 2022, the financial statements have been prepared on the liquidation basis of accounting in conformity with GAAP. For the year ended December 31, 2021, the Plan used the accrual basis of accounting in conformity with US GAAP.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (US GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Pioneer Energy Services Corp. 401(k) Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of April 11, 2022 and December 31, 2021.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events

The Plan Administrator has evaluated subsequent events through February 14, 2023, the date the financial statements were available to be issued.

Note 3. Certified Investments

All investment information disclosed in the accompanying financial statements and supplementary information, including investments held and notes receivable from participants at April 11, 2022 and December 31, 2021, and net appreciation (depreciation) in fair value of investments, investment income, and interest income on notes receivable from participants for the period ended April 11, 2022 and year ended December 31, 2021, was obtained or derived from information provided to Plan management and certified as complete and accurate by Fidelity Management Trust Company (FMTC), the trustee of the Plan.

Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 11, 2022 and December 31, 2021.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the trustee reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 5. Related Party Transactions and Party in Interest Transactions

Certain Plan investments are managed by Fidelity Management Trust Company (FMTC). FMTC is the trustee and record keeper as defined by the Plan and, therefore, these transactions qualify as party-in interest transactions. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan.

Note 6. Tax Status

Effective November 1, 2013, the Plan adopted a prototype volume submitter defined contribution profit sharing plan with Internal Revenue Code Section 401(k) Cash or Deferred Arrangement (CODA) which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020. Plan management believes that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of April 11, 2022 and December 31, 2021, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that some changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
