Scope and Nature of the ERISA Section 103(a)(3)(C) Audits of the 2022 and 2021 Financial Statements

We have performed audits of the financial statements of Integrated Laboratory Systems, LLC (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits in liquidation as of April 22, 2022, and the related statements of changes in net assets available for benefits in liquidation for the period from January 1, 2022 through April 22, 2022, and the related notes to the financial statements (2022 financial statements). Management, having determined it is permissible in the circumstances, has elected to have the audits of the 2022 and 2021 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from qualified institutions, as described in Note 1, as of the period ended April 22, 2022 and for the period January 1, 2022 through April 22, 2022 and as of and for the year ended December 31, 2021 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2022 and 2021 Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the 2022 and 2021 Financial Statements section:

- the amounts and disclosures in the accompanying 2022 and 2021 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- the information in the accompanying 2022 and 2021 financial statements related to assets held by and certified to qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2022 and 2021 Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the 2022 and 2021 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audits opinion.

Plan Termination

As discussed in Note 1 to the financial statements, the Plan sponsor elected to terminate the Plan, effective March 15, 2022, and management determined liquidation was imminent at that time. As a result, the Plan changed its basis of accounting from the going concern basis used in the 2021 and 2020 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinions are not modified with respect to this matter.

Responsibilities of Management for the 2022 and 2021 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audits of the 2022 and 2021 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits of the 2022 and 2021 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions,

Note 1. Description of the Plan

The following description of the Integrated Laboratory Systems, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all employees of Integrated Laboratory Systems, LLC (the "Company") who have attained age twenty-one. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The former trustee of the Plan is Branch Banking and Trust Company (the "former trustee") as of December 31, 2020 and for the period from January 1, 2021 through February 28, 2021. Ascensus, LLC, the recordkeeper of the Plan and as agent for Ascensus Trust Company (the "current trustee"), has certified the information as of April 22, 2022 and December 31, 2021 and for the periods from March 1, 2021 through December 31, 2021 and January 1, 2022 through April 22, 2022. Both trustees are considered qualified institutions in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Plan termination:

The Company's management elected to terminate the Plan effective March 15, 2022. Contributions to the plan were no longer allowed after February 4, 2022. All active participants became 100 percent vested March 15, 2022. Participants were given the option to roll their balances into a third party's plan of their choice, or receive a distribution under the terms of the Plan. All remaining assets were distributed out of the plan on April 22, 2022.

Contributions:

Each year, participants may contribute any portion of eligible compensation, as defined in the Plan. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company in its discretion may determine the amount of a discretionary matching contribution and the matching contribution formula. During the period January 1, 2022 through April 22, 2022 and for the year ended December 31, 2021, the Company contributed 50 percent of the first 6 percent of eligible compensation that a participant contributed to the Plan. Additional profit sharing amounts may be contributed at the option of the Company's board of directors. There was no discretionary profit sharing contribution for the period January 1, 2022 through April 22, 2022 or for year ended December 31, 2021. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Company and employee contributions stopped on February 4, 2022 as a result of the plan termination described above.

Participant accounts:

Each participant's account is credited with the participant's contributions, Company contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after 5 years of credited service. As a result of the decision to terminate, all participants became 100 percent vested in their account balances effective March 15, 2022.

Payment of benefits:

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or other installment options as provided by the Plan. Hardship distributions are permitted upon demonstration of financial hardship. All fully vested balances are available for distribution after the participant reaches the age of 59½.

Forfeited accounts:

At December 31, 2021 and 2020, forfeited nonvested accounts totaled \$0 and \$12,277 respectively. These accounts will be used to reduce future employer contributions. Also in 2021, employer contributions were reduced by \$11,216 from forfeited nonvested accounts. No forfeitures were used to reduce employer contributions or to pay expenses related to plan termination during 2022.

Note 2. Summary of Significant Accounting Policies

Basis of accounting:

Due to the decision to terminate the Plan during 2022, management determined the liquidation of the Plan is imminent and the 2022 financial statements have been prepared using the liquidation basis of accounting. The 2021 and 2020 financial statements were prepared as a going concern on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

There are no investments remaining at April 22, 2022 due to the Plan termination discussed in Note 1.

Investments in the 2021 and 2020 Statements of Net Assets Available for Benefits are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Note 2. Summary of Significant Accounting Policies, Continued

Investment valuation and income recognition, continued:

During 2022, purchases and sales of securities are recorded on a settlement-date basis. Interest income and dividends are recorded on the liquidation basis, including amounts expected to be earned through the final distribution of Plan assets. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during 2022.

During 2021, purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during 2021.

Excess contributions payable:

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions

Payment of benefits:

Benefits are recorded when paid. Distributions pursuant to the Plan termination were paid at the participants' election by (a) rollover distribution to an eligible retirement plan (b) cash distribution (c) a combination of cash distribution and rollover distribution to an eligible retirement plan.

Expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/(depreciation) in fair value of investments.

Subsequent events:

The Plan has evaluated subsequent events through February 15, 2023, the date the financial statements were available to be issued.

Recently issued accounting pronouncements:

Accounting standards that have been issued or proposed by the FASB or other standards-setting bodies are not expected to have a material impact on the Plan's financial statements.

Note 3. Trustee Certifications

The following is a summary of the Plan's asset information as of April 22, 2022, December 31, 2021 and 2020, and for the period January 1, 2022 to April 22, 2022 and for the year ended December 31, 2021, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by the former trustee and the recordkeeper of the Plan, as agent for the current trustee and furnished to the plan administrator. The plan administrator has obtained certifications from the former trustee and the recordkeeper of the Plan, as agent for the current trustee that the information provided to the plan administrator by the former trustee and the recordkeeper of the Plan, as agent for the current trustee related to the following assets is complete and accurate. Accordingly as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following assets:

The former trustee and the record keeper of the Plan, as agent for the current trustee also certified to the completeness and accuracy of \$1,463,769 of depreciation in fair value of investments and \$21,230 of interest and dividends for the period January 1, 2022 to April 22, 2022. The former trustee and the record keeper of the Plan, as agent for the current trustee also certified to the completeness and accuracy of \$1,924,984 of appreciation in the fair value of investments and \$187,581 of interest and dividends for the year ended December 31, 2021.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021 and 2020. The Plan held no investments as of April 22, 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5. Related-Party and Party in Interest Transactions

As described in Note 2, the Plan made direct payments to the third party administrator totaling \$31,734 for the period from January 1, 2022 to April 22, 2022, and \$39,966 for the year ending December 31, 2021 which were not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

Note 6. Tax Status

Effective March 1, 2021 the Plan adopted a non-standardized pre-approved plan sponsored by Ascensus LLC, the plan provider. The plan provider has received an opinion letter from the Internal Revenue Service as to the pre-approved plan's qualified status. The pre-approved plan's letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
