We have performed an audit of the financial statements of ZipWhip Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of April 1, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the period from January 1, 2022 to April 1, 2022 and the year ended December 31, 2021, and the related notes to the financial statements.

Notes to Financial Statements

Period ended April 1, 2022 and Year Ended December 31, 2021

1. Description of Plan

The following description of the ZipWhip Inc. 401(k) Plan (the "Plan") provides general information only. Participants should refer to the summary plan description and plan document for more complete information.

General

The Plan is a defined contribution plan originally effective September 1, 2016 and most recently restated effective October 22, 2021. The Plan covered all employees of ZipWhip, Inc. (the "Company") and excluded leased employees, nonresident aliens and employees covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective July 14, 2021, the Company was acquired by Twilio, Inc. and effective January 1, 2022 participants became eligible to participate in the successor's plan. As of April 1, 2022, all participants balances have been merged into the successor's plan.

CARES Act

On March 27, 2020, the "Coronavirus Aid, Relief, and Economic Security ("CARES") Act" was signed into law. The CARES Act includes several relief provisions available to the Plan and its participants. Plan management evaluated the relief provisions available to Plan participants under the CARES Act and retroactively amended the plan for the following provisions:

- Special coronavirus distributions up to \$100,000 for the period from January 1, 2020 to December 31, 2020, and extended repayment options.
- Special coronavirus loans which allowed for higher loan limits, the lesser of \$1000,000 or 100% of a participant's vested balance.
- Extended the period for loan repayments up to one year.

Eligibility

Employees of the Company were eligible to participate in the deferral and safe harbor match contributions of the Plan after completing 30 days of service. An employee who satisfied the eligibility requirements could commence participation on the next entry date, which was the first day of the following month.

Contributions

Each year, participants were allowed to contribute up to the maximum amount permitted by the Internal Revenue Code ("IRC") of pre-tax or Roth annual compensation, as defined in the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants were also allowed to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Effective January 1, 2021, the Plan was restated to be a safe harbor 401(k) Plan and allowed safe harbor matching contributions at 100% of salary deferrals up to the first 1% of Plan compensation, plus 50% of salary deferrals up to the next 5% of Plan compensation. Employer safe harbor contributions for the year ended December 31, 2021 totaled \$1,394,037. There were no employer safe harbor contributions for the period from January 1, 2022 to April 1, 2022.

Participants were allowed to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participant directed the investments of contributions into various investment options offered by the Plan. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Vesting

Participants were immediately vested in their contributions, plus actual earnings thereon. The Company's safe harbor matching contributions plus actual earnings thereon were subject to a two-year cliff vesting schedule, until 100% vested after two years. Notwithstanding the above, a participant was fully vested upon reaching normal retirement age, death, or permanent disability.

Participant Accounts

Investments in the Plan were participant directed. Each participant's account was credited with their participant contributions and safe harbor matching contributions, as well as allocations of Plan earnings or losses. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled was the benefit that could be provided from the participant's vested account.

Notes Receivable from Participants

Participants were permitted to borrow from their fund accounts a minimum of \$5,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vest account balance. The loans were secured by the balance in the participant's account. The loans had stated interest rates commensurate with local prevailing rates as determined by the plan administrator. Principal and interest were repaid through payroll deductions and monitored by the plan administrator. As of December 31, 2021, the interest rates on the outstanding note receivable ranged from 4.25% to 5.75%. At April 1, 2022, there were no outstanding notes receivable.

Benefits Paid to Participants

Upon termination, death, disability or retirement, a participant could have elected to receive a lump-sum distribution or installment payments over a specified period of time, subject to certain limitations, equal to the value of the participant's vested interest in their account.

Forfeitures

Forfeitures were created when a participant terminates his or her employment prior to attainment of full vesting. Such amounts could have been used by the trustees to pay for the Plan's administrative expenses or to reduce future safe harbor match contributions, as defined in the Plan document. During the year ended December 31, 2021, approximately \$37,192 of forfeiture account were used to pay for a portion of employer matching contributions and approximately \$15,075 was added to the forfeiture account. During the period from January 1, 2022 to April 1, 2022, approximately \$3,560 was added to the forfeiture account. The forfeiture account balance was approximately \$444 and \$0 as of December 31, 2021 and April 1, 2022, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2021 and April 1, 2022. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Certain expenses incurred maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investments related expenses are included in net appreciation of fair value of investments.

3. Investment Information Certified by the Plan Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock, Life Insurance Company (U.S.A.) ("John Hancock"), the custodian and insurance company of the Plan, has certified the following information as complete and accurate:

- Investments at fair value, contract value and notes receivable from participants included in the statements of net assets available for benefits as of April 1, 2022 and December 31, 2021.
- Investment activity and interest on notes receivable from participants included in the statements of changes in net assets available for benefits for the period from January 1, 2022 to April 1, 2022 and for the year ended December 31, 2021.

4. Fair Value Measurements

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021:

- *Pooled Separate Accounts:* Valued at the net asset value (NAV) of units as determined by John Hancock Life Insurance Company. The NAV is based on the market value of securities underlying the pooled separate accounts, and is a readily determinable fair value and is the basis for current transactions. The pooled separate accounts are not traded on a public exchange. Participants may transfer all or a portion of their account value among the Plan's pooled separate accounts. Participants eligible to receive benefit payments may withdraw the value of their pooled separate accounts, in whole or in part, at any time without penalty. Participant transactions may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Group Annuity Contract with Insurance Company

In 2016, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with John Hancock Life Insurance Company (U.S.A.) (John Hancock). John Hancock maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the Plan by John Hancock, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

6. Related Party Transactions

Certain Plan investments are managed by the Plan's custodian and, therefore, transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Other fees and expenses, such as investment fees and certain plan administrative expenses, maybe deducted directly from investment returns in accordance with the applicable investment option selected by the participants.

7. Plan Termination

The Company reserves the right to amend, alter or terminate the Plan subject to the provisions of ERISA. The plan was terminated as of April 1, 2022 and all participant balances were transferred into the Twilio 401(k) Plan. All participants were fully vested in their individual accounts as of April 1, 2022.

8. Tax Status

The Plan is placing reliance on an opinion letter dated June 30, 2020 received from the IRS on the prototype plan indicating that the Plan is qualified under Section 401 of the IRC and is therefore not subject to tax under current income tax law. The prototype plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2018.

9. Risks and Uncertainties

The Plan's invests in various investment securities. Such securities are subject to various risks that affect the value of the funds. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of these securities it is at least reasonably possible that the changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.

10. Subsequent Events

The Plan has evaluated subsequent events through February 14, 2023, the date the financial statements were available for issuance.

11. Excess Employer Contribution Payable

For the year ended December 31, 2021 an excess employer contribution payable of \$77,666 was recorded as a liability in the accompanying statements of net assets available for benefits, of which \$77,666 was recorded as a reduction of employer contributions in the statements of changes in net assets available for benefit, in order to satisfy ERISA testing requirements.

12. ERISA Fidelity Bond

ERISA requires that fiduciaries of an employee benefit plan and persons who handle funds or other property of a plan must be bonded. The amount of the fidelity bond for the Plan was \$300,000 for the year ended December 31, and during the period from January 1, 2022 to April 1, 2022 which was lesser than 10 percent of the Plan's asset measured at the beginning of the Plan year or \$500,000.
