Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2021 Financial Statements:

NOTE 1 – PLAN DESCRIPTION

The following description of the MICHAEL E JONES MD PC 401(K) Profit Sharing Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan for the benefit of the employees of MICHAEL E JONES MD PC (the “Company”). The Plan became effective January 1, 2016. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Although the plan meets the eligibility criteria for an audit as of December 31, 2021, the plan has yet to receive any contributions from employees or the employer and has yet to earn any investment income, incur any administrative expenses or invest any funds into any investment vehicle.

Plan Termination

Although it has been expressed that there is no intention to do so, the Company retains the right to terminate the plan. In the event of Plan termination, all amounts credited to participants’ accounts become fully vested subject to the requirements of ERISA. The Company also retains the right to amend the plan.

Eligibility

An employee is eligible to participate in the Plan upon completing one month of service following the date of hire. A year of service is defined as 1,000 hours of service during plan year.

Contributions and Allocations

Participants may contribute a portion of their salary or wages through payroll deduction contributions. Each participant is permitted to defer up to 100% of his or her compensation. Each participant’s contribution was limited by the Internal Revenue Service (IRS) to a maximum of \$19,500 during 2021. In addition, participants older than 50 may make a catch-up contribution of up to \$6,500. Participants’ contributions to the Plan are invested as directed by the participants.

NOTE 1 – PLAN DESCRIPTION (continued)

At the consent of the Company, the Plan will allow employees to rollover amounts into the Plan from other qualified plans. The rollover contribution is permitted provided the trust from which the funds are to be transferred permits the transfer to be made.

Benefits and Vesting

Participants will be immediately vested in their contributions and actual investment earnings and losses thereon. Participants will vest in the company's matching contributions over a 6-year vesting schedule as per the plan document.

Participants or their beneficiaries will be eligible to receive distributions of their vested account balances upon retirement or other termination of employment. Distributions of benefits while the participant is still employed will be permitted for rollovers of the account balances, after- tax distributions, financial hardship, as defined, or upon the attainment of age 59 ½. Participants or their beneficiaries may elect to receive a lump sum payment or minimum required payments.

Investment Management Fees and Operating Expenses

Investment management fees and operating expenses will be charged to the Plan for investments in the various funds and deducted from income earned on a daily basis and are reflected as a component of net appreciation in fair value of investments.

Notes/Loans Receivable from Participants

Participants will be allowed to borrow against their individual vested accounts. Loan amounts are limited to 50% of a participant's vested balance to a maximum of \$50,000, with an interest rate that approximates the current market rates. Had the plan had any outstanding loans at December 31, 2021, the interest rates on outstanding loans would have ranged from 3.5% to 4%. The financial risk and all associated costs with non-performing loans is borne by the individual loan holder.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are significant accounting policies followed by the Plan:

Basis of Accounting - The Plan uses the accrual basis of accounting for transactions in accordance with accounting principles generally accepted in the United States of America. Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. Purchase and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Benefits are recorded when paid. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable/Loans from Participants - Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent loans are treated as distributions based on the terms of the Plan document.

Risks and Uncertainties - The Plan provides for various investment options in money market and mutual funds. These investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent Events - The Plan has evaluated subsequent events through our report date of September 7, 2022, the date the financial statements were available to be issued

NOTE 3 – INVESTMENTS

The Company has entered into an agreement whereby, Paychex Securities Corp ("Custodian") has been appointed the Custodian of the Plan's assets. Under the terms of the agreement, the Custodian holds and invests the funds of the Plan assets. Under the terms of the agreement, the Custodian holds and invests the funds of the Plan subject to

the direction of a designated investment committee. The Company is the Plan's administrator. All investments will be carried at fair value.

NOTE 4 – FAIR VALUE MEASUREMENTS

The Plan defines fair value as an exit price, representing the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. As such, fair value is a market-based measurement that should be determined based on assumptions that market participants would use in pricing an asset or liability. As a basis for considering such assumptions, accounting standards codification establishes a three-level fair value hierarchy that prioritizes the inputs used to measure fair value. The three levels of inputs used to measure fair value are as follows:

Level 1 – Quoted prices in active markets for identical assets or liabilities

Level 2 – Observable inputs other than quoted prices included in Level 1, such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Unobservable inputs that are supported by little or no market activity and are significant to the fair value of the assets or liabilities. This includes certain pricing models, discounted flow methodologies and similar techniques that use significant unobservable inputs.

All investments in the plan are expected to be in mutual funds and money market accounts. The fair values for mutual funds and money market accounts will be based on quoted prices in active markets and are therefore classified within Level 1 of the fair value hierarchy.

NOTE 5 – Information Certified by Custodian

NOTE 6 –TAX STATUS

The trust established under the Plan to hold the Plan’s assets is qualified pursuant to applicable sections of the internal revenue Code, and accordingly, net investment income is exempt from income taxes. The Company has obtained a favorable tax determination letter during 2016 from the IRS and believes that the Plan continues to qualify and to operate as designed.

Plan management has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7- ADMINISTRATIVE EXPENSES

Non-vested contributions will be forfeited by employees due to termination of employment prior to achieving vested status may be used to reduce employer contributions or pay plan expenses. There were no forfeitures for the year ended December 31, 2021.

NOTE 9 - RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds collective trusts managed by the trustees and, therefore, these transactions qualify as party-in-interest transactions.
