We have performed audits of the accompanying financial statements of Sierra Nevada Memorial Hospital 403(B) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of April 6, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for period January 1, 2022 to April 6, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of April 6, 2022 and December 31, 2021, and for the period January 1, 2022 to April 6, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Note 1 to the financial statements, the Plan was merged into the CommonSpirit Health ERISA 403(b) Plan (the CommonSpirit Plan) effective April 6, 2022. As a result of the merger, total plan assets of \$103,015,313 were transferred from the Plan into the CommonSpirit Plan on that date.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - PLAN DESCRIPTION

Plan Merger

The Sierra Nevada Memorial Hospital 403(B) Savings Plan (the Plan) was merged into the CommonSpirit Health ERISA 403(b) Plan (the CommonSpirit Plan) effective April 6, 2022. The CommonSpirit Plan is sponsored by CommonSpirit Health, which is an entity related to Sierra Nevada Memorial-Miners Hospitals, Inc., the Plan's sponsor, through common ownership. As a result, plan assets totaling to \$103,015,313 were transferred from the Plan into the CommonSpirit Plan on April 6, 2022. Plan participation, participant balances, contribution rates, and investment elections were transferred into the merged plan without initiating any blackout or quiet period.

General

Sierra Nevada Memorial-Miners Hospitals, Inc. (the Sponsor) established the Plan effective September 15, 1989. The Plan was a 403(b) tax deferred plan covering employees of certain Sponsor-affiliated entities. The Plan was intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and similar state tax laws and was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration

The Sponsor was the plan administrator and was responsible for day-to-day operations of the Plan. Lincoln National Life Insurance Company (Lincoln) was the custodian and recordkeeper of the Plan's Multi-Fund platform of investments (the MF Platform). Fidelity Management Trust Company (Fidelity) was the custodian and recordkeeper of the Plan's Alliance platform of investments (the Alliance Platform). Lincoln and Fidelity invested cash received, interest, and dividend income, and made distributions to participants. Lincoln and Fidelity also administered the payments of interest and principal on the notes receivable from participants.

Eligibility and Contributions

All employees who were not eligible for other retirement plans sponsored by the Sponsor and who were employed by the Sponsor were eligible to participate in the Plan upon their hire date. In order to be eligible to receive employer matching contributions, employees must have been in a benefited position, have completed two years of service and have reached 18 years of age.

Eligibility and Contributions – Continued

Employees were able to enroll into the Plan on the first day of the payroll period, provided they agreed to defer at least \$200 annually. Participants may have elected to defer different amounts, subject to certain limitations under the IRC, by completing an elective deferral agreement. Plan participants over age 50 may have deferred additional catch-up contributions, subject to the IRC limitations. Participants may have also contributed amounts representing distributions from other qualified plans.

The Sponsor made matching contributions to eligible employees at 100% of elective deferrals subject to limits applied per payroll period.

Sponsor matching contribution limits were based on the number of years each employee has participated in the Plan as described in the following table:

Vesting

Participants were 100% vested in their salary deferral contributions, rollover contributions, and employer contributions, plus actual earnings thereon.

Investment Options

Participants directed the investment of their contributions into various investment options offered by the Plan and may have changed their investment elections at any time directly through Lincoln and Fidelity. The Plan offered a combination of fixed and variable investment options held with Lincoln and Fidelity.

On October 1, 2015, the investment options for which participants may direct their contributions changed from the MF Platform to the Alliance platform. Participants may have kept funds currently invested in the MF Platform, but contributions and transfers subsequent to October 1, 2015 may have only been directed to the Alliance Platform.

Investment Options – Continued

Under the Alliance Platform, the variable investment options were made available through mutual funds registered with the Securities and Exchange Commission (SEC). Under the MF Platform, variable investment options were made available through Lincoln's separate accounts with underlying investments in mutual funds registered with the SEC.

Fixed investment options under both platforms were guaranteed against loss of principal, less withdrawals, charges, and adjustments. These accounts were invested in accordance with applicable state regulations and guaranteed to earn at least a minimum rate of interest, as provided in the respective contracts. The interest was credited daily and declared on a quarterly basis.

Participant Accounts

Individual accounts were maintained for each Plan participant. Each participant's account was credited with the participant's contributions (including those rolled over from another qualifying plan) and allocations of Sponsor matching contributions, if any, and Plan earnings, and charged with withdrawals, allocations of Plan losses, and administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Forfeitures

The Plan had no forfeitures because all accounts were 100% vested at all times.

Payment of Benefits

On retirement, death, disability, or termination of service, a participant (or participant's beneficiary in the event of death) may have received a lump-sum distribution or annuity payments of the participant's vested account balance. As of April 06, 2022 and December 31, 2021, there were no benefits payable to participants that have elected to withdraw from the Plan but have not yet been paid.

Notes Receivable from Participants

Participants were permitted to borrow from their fund accounts as defined by the Plan agreement, subject to certain limitations. Generally, notes receivable were repaid on an installment basis over a period not to exceed five years, except in the case where the loan was used to acquire a principal residence. All notes receivable were adequately secured by the participant's account balance and bore interest as defined by the Plan agreement.

Administrative and Investment Management Expenses

Loan origination fees associated with notes receivable from participants and the Plan's recordkeeping and trustee/custodian fees were paid by the Plan and were reflected in the financial statements as administrative expenses. Investment management fees were charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan. All other expenses of the Plan were paid by the Sponsor.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis in conformity with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP required the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements, and the reported amounts of additions and deductions during the reporting period. The most important of these estimates and assumptions relate to fair value measurements of the Plan's investments. These and other estimates and assumptions were based on the best available information but actual results could have been materially different from those estimates.

Risks and Uncertainties

The Plan utilized various investment instruments. Investment securities, in general, were exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it was reasonably possible that changes in the values of investment securities would have occurred in the near term, and that such changes could have materially affected the amounts reported in the statements of net assets available for benefits.

Valuation of Investments

All assets of the Plan were stated at fair value with the exception of fully benefit-responsive investment contracts. Fully benefit-responsive investment contracts were reported at contract value because contract value was the amount participants would have received if they initiated permitted transactions under the terms of the Plan. Contract value represented contributions made under the contract, plus earnings, less plan withdrawals and administrative expenses.

Valuation of Investments – Continued

Plan assets invested in mutual funds were stated at aggregate fair value based upon quoted market prices.

Plan assets invested in separate accounts were valued by Lincoln at fair value, which was determined based on the fair value of the underlying mutual funds. Separate accounts have the characteristics of a structure similar to a mutual fund; therefore, as clarified by Financial Accounting Standards Board (FASB) Accounting Standards Update (ASU) 2015-10, *Technical Corrections and Improvements*, its value was considered readily determinable as each account published a daily price at the end of each day. As such, the investments in separate accounts were classified in Level 2 of the fair value hierarchy.

Investment Contract with Insurance Company – the MF Platform

Under the MF platform, the Plan had entered into a fully benefit-responsive investment contract with Lincoln through the Fixed Account, which was part of Lincoln's General Account and was reported at contract value. The Fixed Account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The terms of the investment contract required all permitted participant-initiated transactions with the Plan to occur at contract value with no conditions, limits, or restrictions.

The investment contract issuer guaranteed the principal and a minimum rate of return. There were no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate was based on a formula agreed upon with the issuer and was reviewed from time to time, as determined by the contract.

Certain events, such as market value adjustment and surrender charges, could have limited the ability of the Plan to transact at contract value.

Stable Value Fund – the Alliance Platform

Under the Alliance platform, the Plan had entered into a fully benefit-responsive investment contract with Lincoln through the Stable Value Fund. Lincoln maintained the contributions in its general account. The contract guaranteed a minimum crediting interest rate of 1.00% for all years. The interest crediting rate was updated quarterly based upon contract provisions. Lincoln's general account was credited with earnings on the underlying investments and was charged for participant withdrawals and administrative expenses. Participants may have ordinarily directed the withdrawal or transfer of all or a portion of their account balances at contract value. Thus, the investment contract was considered fully benefit-responsive, as defined by GAAP.

Stable Value Fund – the Alliance Platform – Continued

The contract specified certain conditions under which distributions from the contract would have been payable at amounts below contract value. Such circumstances included termination of the contract by the Sponsor, as well as circumstances under which the issuer may have terminated the contract. Examples of circumstances which would have allowed the issuer to terminate the contract included the balance of the contract falling below minimum specified levels, lack of deposit activity into the contract, the Plan's loss of its qualified status, uncured material breaches of responsibilities, the issuer discontinuing offering this contract to the public, Sponsor termination of the recordkeeping agreement or material and adverse changes to the provisions of the Plan. If one of these events occurred, the Sponsor could have requested the market value payment option, which could have resulted in payments to the participants at less than contract value.

Fixed-Interest Option – the Alliance Platform

The Plan entered into an investment contract with The Variable Annuity Life Insurance Company (VALIC), now known as AIG Retirement Services, through its Fixed-Interest Option (the Fund), which was a fully benefit responsive investment contract and was reported at contract value. The Fund was a group annuity contract managed by VALIC that invested in the general account assets of VALIC and offered guaranteed crediting rates specified in advance of participant investments. The VALIC general account invested in a diversified portfolio of bonds, mortgages, cash and short-term investments, equity-related investments, and policy loans. Unit price, yield, and return varied.

The Fund was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses as allowed by the Plan. Participants may have ordinarily directed the withdrawal or transfer of all or a portion of their investment at contract value. There were no reserves against contract value for credit risk of the contract issuer or otherwise.

Recognition of Income

Sales and purchases were accounted for on a trade date basis, and interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date.

Net Change in Fair Value of Investments

Net change in fair value of investments includes realized and unrealized gains and losses on investments bought and sold or held during the year.

Notes Receivable from Participants

Notes receivable from participants were reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants was recorded when earned.

Payment of Benefits

Benefit payments to participants were recorded when paid.

NOTE 3 - TAX STATUS

403(b) plans currently are not required to submit plans to the Internal Revenue Service (IRS) for determination. However, the Plan was required to operate in accordance with the IRC to maintain its tax-exempt qualification. The plan administrator believes that the Plan was designed and operated in accordance with applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

In accordance with GAAP, the Plan management is required to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of April 6, 2022, there are no uncertain positions taken or expected to be taken. As a result, the Plan has recognized no interest or penalties related to uncertain tax positions.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

NOTE 4 - INFORMATION CERTIFIED BY THE PLAN'S CUSTODIANS

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodians of the Plan have certified to the completeness and accuracy of investments (see table below) reflected in the accompanying statements of net assets available for benefits as of April 6, 2022 and December 31, 2021, and the related investment activity reflected in the accompanying statement of changes in net assets available for benefits for the period January 1, 2022 to April 6, 2022.

NOTE 5 - FAIR VALUE MEASUREMENTS

Fair value is defined as the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date (an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value into three levels, with the highest priority given to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority given to unobservable inputs (Level 3). The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require transfer of financial instruments from one level to another. In such instances, the transfer is reported at the end of the reporting period.

During the period January 1, 2022 to April 6, 2022, the Plan’s investments measured at fair value (including dividends, and gains and losses on investments bought and sold, as well as held during the year) depreciated in value by \$3,916,041.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were managed by Lincoln and Fidelity, the custodians, as defined by the Plan document. Therefore, these transactions qualified as party-in-interest. However, these party-in-interest transactions were exempt pursuant to ERISA regulations.
