Basis for Disclaimer of Opinion

We have been informed by the plan administrator that Reliance Trust Company and Massachusetts Mutual Life Insurance Company hold the Plan's investment assets and execute investment transactions. The plan administrator has obtained certifications from Reliance Trust Company and Massachusetts Mutual Life Insurance Company as of December 31, 2018 and 2017 and for the year ended December 31, 2018 that the information provided to the plan administrator by Reliance Trust Company and Massachusetts Mutual Life Insurance Company is complete and accurate.

Disclaimer of Opinion

Because of the significance of the matter described in the Basis for Disclaimer of Opinion paragraph, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion. Accordingly, we do not express an opinion on these financial statements.

Emphasis of Matter

As described in Note 3 to the financial statements, the Plan sponsor elected during 2015 to terminate the Plan. As a result, the Plan administrator determined that liquidation is imminent, and the Plan's 2017 and 2018 financial statements are prepared on a liquidation basis. Our opinion is not modified with respect to this matter.

Other Matter

The supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2018 is required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 and is presented for purposes of additional analysis and is not a required part of the financial statements. Because of the significance of the matter described in the Basis for Disclaimer of Opinion paragraph, we do not express an opinion on the supplemental schedule.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Pennock Hospital 401(a) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. As further described in Notes 2 and 3, the Plan was terminated effective December 31, 2015.

General and Eligibility: The Plan, established January 1, 1990 and most recently restated January 1, 2010, is a money purchase pension plan providing tax-deferred benefits for substantially all employees of Pennock Hospital (the "employer" and "Plan Sponsor") who have completed one year of service and at least 1,000 hours of service and are at least 18 years old. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The minimum funding requirements have been met.

Contributions: Prior to December 31, 2015, the Plan sponsor contributed a specific percentage of eligible employees' wages to their accounts, subject to a maximum percentage of compensation. The hospital provided a 2% base contribution of employees' eligible earnings for employees with one to four years of service, 3% for employees with five to nine years of service, 4% for employees with ten to fourteen years of service, and 5% for employees with 15 or more years of service. No employee contributions are allowed.

Participant Accounts: Individual accounts are maintained for each plan participant. Each participant's account is credited with the employer contributions and earnings thereon and charged with an allocation of plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the vested participant's account.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: All employees became fully vested at December 31, 2015.

Payment of Benefits: Participants may withdraw funds from their accounts upon the occurrence of one of the following: death, normal retirement, termination of employment, or disability. A variety of different benefit options are available to each participant, such as receiving a lump sum amount equal to the value of his or her account or a variety of annuity options as defined by the Plan document.

Forfeitures: The non-vested portion of the discretionary Plan sponsor profit-sharing contribution of terminated participants is used to offset administrative fees and future employer contributions. During 2018, there were no forfeitures used to offset administrative expenses.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. The notes are repaid ratably through weekly payroll deductions over a period of five years or less, unless used to acquire a principal residence, in which the repayment period may exceed five years.

Administrative and Investment Management Expenses: Loan origination fees associated with notes receivable from participants and the Plan's record keeping and custodial fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan. All other expenses of the Plan are paid by the Plan sponsor.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: Effective December 31, 2015, the Plan Sponsor elected to terminate the Plan and determined that liquidation was imminent. The financial statements as of December 31, 2018 and 2017 and for the year ended December 31, 2018 have been prepared under the liquidation basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts for assets and liabilities, revenues, and expenses, as well as the disclosures provided. Future results could differ from the current estimates.

Risks and Uncertainties: The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rate, credit, liquidity and overall market volatility. Due to the level of risk associated with certain investments, it is reasonably possible that changes in their values could occur in the near term and such changes could materially affect participant's account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 5. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payment of Benefits: Benefits are recorded when paid.

NOTE 3 – PLAN TERMINATION

On December 23, 2015, Plan management consented to freeze and terminate the plan effective December 31, 2015 ("Effective Date"), due to the merger of the Plan Sponsor with Spectrum Health. No further contributions are permitted under the Plan with respect to Plan Compensation earned on or after the above Effective Date. The participants' accounts are fully vested at the Effective Date and are held under the Plan on their behalf.

NOTE 3 – PLAN TERMINATION (Continued)

Plan management filed for a termination determination letter with the IRS and received a favorable opinion on October 12, 2017. The plan assets were distributed during 2019. The Plan did not have any liabilities to be settled at the date of liquidation. Interest income and accrued expenses through the date of liquidation were immaterial.

**NOTE 4 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS –
UNAUDITED INFORMATION**

Substantially all information pertaining to the Plan's investments and notes receivable from participants included in the financial statements, including the associated investment income and interest earned on notes receivable from participants, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company and Massachusetts Mutual Life Insurance Company. This information has not been audited by independent accountants.

NOTE 5 – FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. The effect of a change in valuation technique or its application on a fair value estimate is accounted for prospectively as a change in accounting estimate. When evaluating indications of fair value resulting from the use of multiple valuation techniques, the Plan is to select the point within the resulting range of reasonable estimates of fair value that is most representative of fair value under current market conditions. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Traditional Guaranteed Investment Contract: The Plan holds a traditional guaranteed investment contract that is not fully benefit-responsive and, accordingly, it is measured at fair value. The fair value of the contract has been determined to approximate contract value, based upon its lack of contractual maturities, the frequency of the re-setting of contractual interest rates to market rates, participant transactions typically being executed at contract value, and the credit quality of the issuer (Level 3 inputs). Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 – INCOME TAX STATUS

The Plan obtained its latest determination letter dated October 12, 2017, in which the Internal Revenue Service stated the termination does not affect the qualification of the plan. No provision for income taxes has been included in the Plan's financial statements.

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor ("DOL") regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. Professional fees for the administration, legal services and audit of the Plan were paid by the Plan sponsor. Investment management fees are paid for by the Plan to investment managers who qualify as parties-in-interest. These investment management fees are reflected in the financial statements as a reduction of the return on the Plan's investments. Certain mutual fund investments totaling \$0 and \$2,056,750 at December 31, 2018 and 2017, respectively, are managed by MassMutual or OppenheimerFunds, who are affiliates of the Plan service provider, and therefore, these transactions qualify as party-in-interest transactions. The investment contract totaling \$25,705 and \$828,031 at December 31, 2018 and 2017, respectively, was issued by Massachusetts Mutual Life Insurance Company, the service provider of the Plan, and therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions. Notes receivable from participants as of December 31, 2018 and 2017 were \$0 and \$60,108, respectively.
