Opinion

Notes to Financial Statements

1. Description of Plan

The following description of the Storage Solutions Profit Sharing Plan (the Plan) (formerly the Storage Solutions ESOP [the ESOP]) is provided for general information purposes only. Participants should refer to the Plan agreement or the Summary Plan Description for a more complete description of the Plan's provisions.

Plan Termination

On November 20, 2020, the ESOP sold 100% of its common stock to an unrelated party for cash consideration of \$29,833,182 (the Transaction). In conjunction with the sale, the Board of Directors of the Plan Sponsor and the Committee of the ESOP authorized an amendment to the ESOP, which effectively terminated the ESOP. As of the effective date of the termination, participants became 100% vested in plan benefits. Liquidation of assets through distribution to participants with vested balances began in 2021 and was completed in 2022. Prior to Plan termination, the Plan was an Employee Stock Ownership Plan and from and after the consummation of the Transaction, became a tax-qualified profit-sharing plan within the meaning of Internal Revenue Code (IRC) Section 401(a). All distributions from and after the consummation of the Transaction, whether in respect of a distribution event occurring prior to or after the Transaction, were in cash, and participants had no right to demand payment in Company stock.

General

SSI Holdings, Inc. (the Company) established the Plan effective June 1, 2013. Until November 20, 2020, the Plan operated as a leveraged employee stock ownership plan and was designed to comply with IRC Section 4975(e)(7) and the regulations thereunder of the IRC and was subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The ESOP was administered by an ESOP Committee (the Committee), comprising two individuals appointed by the Company's board of directors. The Plan's trustee was an independent bank.

The Plan's assets were held by the trustee of the Plan.

Eligibility

Employees of the Company were eligible to participate in the Plan upon attaining the age of 21 and completing one year of service, provided they worked at least 1,000 hours during the consecutive twelve-month period from their hire date. Participants who did not have at least 1,000 hours of service during such a plan year or who were not employed on the last working day of a plan year were generally not eligible for an allocation of Company contributions for such a year. Employees entered the Plan on January 1 or July 1, upon meeting the Plan's eligibility requirements.

Effective as of the ESOP termination date, employees who were not participants in the ESOP as of the ESOP termination date were excluded from participating in the Plan.

Participant Accounts

Plan earnings and losses and Plan expenses were allocated to each participant's account based on the ratio of the participant's ending account balance to all participants' ending account balances at the ESOP termination date.

Vesting

Participants with an account balance as of the ESOP termination date were 100% vested in such account, regardless of years of service.

Payment of Benefits

Payments were recorded when paid.

Administrative Expense

As provided by the Plan agreement, administrative expenses may be paid by the Plan or by the Company. Certain administrative functions are performed by employees of the Company. No such employees received compensation from the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared under the liquidation basis of accounting for the net assets available for benefits as of July 31, 2022, and December 31, 2021, and the period January 1, 2022, to July 31, 2022, and the year ended December 31, 2021, in conformity with accounting principles generally accepted in the United States of America. The liquidation basis of accounting presents the Plan's statement of net assets available for benefits and the Plan's statement of changes in net assets available for distribution to Plan participants.

Use of Estimates

The preparation of financial statements in accordance with the liquidation basis of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Income Recognition

Interest income is recorded on the accrual basis.

Cash Equivalents

Cash equivalents are highly liquid, short-term cash investments generally with original maturities of three months or less.

3. Employer Contributions

The Plan was terminated on the ESOP termination date and was in liquidation on July 31, 2022, and December 31, 2021. Therefore, no further contributions were made to the Plan.

4. Related Party and Party-in-Interest Transactions

GreatBanc Trust Company is the trustee as defined by the Plan and is considered to be a party-in-interest. Fees paid to the trustee were \$1,270 in the period January 1, 2022 to July 31, 2022. There were no fees paid to the trustee in 2021. These party-in-interest transactions were not prohibited by ERISA.

5. Tax Status

The Plan reviews its tax positions for uncertainty and records a provision for tax positions which may not be sustained based on their technical merits if examined by taxing authorities. At July 31, 2022, and December 31, 2021, there were no matters requiring a provision for uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

The Plan was terminated on November 20, 2020, in conjunction with the Transaction; subsequently, becoming a profit-sharing plan. See Note 1. On September 7, 2021, the Plan submitted an application with the IRS for a determination that the termination of the Plan effective November 20, 2020, did not adversely affect the Plan's tax-qualified status. A favorable determination letter was received from the IRS dated March 25, 2022.

6. Subsequent Events

Subsequent events were evaluated through February 6, 2023, the date the financial statements were available to be issued.
