INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the 401(K) Profit-Sharing Plan for Employees of Royal Home Care Services, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of January 31, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period January 1, 2022 to January 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of January 31, 2022 and December 31, 2021, and for the period January 1, 2022 to January 31, 2022, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

Note 1 – Description of Plan

The following description of the 401(K) Profit-Sharing Plan for Employees of Royal Home Care Services, Inc. (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Royal Home Care Services, Inc. (the “Company”), who are age 21 or older, except non-resident aliens and those who are classified as independent contractors. There is no service requirement for elective deferrals. Participants are eligible for Company contributions upon completion of one year of service. The Plan was established effective September 1, 2020 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

In September 2021, the Board of Directors of the Company resolved to merge the Plan into the Paychex Pooled Employer 401(k) Plan effective October 14, 2021. All participant and employer contributions to the Plan ceased after that date and all subsequent contributions were remitted to the Paychex Pooled Employer 401(k) Plan. In January 2022, the Plan’s assets which totaled \$65,590, were transferred to the Paychex Pooled Employer 401(k) Plan in a direct plan-to-plan transfer of assets.

Contributions

Prior to the Plan being merged into the Paychex Pooled Employer 401(k) Plan, participants could contribute each year, up to 100% of their annual compensation, as defined in the Plan, on a pre-tax or an after-tax (Roth) basis. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan. The Company could make matching contributions equal to a discretionary % of participants’ elective deferrals as determined by the Company each Plan year. The Company could also make discretionary employer base contributions to the Plan as determined by the Company annually. Employer base contributions were to be allocated to eligible participants in the ratio that each eligible participant’s compensation bears to the total compensation paid to all eligible participants. The Company did not make employer contributions to the Plan for the period January 1, 2022 to January 31, 2022. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant’s account was credited with the participant’s contribution and Company matching contributions, if any, as well as allocations of the Company’s employer base contributions, and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that are paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant’s vested account.

Vesting

Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts was based on years of continuous service. A participant was 100% vested after 3 years of credited service. Participants who were active employees of the Company also become 100% vested upon reaching normal retirement age, death, or disability.

Notes Receivable from Participants

The Plan did not permit participants to borrow from their accounts.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various forms of annuities, as provided in the Plan document. In-service distributions were permitted for participants who attain age 59½ or for a participant who was experiencing financial hardship.

Forfeited Accounts

At January 31, 2022 and December 31, 2021, forfeited non-vested accounts totaled \$0 and \$675, respectively. These accounts were able to be used to reduce future Company contributions. During the period January 1, 2022 to January 31, 2022, forfeitures were not used to reduce Company contributions.

Recent Regulatory and Economic Events

On January 1, 2020, the Setting Every Community Up for Retirement Enhancement Act (SECURE Act) of 2019, which was enacted and signed into law on December 20, 2019, to incentivize saving and investing for retirement, went into effect. The SECURE Act a) increases the required minimum distribution (RMD) age for retirement accounts from age 70.5 to age 72; b) repeals the maximum age for traditional IRA contributions; c) requires employers to include long-term part-time employees who have completed at least 500 hours of service each year for three consecutive years and are age 21 or older, as participants in 401(k) plans, except in the case of collectively bargained plans. However, these participants can be excluded from safe harbor contributions, nondiscrimination and top-heavy requirements; d) allows for distributions of up to \$5,000 from retirement accounts penalty-free within a year of birth or adoption for qualified expenses; e) allows automatic-enrollment safe harbor plans to increase the cap on raising payroll contributions from 10 percent to 15 percent; and f) allows individuals to withdraw up to \$10,000 from 529 plans to repay their child's student loans.

On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), was enacted and signed into law. Section 2202 of the CARES Act provides for special distribution options and rollover rules for retirement plans and IRAs and expands permissible loans from certain qualified retirement plans. The CARES Act a) provides for expanded distribution options and waives the 10% early distribution penalty, for up to \$100,000 of coronavirus-related distributions from eligible retirement plans (certain employer retirement plans, such as section 401(k) and 403(b) plans, and IRAs) to qualified individuals, as well as providing special rollover rules with respect to such distributions; b) allows plan sponsors to adopt a provision to allow participants who were impacted by COVID-19 and meet certain criteria, to increase the maximum amount eligible participants may borrow from their account to the lesser of \$100,000 (minus outstanding plan loans of the individual), or 100% of the participant's vested balance for loans established from March 27, 2020, to September 22, 2020. Furthermore, it allows participants with existing loans to defer their loan repayments with a due date from the enactment date through December 31, 2020, for up to one year; and c) waives the requirement for participants to take a required minimum distribution (RMD) from their retirement account for the 2020 calendar year.

On December 27, 2020, the Consolidated Appropriations Act, 2021 (CA Act) was enacted and signed into law. The CA Act includes a temporary rule preventing partial plan terminations for qualified retirement plans in some circumstances. The IRS previously issued guidance under the CARES Act clarifying employees furloughed or laid off due to COVID-19 but rehired by the end of 2020 would not be counted in determining whether a retirement plan incurred a partial plan termination for the plan year. The CA Act gives employers broader relief than the IRS guidance. Under this new law, a retirement plan will not have a partial termination for a plan year if (1) any portion of the plan year includes the period beginning March 13, 2020, and ending on March 31, 2021, and (2) the number of active participants covered by the plan on March 31, 2021, is at least 80% of the number of active participants covered by the plan on March 13, 2020.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by investment advisers, custodian, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

Subsequent Events

Plan management has evaluated subsequent events through the date of the report, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Note 3 – Fair Value Measurements (continued)

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at January 31, 2022 and December 31, 2021:

Separate Account: Investments held by the Plan in the Mutual of America Separate Account consist solely of mutual funds registered with the U.S. Securities and Exchange Commission and are carried at the net asset value (NAV) at which the mutual fund shares are actively traded. These funds are required to publish their NAV and to transact at that price.

Note 4 – Related Party Transactions and Party-In-Interest Transactions

The Plan's investments were managed by Mutual of America Life Insurance Company (Mutual of America). Mutual of America served as the Plan's custodian. These transactions qualify as exempt party-in-interest transactions.

The Plan utilized various third-party service providers who provided certain administrative services to the Plan pursuant to service agreements. Fees incurred by the Plan for investment management services are included in net depreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. During 2022, the Plan did not make direct payments to third-party service providers for administrative services provided to the Plan. The Plan sponsor pays directly any other fees related to the Plan's operations. These transactions qualify as exempt party-in-interest transactions.

Note 5 – Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions (see Note 1).

Note 6 – Tax Status

The Plan was structured and followed a prototype non-standardized profit-sharing plan with cash or deferred arrangement (CODA), pre-approved by the IRS. The IRS issued an opinion letter dated March 31, 2014, that the prototype non-standardized profit-sharing plan is acceptable in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan had been amended since receiving the opinion letter, the Plan administrator believes that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan was qualified, and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 – Custodian Certification

Certain information related to investments disclosed in the accompanying financial statements, including investments held at December 31, 2021, and net depreciation in fair value of investments for the period January 1, 2022 to January 31, 2022, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Mutual of America Life Insurance Company, the custodian of the Plan.

Note 8 – Delinquent Participant Contributions

During 2021, the Company failed to remit to the Plan's custodian certain participant contributions totaling \$1,153, within the period prescribed by the Department of Labor regulations. The Company remitted these contributions to the Plan during 2021 and will make contributions to the affected participants' accounts maintained in the Paychex Pooled Employer 401(k) Plan (see Note 1) to compensate those participants for potential lost income due to the delays.

Note 9 – Compliance Matter

The Company identified a potential operation error related to the methodology used to allocate the employer base contributions remitted to the Plan in September 2020. Additionally, the Company identified an operational error in the compensation used to allocate the 2020 contributions remitted to the Plan in March 2021. The Company intends to research the matter further and consult an ERISA attorney to determine if correction to the allocation of these contributions is required. If correction is required, the Company intends to make the corrections using the applicable correction programs under the IRS Employee Plans Compliance Resolution System. The Company does not expect the financial impact, if corrections are required, to be material to the financial statements as a whole.
