The financial statements comprise the statements of net assets available for benefits as of July 31, 2022 and December 31, 2021, the related statements of changes in net assets available for benefits for the period from January 1, 2022 to July 31, 2022 and year ended December 31, 2021, and the related notes to the financial statements.

1. Plan Description

The following brief description of the Marena Group 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits to all employees of The Marena Group, Inc. (the Company).

Employees were eligible to make pre-tax and designated Roth salary reduction contributions on the first day of the quarter after completing one month of service, having attained the age of 21, are not non-resident aliens, and are not employees of an administrative services organization with outside payroll services. Participants were also eligible to receive discretionary matching and profit-sharing contributions upon attaining eligibility requirements to participate in the Plan.

Contributions

Participants could elect to defer up to 100% of their annual compensation as defined by the Plan, up to the maximum dollar amounts allowable by law. Participants could also contribute amounts representing distributions for other qualified plans. All employees were automatically enrolled with a 3% deferral contribution once they become eligible for the Plan. At any time, a participant could elect not to contribute or could increase or decrease his or her deferral rate. The Plan provided for a discretionary matching contribution for each participant, which was 50% of the first 6% of annual compensation (as defined by the Plan) that a participant contributed to the Plan for the period January 1, 2022 to July 31, 2022 and year ended December 31, 2021. The Plan also provided for a discretionary profit-sharing contribution. There were no discretionary profit-sharing contributions for the period January 1, 2022 to July 31, 2022 and year ended December 31, 2021. Participants who were eligible to make deferral contributions and who attained age 50 before the close of the calendar year are eligible to make catch-up contributions. The Plan provided for the acceptance of rollover contributions from other plans qualified under the Internal Revenue Code. Participants directed the investment of their contributions into various options offered by the Plan. Contributions were subject to certain limitations.

Participant Accounts

Each participant's account was credited with the participant's contributions and an allocation of a) the Company's discretionary matching and profit-sharing contributions, b) Plan earnings and losses and c) an allocation of administrative expenses paid by the Plan. Discretionary matching contributions were allocated among participants based upon each eligible participant's elected salary deferral. Discretionary profit-sharing contributions were allocated based on the eligible compensation of participants. Plan earnings or losses were allocated on the basis of actual results of the investments selected by each participant. Investments were maintained in individual member accounts managed by Voya Retirement Insurance and Annuity Company (Voya).

Vesting

Participants were immediately vested in their participant contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching and profit-sharing contributions credited to participants' accounts was based on years of continuous service. A participant was 100% vested upon completion of three years of credited service.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the participant's highest outstanding loan balance during the previous twelve months or 50% of their vested account balances, subject to Plan provisions. Notes receivable terms ranged from one to five years or up to fifteen years for the purchase of a primary residence. Notes receivable were secured by the vested balance in the participants' accounts and bore interest at the prime rate plus 1%. Principal and interest was paid ratably through bi-weekly payroll deductions.

Payment of Benefits

Upon the attainment of age 59.5 or termination of service, a participant or beneficiary could elect to receive a lump-sum amount equal to the value of the vested funds allocated to the participant's account, or an annuity (only if invested in specific investments and only if elected), subject to Plan provisions. The Plan required that distribution payments between \$1,000 and \$5,000 be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant did not elect otherwise.

Participants could also receive hardship and in-service distributions, as permitted in the Plan document. A participant who received a hardship distribution was not prohibited from making deferrals after receipt of their distribution. Benefits were recorded when paid.

Forfeitures

Upon a participant's termination of employment before normal retirement, disability or death, the portion of their Company contributions not then vested were forfeited. The forfeited portion of any participant's account could be used to reduce Company contributions or to pay Plan expenses. As of July 31, 2022 and December 31, 2021, unallocated forfeiture accounts totaled \$0 and \$10,048, respectively. During the period from January 1, 2022 to July 28, 2022 and year ended December 31, 2021, forfeitures of \$14,004 and \$64,924, respectively, were used to reduce Company contributions and pay Plan expenses.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value, except for fully benefit-responsive investment contracts, which were reported at contract value. Fair value was the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. Plan management determined the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for further discussion of fair value measurements.

Fully benefit-responsive investment contracts were reported at contract value. Contract value was the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value was the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Company invested in investment contracts through a guaranteed interest account.

Purchases and sales of investments were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes were reclassified as distributions based upon the terms of the Plan document.

Expenses

Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants were charged directly to the applicable participants' accounts and are included in administrative expenses. Investment related expenses were included in net appreciation (depreciation) in fair value of investments on the accompanying statements of changes in net assets available for benefits.

Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through January 31, 2023, noting no items requiring disclosure.

3. Information Certified by Voya

The plan administrator had elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Voya, the custodian of the Plan, except for comparing such information certified by the custodian to information included in the Plan's financial statements.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Pooled Separate Accounts: Valued at the Net Asset Value (NAV) of its underlying investments. The pooled separate accounts included underlying investments in mutual funds which had observable level 1 or level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. FASB ASC 820, *Fair Value Measurement and Disclosures*, allows NAV per share to estimate the fair value as long as certain requirements are met. It is the Plan's assessment that these accounts met those requirements. Since the participants had the ability to redeem the accounts at NAV as of the measurement dates on a daily basis, the accounts were properly categorized as a Level 2 fair value measurement.

The methods described above could produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no Plan investments as of July 31, 2022.

5. Investment Contract with Insurance Company

The Plan had entered into an investment contract with Voya. Voya maintained the contributions in pooled separate accounts and guaranteed interest accounts. The accounts were credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Voya.

The pooled separate accounts, as reported to the Plan by Voya, were included in the financial statements at fair value, which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses.

As the guaranteed interest account was fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest account. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive contracts was dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could be affected by future economic developments. No events were probable of occurring that could have limited the ability of the Plan to transact at contract value with the contract issuers and that also would have limited the ability of the Plan to transact at contract value with the participants.

6. Tax Status

The Plan was qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986, as amended.

The plan administrator believes that the Plan was currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes was included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator had analyzed the tax positions taken by the Plan and had concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

7. Related-Party Transactions

Certain Plan investments were pooled separate accounts with underlying shares in mutual funds and a guaranteed interest account managed by Voya. Voya was the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions.

8. Plan Merger

Effective in July 2022, the Company approved the Plan to be merged into a new plan called the SaveWise Pooled Employer Plan (SaveWise Plan). Newport Group is the custodian of the SaveWise Plan. The merger into the SaveWise Plan initiated a “Black Out” period that continued through August 15, 2022. During the black out period, funds could not be applied to the employee selected funds or withdrawn from the Plan or the SaveWise Plan until Newport Group had time to accurately complete the merger conversion. Plan assets of \$3,763,136 were transferred to the SaveWise Plan by July 31, 2022. The participants will continue to make payroll contributions to the SaveWise Plan thereafter.
