### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Mistequay Group, Ltd 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 22, 2022 (In liquidation) and December 31, 2021 (ongoing) and the related statement of changes in net assets available for benefits for the period January 1, 2022 through September 22, 2022 (In liquidation) and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of September 22, 2022 and for the period January 1, 2022 to September 22, 2022, and for the year ended December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.



### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles.
- The information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audit in accordance with U.S. generally accepted auditing standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter**

As discussed in Note 1 to the financial statement, management of the Plan approved a plan liquidation on May 25, 2022, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the ongoing basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements.

Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with U.S. generally accepted accounting principles, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.



### **Auditor's Responsibility for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with U.S. generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with U.S. generally accepted auditing standards, we:

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. generally accepted accounting principles.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles.

**NOTE 1 - PLAN DESCRIPTION**

The following description of the Mistequay Group, Ltd. 401(k) Plan (Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the plan document.

**General.** The Plan is a defined contribution plan established by Mistequay Group, Ltd. (Company) under the provision of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. All employees of Mistequay Group, Ltd. who have completed two months of service, as defined, are eligible to participate, provided they are at least 19 years of age and are non-union employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

**Plan Administration.** The Plan is administered by the Benefits Committee which is appointed by the board of directors of the Company. The Plan's custodian, Nationwide Trust Company (Custodian), is responsible for the custody and management of the Plan's assets.

**Coronavirus Aid, Relief and Economic Security (CARES) Act.** On March 11, 2020, the World Health Organization declared the outbreak of the novel coronavirus, COVID-19, to be a pandemic. In response to this declaration, the United States federal government passed the CARES Act on March 27, 2020. The CARES Act allows eligible plan participants to request penalty-free distributions of up to \$100,000 before December 31, 2020 for qualifying reasons associated with the COVID-19 pandemic. These distributions are permitted to be repaid. The CARES Act also permits a temporary increase on plan loan amounts from \$50,000 to \$100,000 and suspension of loan payments for up to one year. The Plan adopted these changes during 2020.

**Contributions.** Eligible employees can contribute up to the maximum percentage of compensation and dollar amount permissible under Section 402(g) of the IRC not to exceed the limits of Code Sections 401(k), 404 and 415. The Company may provide a discretionary matching contribution to be determined annually. The participant contributions and the Company matching contributions may be allocated to various collective investment and mutual funds as the participant directs.

**Plan Termination.** The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the applicable requirements of ERISA and in accordance with the provisions on the plan document. Effective May 25, 2022, the Company's board of directors adopted a resolution to terminate the Plan. As part of this transaction, all participants became 100% vested in the Company contributions on this date and all participant contributions to the Plan ceased. As a result, management determined that liquidation was imminent.

In May 2022, termination packets were distributed to all participants. As a result of the resolution to terminate the Plan, each employee who had made contributions to the Plan had the option of receiving a lump sum cash payment of their account balance or rolling the balance over to another qualified plan. Total cash payments made in conjunction with the Plan termination during the period ended September 22, 2022 were \$10,002,279. These amounts are included in the benefit payments on the Statement of Changes in Net Assets Available for Benefits.

**NOTE 1 - PLAN DESCRIPTION (CONTINUED)**

***Vesting.*** As a result of the decision to terminate the Plan during 2022, all participants became fully vested in their account balances on the date of termination. Prior to the Plan's termination, participants began vesting in employer contributions at 20% after 2 years of service. The vesting increased 20% per year for each year of service after the first two and participants were fully vested after providing 6 years of service. Participants are always vested 100% in their contributions and related earnings.

***Payment of Benefits.*** On retirement, death, disability or termination of service, a participant (or the participant's beneficiary in the event of death) may elect to receive a lump-sum distribution equal to the participant's account balance. In addition, hardship distributions are permitted if certain criteria are met.

***Participant Accounts.*** Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions and related employer matching contributions, as well as the participant's share of the Plan's income and any related administrative expenses. Allocations of income and expenses are based on the proportion that each participant's account balance bears to the total of all participant account balances.

***Participant Loans.*** A participant may borrow from his or her account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years. The loans are secured by the balance in the participant's account and bear interest based on the average rate charged by at least two local commercial lenders. Loans are repaid by means of payroll deduction. A fee related to administering a loan under the Plan may be deducted from the participant's account.

***Forfeited Accounts.*** Forfeited nonvested accounts are allocated to the participants in the same manner as employer contributions or used to pay administrative expenses. The amount of forfeitures used to pay fund the employer match was \$909 for 2022 and \$5,700 for 2021. There were no unallocated forfeitures as of September 22, 2022.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting and Use of Estimates**

As a result of the decision to terminate the Plan effective May 25, 2022, and in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), management determined that liquidation of the Plan is imminent and the financial statements as of September 22, 2022 and for the period January 1, 2022 through September 22, 2022 have been prepared on the liquidation basis of accounting. For the periods before the decision to terminate the Plan was made, the financial statements were prepared using the ongoing plan basis of accounting. The accompanying Statement of Net Assets Available for Benefits as of December 31, 2021 is presented on that basis.

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from these estimates.

**Income Recognition**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Investment Valuation**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisor and custodians. See Note 6 for more information. Participant notes receivable are valued at cost which approximates fair value. The contract value of the guaranteed investment contract is calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations.

**Net Appreciation (Depreciation) in Fair Value of Investments**

Net realized and unrealized appreciation (depreciation) is recorded in the accompanying statement of changes in net assets available for benefits as net depreciation in fair value of investments. Brokerage fees are added to the acquisition costs of assets purchased and subtracted from the proceeds of assets sold.

**Risks and Uncertainties**

The Plan provides for investment options in collective investment funds, unallocated contracts and mutual funds with Nationwide Trust Company and Nationwide Life Insurance Company. The underlying investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that the changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

**Administrative Expenses**

Substantially all administrative expenses are paid by the Plan. The Company paid \$7,500 on behalf of the Plan during 2022.

**Events Occurring After Reporting Date**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through the date of the accompanying Independent Auditor's Report, which is the date the financial statements were available to be issued.

**NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S CUSTODIANS**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Nationwide Trust Company and Nationwide Life Insurance Company, the Custodians, have certified that the investment assets, transactions, and income reported in the accompanying Statements of Net Assets Available for Benefits as of September 22, 2022 (liquidation basis) and December 31, 2021 (ongoing) and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the period January 1, 2022 through September 22, 2022 (liquidation basis) is complete and accurate. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

**NOTE 4 - INVESTMENTS**

There were no investments which were both acquired and disposed within the respective plan year that are required to be disclosed.

**NOTE 5 - INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan entered into an investment contract with Nationwide Life Insurance Company. Nationwide Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Nationwide Life Insurance Company. The contract is included in the financial statements at contract value (which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses), because it is fully benefit-responsive. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The average yield and crediting interest rate was 1.50 % for 2022 and 2021. The crediting interest rate is based on an agreed-upon formula with the issuer, but cannot be less than zero.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents; (2) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or (3) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with contract issuers and that also would limit the ability of the Plan to transact at contract value with participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; or (4) a material amendment to the agreement without consent of the issuer.

**NOTE 6 - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

**NOTE 7 - RELATED PARTY TRANSACTIONS**

Certain Plan investments are shares of mutual funds, units of common/collective investment funds and an unallocated contract managed by Nationwide Trust Company and Nationwide Life Insurance Company. Nationwide Trust Company and Nationwide Life Insurance Company are the custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Administration fees of \$41,300, \$18,610 and \$20,081 were paid to the custodians, investment advisor and third party administrator, respectively by the Plan during 2022.

**NOTE 8 - INCOME TAX STATUS**

The Company adopted a Prototype Non-Standardized Profit Sharing Plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Company believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of September 22, 2022. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
