### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Jamaica Bearings Co., Inc. Employees 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of April 29, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period January 1, 2022 to April 29, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Jamaica Bearings Co., Inc. ### 1. Description of Plan

The following description of Jamaica Bearings Co., Inc. Employees 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all full-time employees of Jamaica Bearings Co., Inc. and Jamaica Aerospace Company LLC ("the Companies") who have three months of service and are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Plan Merger

Effective April 29, 2022, the Plan, including all assets and liabilities, were merged into and with the Alcott Group 401(k) Plan with participants of the Plan becoming participants in the Alcott Group 401(k) Plan.

#### Contributions

For 2022, participants could contribute up to \$20,500, or 100 percent of pre-tax annual compensation, as defined in the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions of \$6,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Companies may make discretionary matching contributions to the Plan equal to a percentage of each participant's defined compensation, the exact percentage to be determined each year by the employer. Additionally, the Companies may make a profit-sharing contribution as of the end of the year based upon profits. For the period ended April 29, 2022, the Companies' contributions totaled \$29,481.

#### Investment Options

Participants direct the investment of their contribution into various investment options offered by the Plan.

#### Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of the Companies' contributions and Plan earnings and charged with an allocation of plan losses and administrative expenses. Allocations are based on participant's earnings or account balances, as defined. Forfeited balances of terminated participants' non-vested accounts are used to reduce the Companies' future contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Companies' discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after five years of credited service.

### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 5.25% to 7.5%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through weekly payroll deductions. Delinquent notes receivable from participants were reclassified as distributions based upon the terms of the Plan document.

### Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a ten-year period. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

### Forfeitures

Employer contributions and Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year. The Companies used no forfeitures for the period ended April 29, 2022.

### Expenses

The Companies pay administrative expenses of the Plan, with the exception of certain asset-based investment fees.

## **2. Summary of Significant Accounting Policies**

### Basis of Accounting

The financial statements of the Plan have been prepared under the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid accrued interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account are included in administrative expenses when incurred. As of April 29, 2022, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the term of the Plan document.

### Payments of Benefits

Benefits are recorded when paid.

### **3. Unaudited Information Certified by the Plan Trustee**

The April 29, 2022, Statements of Net Assets Available for Benefits, the investment activities included on the Statements of Changes in Net Assets Available for Benefits for the period from January 1, 2022 to April 29, 2022, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by Ascensus Trust Company (the "Trustee") in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Disclosure under the Employee Retirement Income Security Act of 1974. The information certified for the period ended April 29, 2022 includes no investments and related total investment losses of \$2,259,703.

### **4. Fair Value Measurements and Investments**

FASB ASC Topic 820, Fair Value Measurements, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

*Level 1:* Inputs are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access, at the measurement date.

*Level 2:* Inputs other than quoted prices included in Level 1 that are observable for the asset or liability through corroboration with market data at the measurement date.

*Level 3:* Unobservable inputs that reflect management's best estimate of what participants would use in pricing the asset or liability at the measurement date.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

#### *Registered investment companies*

These investments are valued at the daily closing price as reported by the fund. Registered investment companies (mutual funds) held by the Plan are open-end mutual funds that are registered with the

Securities and Exchange Commission (“SEC”). The mutual funds held by the Plan are deemed to be actively traded.

### *Common collective trust funds*

Investments in common collective trusts are valued based on NAV’s reported by the Trustee of the funds which are based on the value of the underlying assets owned by the fund, minus its liabilities and then divided by number of shares outstanding. The NAV is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The fair values of receivables approximate their carrying values.

## 5. Tax Status

The plan administrator has adopted an IRS pre-approved prototype plan of Ascensus, Inc. (a wholly owned subsidiary of Ascensus Trust Company, the trustee). On March 31, 2014, Ascensus, Inc. obtained a letter in which the IRS stated its opinion that the form of the pre-approved prototype plan of Ascensus, Inc. is acceptable under Section 401 of the Internal Revenue Code ("IRC") for use by employers for the benefit of their employees. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

## 6. Related Party and Party-In-Interest Transactions

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Companies. Notes receivable from participants are also considered to exempt party-in-interest transactions.

## 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur

in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

### **8. Subsequent Events**
