Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of VestraCare, Inc. 401(k) Savings and Retirement Plan (formerly known as the Golden Hills Advisors Corporation 401(k) Savings and Retirement Plan) (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Merger

As discussed in Note 1 to the financial statements, the 401(k) Committee, approved on November 3, 2021, to merge the Plan into The McGuire Group 401(k) Plan. The merger was effective April 22, 2022 and all plan assets were transferred to The McGuire Group 401(k) Plan on April 18, 2022. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

Supplemental Schedule Required by ERISA

The supplemental schedule H, line 4a – schedule of delinquent participant contributions for the period ending April 18, 2022 is presented for purposes of additional analysis and is not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates

directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the VestraCare, Inc. 401(k) Savings and Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all employees of VestraCare, Inc. (the Company) and its wholly owned subsidiaries including Susquehanna Nursing and Rehabilitation (Susquehanna), Chautauqua Nursing and Rehabilitation (Chautauqua), Clinton Square Operations d/b/a Bishop Rehabilitation and Nursing (Bishop), and Roscoe Regional HealthCare d/b/a Roscoe Rehabilitation and Nursing (Roscoe), (collectively, the Employers) who are not non-resident aliens, have six months of service, and are age 21 or older. Plan entry dates are the first day of the month coinciding with or the following month after the date the eligibility requirements are met. The name of the Plan was changed to VestraCare, Inc. 401(k) Savings and Retirement Plan, formerly known as the Golden Hill Advisors Corporation 401(k) Savings and Retirement Plan, effective September 21, 2021. The Plan is subject to the provisions of ERISA. The Plan Trustees are responsible for oversight of the Plan. The Plan's investment advisor determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Plan Merger: On November 3, 2021, the 401(k) Committee resolved to merge the Plan into The McGuire Group 401(k) Plan. As a result, net assets including notes receivable from participants, of \$6,696,183 were transferred to The McGuire Group 401(k) Plan effective April 18, 2022. The merger does not impact participant benefits as the benefit provisions were incorporated in The McGuire Group 401(k) Plan.

Contributions: Each year, participants may contribute up to the maximum amount allowed by law of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan allows for after-tax Roth contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Plan allows the Employers to make a discretionary employer matching contribution at a percentage or dollar amount to be determined by the Employers on a uniform basis for all participants. For employees of the Company, Susquehanna, and Chautauqua, the Employers contribute 100 percent, up to a maximum of 3 percent, of the participant's eligible compensation. For employees of Bishop, the Employer contributes 100 percent, up to a maximum of 2 percent for union employees and up to a maximum of 4 percent for non-union employees, of the participant's eligible compensation. For employees of Roscoe, the Employer contributes 100 percent, up to a maximum of 4 percent, of the participant's eligible compensation. For employees of the Company, Susquehanna, Chautauqua, and Roscoe, in order for a participant to receive the discretionary employer matching contribution, the employee must fulfill the eligibility requirements and complete six months of service. For employees of Bishop, in order for a participant to receive the discretionary matching contribution, the employee must fulfill the eligibility requirements and complete one year of service and 1,000 hours of service if a union employee and 6 months of service and 500 hours of service if a non-union employee.

The Plan allows the Employers to make a discretionary profit-sharing contribution. The discretionary profit-sharing contribution will be allocated in the same ratio as each participant's compensation bears to the total of such compensation of all participants. In order for a participant to receive the discretionary profit-sharing contribution, the employee must fulfill the eligibility requirements and complete six months of service, as defined in the Plan document.

NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

Participant Accounts: Each participant's account is credited with the participant's contribution, any discretionary employer matching contributions, any employer discretionary profit-sharing contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employers contribution portion of their accounts is based on years of continuous service. Participants are 20 percent vested in discretionary matching contributions and profit-sharing contributions after two years of service, as defined by the Plan with a 20 percent annual increase each of the next four years.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 2 percent above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits: On termination of service due to death, disability, retirement, or when a participant ceases to be an employee of the Company, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. A participant can also withdraw all or any portion of his or her account in the event of financial hardship. In addition, in-service distributions, without penalty, may be made upon the attainment of age 59.5, if the participant has been a participant in the Plan for at least 5 years, or if the amounts being distributed have accumulated in the Plan for at least 2 years.

Forfeited Accounts: At December 31, 2021, forfeited nonvested accounts were \$60,213. There were no forfeited nonvested accounts as of April 18, 2022. These accounts are used to reduce future employer contributions. During the period ending April 18, 2022 and for the year ended December 31, 2021, employer contributions were reduced by \$69,841 and \$110,523, respectively, from forfeited nonvested accounts.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value (except the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the period and year.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of April 18, 2022 or December 31, 2021.

Excess Contributions Payable: Amounts payable to participants for contributions in excess of amounts allowable by the IRS are recorded as a liability with a corresponding reduction to contributions. As the Plan did not distribute the 2021 excess contributions to the applicable participants prior to the period ended April 18, 2022, the Plan Sponsor must pay a 10% excise tax.

Payment of Benefits: Benefit payments are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net (depreciation) appreciation in fair value of investments.

Subsequent Events: The Plan has evaluated subsequent events through February 23, 2023, the date the financial statements were available to be issued.

NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 18, 2022 and December 31, 2021.

Money market account: Valued at cost plus accrued interest. The money market fund is classified as a Level 1 investment.

Shares of registered investment companies: Valued at the net asset value (NAV) of shares held by the plan at year end. The NAV is the closing price reported on the active market on which the securities are traded. Shares of registered investment companies are classified as Level 1 investments.

The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2021. There were no assets at fair value in the Plan as of April 18, 2022.

NOTE 4. GUARANTEED INVESTMENT CONTRACT

The Plan has a traditional fully benefit-responsive guaranteed investment contract with Nationwide Life Insurance Company (Nationwide) which totaled \$34,504 as of December 31, 2021. Nationwide maintains the contributions in a general account. The account is credited with interest based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate quarterly. The interest rate is based on a formula established by the contract issuer. The interest rate is reviewed on a quarterly basis for resetting. For the period ending April 18, 2022, the interest rate was 1.18%, (ranged from 1.18% to 1.24% - for the year ended December 31, 2021). The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. There is no minimum interest rate and there is no scheduled maturity date. There was no guaranteed investment contract as of April 18, 2022.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Nationwide, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

NOTE 5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Nationwide Trust Company, FSB and Nationwide Life Insurance Company, the custodians of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

NOTE 6. TAX STATUS

Effective January 1, 2015, the Plan adopted a volume submitter plan sponsored by Nationwide. The volume submitter plan has received an advisory letter from the IRS regarding the volume submitter plan's qualified status. The volume submitter plan advisory letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9. FINANCIAL CERTIFICATION

The following financial information relating to the Plan's assets as of April 18, 2022 and December 31, 2021, as well as income and transactions for the period ended April 18, 2022 and the year ended December 31, 2021, has been derived from information provided by Nationwide Trust Company, FSB and Nationwide Life Insurance Company, the custodians of the Plan, and has been certified by them as complete and accurate. The incorporation of this financial information in the accompanying financial statements is based solely on their certifications and has not been audited by independent accountants.
