Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of CenterPointe 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits (in liquidation) as of June 24, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits (in liquidation) for the period ended June 24, 2022 and year ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of CenterPointe 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 24, 2022 and December 31, 2021 and for the period ended June 24, 2022 and the year ended December 31, 2021, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of CenterPointe 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter - Basis of Accounting

As discussed in Note 1 to the financial statements, the governing body of the CenterPointe 401(k) Plan approved a plan of liquidation on December 31, 2021, and management determined liquidation is imminent. As a result, the Plan's financial statements are presented on the liquidation basis of accounting as of June 24, 2022 and for the period then ended and at December 31, 2021. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about CenterPointe 401(k) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit the section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

The supplemental schedule of delinquent participant contributions for the period ended June 24, 2022 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of the CenterPointe 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan's provisions.

General

Employees were immediately eligible upon hire to contribute pretax deferrals to the Plan. The Plan was established May 30, 2003, as a defined contribution plan and includes the employees of Little Hills Health Care, LLC d/b/a CenterPointe Hospital, Signature Behavioral Hospital Operations, LLC d/b/a Signature Psychiatric Hospital and CenterPointe Hospital of Columbia, LLC. The Plan Sponsor is CenterPointe Behavioral Health System, LLC ("the Hospital").

Employees who were age 21 or older and had completed one year of service with over 1,000 hours of service, were eligible to receive Hospital matching and discretionary profit-sharing contributions. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Retirement Committee was responsible for oversight of the Plan and determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Effective December 31, 2021, the Plan was terminated and all Plan assets were distributed in June 2022. In accordance with the Plan's liquidation, the Plan accrued expected 2022 administrative expenses as of December 31, 2021.

Contributions

Participants could contribute a portion of their pretax annual compensation, not to exceed the maximum percentage of annual compensation allowed by the Internal Revenue Code ("IRC"). Participants who had attained age 50 before the end of December 31, 2021 were eligible to make catch-up contributions for the year ended December 31, 2021. Participants could also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans.

The Hospital matched 50 percent of the employee's deferral contribution up to 6 percent of their annual compensation, as defined in the Plan. The Hospital could contribute additional profit-sharing amounts at the discretion of the Hospital's Board of Directors. The Hospital made no discretionary contributions during the year ended December 31, 2021 and 2022. Contributions were subject to certain IRC limitations. Effective February 1, 2019, the Plan was amended and restated to include an automatic enrollment feature for all newly eligible participants. Participants were deemed to have elected to make a salary deferral of 2% of their compensation (as defined by the Plan), unless they file an election to contribute a different amount (or no amount).

Effective December 31, 2021, the Plan was terminated and all contributions were ceased, however, all deferrals that were not deposited into the Plan as of December 31, 2021 were deposited into the Plan and allocated to the applicable participant accounts during 2022.

Participant accounts

Each participant's account was credited with the participant's contributions and Hospital matching contributions, as well as allocations of the Hospital profit sharing contribution and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were vested immediately in their contributions plus actual earnings thereon.

As of December 31, 2021, vesting in the Hospital's contribution portion of their accounts was based on years of continuous service, as follows:

All participants became fully vested in the Hospital's contribution portion of their accounts effective December 31, 2021 when the Plan terminated.

Notes receivable from participants

Participants could borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans were secured by the balance in the participant's account and beared interest at a reasonable rate as determined by the Plan administrator, based on the then prevailing interest rates. Principal and interest were paid ratably through payroll deductions. Effective December 31, 2021, the Plan was terminated and new loans were not applicable.

Payment of benefits

Any participant who terminated employment or became disabled received a lump sum distribution if the participant's vested account balance was less than \$5,000. If the participant's vested account balance exceeded \$5,000, the participant could elect to defer receipt of their benefits until age 65, subject to certain IRC minimum distribution rules. In the event of the participant's death, the participant's vested account balance was paid to the participant's designated beneficiaries. Due to the Plan termination effective December 31, 2021, all assets were distributed by June 2022.

Forfeited accounts

At June 24, 2022 and December 31, 2021, there were \$0 and \$16,354 forfeitures available for use, respectively. These accounts were used to reduce the Hospital's employer contributions to the Plan and to pay administrative fees of the Plan. During 2022 and 2021, the Hospital used forfeitures totaling \$16,257 and \$61,198 to reduce its contributions and administrative fees, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

As disclosed in Note 1, the Company terminated the Plan on December 31, 2021. As a result, the Plan's basis of accounting is the liquidation basis of accounting for the period ended June 24, 2022 and the year ended December 31, 2021. Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

Investment valuation and income recognition

The Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of estimates in financial statement presentation

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes receivable from participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when incurred. No allowance for credit losses was recorded as of June 24, 2022 and December 31, 2021.

Payment of benefits

Benefits were recorded when paid.

Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Hospital. Expenses that were paid by the Hospital are excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation in fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through February 2, 2023, the date the financial statements are available to be issued.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;

- Quoted prices for identical or similar assets or liabilities in the inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at June 24, 2022 and December 31, 2021.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The fully benefit-responsive investment contract, the Standard Stable Asset Fund ("The Standard"), was a group annuity contract and was reported at contract value in the 2022 and 2021 statements of net assets available for benefits. The 2022 and 2021 statements of changes in net assets available for benefits were also prepared on a contract value basis. Benefit responsiveness was defined as the extent to which a contract's terms and the Plan permit or require participant-initiated withdrawals at contract value. Contract value was the relevant measure for fully benefit-responsive investment contracts because this was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

Specific securities within the general account were not attributed to the investment contract with the Plan. The Plan owned a series of guarantees that were embedded in the insurance contract. The contractual guarantees were backed up by the full faith and credit of The Standard, the contract issuer. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Standard was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There were no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate was based on a formula agreed upon with the issuer and includes such factors as the investment-year method experience of the underlying contract or pool, projected levels of cash flows within the current interest rate environment, and the projected maturity of the underlying investments.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (iii) bankruptcy of the Sponsor or other Sponsor event (e.g., divestitures or spin-offs of a subsidiary) that causes a significant withdrawal from the Plan; or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

5. CERTIFICATION OF INVESTMENT INFORMATION

The Plan Administrator elected the method of compliance permitted by 29 CFR 2520.130-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust and The Standard Insurance Company, the trustees and custodian of the Plan, respectively, have certified to the completeness and accuracy of the investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of June 24, 2022 and December 31, 2021 and the related investment activity reflected in the statements of changes in net assets available for benefits for the period ended June 24, 2022 and the year ended December 31, 2021.

6. TAX STATUS

On March 31, 2014, the Internal Revenue Service ("IRS") stated that the prototype adopted by the Plan, as then designed, qualifies under the Code Section 401(a). The Plan had not received a determination letter specific to the Plan itself, however, the Plan Administrator believes that the Plan was designed and was operated in compliance with the applicable requirements of the Code. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision for income taxes were included in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there were no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

8. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were managed by the trustees and investment custodian as defined by the Plan; therefore, these transactions qualify as permitted party in interest transactions.

9. DELINQUENT PARTICIPANT CONTRIBUTIONS

The Company had late contributions totaling \$46,811, for the Plan year ended December 31, 2021. The Company utilized the Department of Labor Voluntary Fiduciary Corrections Program calculator to determine lost earnings in an effort to self-correct these delinquent contributions. The Company self-corrected all of the 2021 delinquent contributions by remitting the lost earnings to the affected participants during 2022.
