Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of eQHealth Solutions, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of May 18, 2022 and December 31, 2021 (in liquidation), and the related statement of changes in net assets available for benefits for the period ended May 18, 2022 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of May 18, 2022 and December 31, 2021, and for the period ended May 18, 2022, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Plan Termination

As further discussed in Notes 1 and 2 to the financial statements, the Board of Directors of eQHealth Solutions, LLC, the Plan Sponsor, voted to terminate the Plan effective September 30, 2021. In accordance with accounting principles generally accepted in the United States of America, the Plan has used the liquidation basis of accounting in presenting the financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN

The following brief description of the eQHealth Solutions, LLC 401(k) Plan (the Plan) is provided for general information purposes only. The Plan agreement contains a more complete description of the Plan's provisions.

General

The Plan was established on November 1, 2019, as a defined contribution plan by eQHealth Solutions, LLC (the Company or Plan Sponsor). The Plan was intended to meet the requirements of a qualified cash or deferred arrangement under Section 401(k) of the Internal Revenue Code (IRC) and was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Plan management was charged with responsibility for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

During 2021, the Plan adopted special relief measures established by the Coronavirus Aid, Relief, and Economic Security (CARES) Act and was also amended for the Setting Every Community Up for Retirement Enhancement (SECURE) Act of 2019. Effective January 1, 2022, the Plan was amended and restated to comply with the requirements of current laws and regulations.

Plan Termination

On August 26, 2021, the Company and Keystone Peer Review Organization, Inc. (KEPRO) announced the signing of a definitive merger agreement (Merger Agreement or Merger) whereby the Company would merge with and into KEPRO. The Merger was completed on October 1, 2021. Existing employees of the Company who became KEPRO employees were eligible to participate in the KEPRO 401(k) Plan on October 1, 2021.

Per the terms of the Merger Agreement, the Company's Board of Directors adopted a resolution effective September 30, 2021, to terminate the Plan, making liquidation of the Plan imminent. Subsequent to the Plan's termination, no employees were permitted to enter the Plan, and there were no additional benefit accruals. Additionally, all participants with an account balance remaining in the Plan became fully vested in all contribution sources, regardless of status or years of vested service. The Plan's termination also ceased employee and employer contributions into the Plan. The Plan Sponsor liquidated all Plan assets through distributions to participants with account balances by May 18, 2022.

Eligibility

The Plan covered substantially all full-time employees of the Company who were aged 18 or older. Employees were eligible to make elective salary deferral contributions upon attainment of age of 18 provided they were not an excluded employee, as defined in the Plan agreement. Employees who were employed on November 1, 2019, the effective date of the Plan, became eligible to participate in the Plan immediately as of that date. Eligibility for employer safe harbor matching contributions was the same as for participant elective salary deferrals.

Contributions

Participants could contribute up to 100 percent of their eligible compensation as pre-tax 401(k) deferrals subject to certain limits prescribed by law. Employees were automatically enrolled at a 3 percent deferral

rate upon becoming eligible to participate in the Plan and could elect to change or discontinue deferrals at any time. Active employees who did not select investment directives were automatically enrolled in the Mainspring Managed service. The accounts of terminated employees and employees with insufficient data for enrollment in the Mainspring Managed service defaulted to the Vanguard Balanced Index Admiral Fund. The Plan allowed participants aged 50 or older to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan.

The Company contributed a safe harbor match of 100 percent of the first 5 percent of the participant's elective deferrals, as defined by the Plan agreement. The Plan allowed for the Company to make discretionary profit sharing contributions. There were no discretionary profit sharing contributions made since the Plan's inception.

Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account was credited with the participant's contributions and the Company's matching contributions and allocations of Plan earnings and was charged with an allocation of administrative expenses. Plan earnings were allocated based on the participant's share of net earnings or losses of his or her respective elected investment options. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were vested immediately in all contributions plus actual earnings thereon.

Payment of Benefits

On termination of service, or upon death, disability or retirement, a participant could elect to receive a lump sum amount equal to the value of the participant's vested interest in their account, partial withdrawals, or installment payments. If a participant's vested account balances did not exceed \$5,000 upon termination of service, the vested account balance was distributed via lump-sum payment, unless otherwise elected by the participant. Provisions were available to allow withdrawals of benefits prior to termination of employment as defined in the Plan agreement and in compliance with the IRC.

As described above, the Plan was terminated effective September 30, 2021. Participants with balances at the termination date could elect to roll over their vested balance to another qualified plan or individual retirement account or receive a lump sum net of applicable taxes. Vested account balances of participants who did not make an affirmative election by the established cutoff date were rolled into a default individual retirement account with PenChecks Trust Company.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

As a result of the decision to terminate the Plan effective September 30, 2021, and in accordance with accounting principles generally accepted in the United States of America, the Plan's financial statements are presented using the liquidation basis of accounting. Under the liquidation basis of accounting, assets are stated at their estimated net realizable cash value and liabilities, if any, are stated at their anticipated settlement amounts. The Plan's investments are stated at fair value or contract value. In all cases, the reported value is equivalent to the estimated net realizable cash value for the investments during liquidation.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value (except for the fully benefit-responsive insurance contract, which was reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determined the Plan's valuation policies utilizing information provided by the investment adviser and custodian. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation in fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year, and indirect investment expenses.

Payment of Benefits

Benefits were recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Company and are excluded from these financial statements. Fees related to distributions, if any, were charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through February 20, 2023, the date the financial statements were available to be issued.

3. INVESTMENTS

The Standard Insurance Company (The Standard or custodian) held the funds for the Plan and Standard Retirement Services, Inc. (Standard Retirement Services) maintained an individual account for each participant. Contributions made on a participant's behalf under the Plan were directly allocated to that participant's account and were invested, based on the participant's direction, in pooled separate accounts and/or a guaranteed insurance contract.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board, Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 18, 2022 and December 31, 2021.

Pooled separate accounts: Comprised of mutual funds that are valued at the net asset value (NAV) of shares held by the Plan at year end. The publicly quoted prices of these underlying investments are used

in determining the NAV of the pooled separate accounts, which are not publicly quoted. NAV is used as a practical expedient to fair value and shares may be redeemed on a daily basis.

The Plan's pooled separate accounts were valued at NAV on the last day of the plan year based on information reported in the audited financial statements of the respective securities. Plan management reviewed the valuation methodologies used by the pricing services on an ongoing basis and ensured that any valuation methodologies were justified.

5. GUARANTEED INSURANCE CONTRACT WITH INSURANCE COMPANY

The Plan invested in a fully benefit-responsive guaranteed insurance contract with The Standard. The Standard maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting interest rate was based on a formula established by the contract issuer but could not be less than the 1 percent guaranteed rate specified by the Plan's contract. The crediting rate was reviewed quarterly for resetting as set forth in the contract.

The contract met the fully benefit-responsive insurance contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive insurance contracts because this is the amount received by participants if they were to initiate permitted transactions under

the terms of the Plan. Contract value, as reported to the Plan by the contract issuer, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants ordinarily directed the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may have been affected by future economic and regulatory developments. There were no reserves against contract value for credit risk of the contract issuer or otherwise. The balance of the contract was zero at May 18, 2022, due to the termination of the Plan, and \$678,904 at December 31, 2021.

The Plan was terminated effective September 30, 2021. There was no adverse impact to this contract due to the Plan termination and, as such, the contract was fully distributed by May 18, 2022.

6. INFORMATION CERTIFIED BY CUSTODIAN (UNAUDITED)

As permitted by 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, The Standard Insurance Company, the custodian, has certified the following information, which has not been subject to audit by independent auditors, to be complete and accurate:

- Investment balances included in the statements of net assets available for benefits at May 18, 2022 and December 31, 2021, and in the notes to the financial statements.
- Net depreciation in fair value of investments included in the statement of changes in net assets available for benefits for the period ended May 18, 2022, and in the notes to the financial statements.

7. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

The Plan's investments included a guaranteed insurance contract and pooled separate accounts offered and managed by The Standard, the custodian of the Plan. Standard Retirement Services and StanCorp Investment Advisers, Inc. (StanCorp) provided certain recordkeeping, administrative, and investment management services to the Plan pursuant to an agreement. The Standard, Standard Retirement Services, and StanCorp are subsidiaries of StanCorp Financial Group, Inc. These transactions qualified as party in interest transactions.

Certain administrative functions of the Plan were performed by management or employees of the Company. No such member of management or employee received compensation from the Plan.

8. PLAN TERMINATION

The Company had the right under the Plan to terminate the Plan subject to the provisions of ERISA. As disclosed in Note 1, this right was exercised and the Plan was terminated during 2021, with all remaining benefits distributed by May 18, 2022.

9. TAX STATUS

Effective January 1, 2022, the Plan adopted the Standard Retirement Services, Inc. Defined Contribution Volume Submitter Plan, which received an opinion letter dated June 30, 2020, from the IRS indicating that the Defined Contribution Volume Submitter Plan was an acceptable plan under Section 401 of the IRC for use by employers for the benefits of their employees. An employer who adopts this plan will be considered to have a plan qualified under Code Section 401(a), providing all the terms of the Plan are followed and the eligibility requirements and contribution or benefit provisions are not more favorable to officers, owners, or highly compensated employees than for other employees. Plan management and the custodian believe that the Plan was designed, and was being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan was qualified, and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America required Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. RISKS AND UNCERTAINTIES


