Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of General Service Bureau and Early Out Services Employee Savings Plan (“Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of May 3, 2022 (in liquidation) and December 31, 2021 (ongoing), and the related statement of changes in net assets available for benefits for the period from January 1, 2022 through May 3, 2022 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of May 3, 2022 and December 31, 2021, and for the period from January 1, 2022 through May 3, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of General Service Bureau and Early Out Services Employee Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the trustee approved the termination of the plan and merger into Revco Solutions 401(k) Plan, as of May 2, 2022, and management determined liquidation was imminent. As a result, the Plan has changed its basis of accounting from the going concern basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the General Service Bureau and Early Out Services Employee Savings Plan (“Plan”) provides only general information with respect to Plan provisions through May 3, 2022. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

Plan Merger and Termination - In 2021, General Service Bureau, Inc. and Early Out Services were acquired by Revco Solutions, Inc. Separately, Timberline Total Solutions (Timberline) ceased business operations with employees and Timberline no longer contributed to the Plan. In 2022, the Company passed a resolution to terminate the Plan and merge into the Revco Solutions 401(k) Plan with a merger date of May 2, 2022. Accordingly, the Plan adopted the liquidation basis of accounting for the period of January 1, 2022 through May 3, 2022.

All Plan assets, totaling \$3,899,195, were merged into Revco Solutions 401(k) Plan. The transferred net assets have been recognized in the accounts of Revco Solutions 401(k) Plan as of May 3, 2022, at their balances previously carried in the accounts of General Services Bureau and Early Out Services Employee Savings Plan. The transfer out of net assets is included in the accompanying statement of changes in net assets available for benefits for the period of January 1, 2022 through May 3, 2022.

General - The Plan is a multiple-employer defined contribution plan covering all employees of General Service Bureau, Inc., Timberline Total Solutions, and Early Out Services (collectively, the Company) who are age 21 or older and have completed six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees who are 21 or older and have completed six months of service are eligible for the discretionary employer match and profit-sharing contributions. The plan administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions - Each year, participants may contribute a percentage of tax-deferred or after-tax compensation or a dollar amount up to the amount permitted by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participant contributions are deposited into their account, which they can then direct to the investments they choose. Also, the Company contributes matching contributions and additional profit sharing amounts which may be contributed at the option of the Company’s board of directors.

The Plan features automatic enrollment of all eligible employees, with a 4% elective deferral rate, unless the employee elected out of the Plan or requests a change of the withholding rate. Employees that contribute less than 8% will automatically have their deferral contributions increased 1% per year on January 1, until they reach an effective deferral rate of 8%, unless they elect otherwise.

Participant Accounts - Each participant in the Plan has an individual account balance representing their interest in the Plan. Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contributions and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Vesting - Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contributions portion of their accounts is based on years of continuous service. A participant is 100 percent vested after five years of credited service, death, disability or a normal retirement age.

Notes Receivable From Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits - On termination of service due to death, disability, retirement or for other reasons, a participant may receive partial withdrawals, a lump-sum amount or substantially equal payments whose value is equal to the value of the participant's vested interest in his or her account.

Forfeited Accounts - Upon a participant's termination of employment before normal retirement, disability or death, the portion of their employer contributions not then vested shall be forfeited. At May 3, 2022 and December 31, 2021, forfeited non-vested accounts totaled \$0 and \$11,188, respectively. These accounts will be used to reduce future Company contributions. In 2022, Company contributions were reduced by \$11,526 from forfeited nonvested accounts.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the significant accounting policies applied in the preparation of the accompanying financial statements is set forth below.

Basis of Accounting – The 2022 financial statements of the Plan are prepared on the liquidation basis of accounting, as described in Note 1. The 2021 financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 3 – FAIR VALUE MEASUREMENTS (Continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021.

Pooled separate accounts - The fair value of pooled separate accounts is based on the net asset value (NAV) of units held by the Plan at year end and is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets within the account less liabilities. Investments measured at fair value based on the net asset value practical expedient are excluded from the fair value hierarchy.

NOTE 5 – TAX STATUS

The Plan has adopted a prototype plan that had received an opinion letter from the Internal Revenue Service (IRS), dated March 31, 2014, which states that the prototype plan satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's cash and investments are managed by John Hancock. John Hancock is the custodian for the Plan and, therefore, these transactions qualify as party in interest transactions. Direct expenses paid to John Hancock are included in administrative expenses in the statement of changes in net assets available for benefits for the period from January 1, 2022 through May 3, 2022. These transactions are exempt party in interest transactions under ERISA.
