Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Tennessee Rand, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of April 29, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the period from January 1, 2022 through April 29, 2022 and for the year ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of April 29, 2022 and December 31, 2021, and for the period from January 1, 2022 through April 29, 2022 and for the year ended December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management has determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

(1) Description of plan

The following description of the Tennessee Rand, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan was a defined contribution plan which was adopted on January 1, 1995, to provide retirement benefits for certain employees of Tennessee Rand, Inc. (TRI) (the "Plan Sponsor"). In January 2013, the Plan Sponsor was acquired by Lincoln Electric Holdings, Inc. ("Lincoln Electric"). After the acquisition, and until December 31, 2020, the Plan remained in place for existing and newly eligible employees of the former TRI, after which the Plan was frozen. The Plan covered substantially all full-time employees of the former TRI who are age eighteen or older, who are not union employees, and who have completed three months of service (participants). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective April 29 2022, the Plan merged with the Lincoln Electric Company Employee Savings Plan ("Lincoln Plan") and all of the net assets of the Plan were transferred into the Lincoln Plan. The net assets transferred were recognized in the accounts of the Lincoln Plan as previously carried in the accounts of the Tennessee Rand, Inc. 401(k) Plan.

(b) Contributions

Prior to December 31, 2020, participants could voluntarily make qualified retirement contributions to the Plan which were deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code (IRC). Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participant contributions were permitted up to 75% of compensation, subject to certain IRC limitations.

Prior to December 31, 2020, the Plan Sponsor matched an amount equal to 50% of the participant's contributions up to a maximum of 6% of compensation that a participant contributed to the Plan. Plan Sponsor contributions could not exceed the maximum amount deductible for federal income tax purposes.

Prior to December 31, 2020, the Plan also provided that the Plan Sponsor could make a discretionary contribution each year in an amount authorized by the Plan Sponsor's Board of Directors; however, an annual contribution by the Plan Sponsor was not required. No annual discretionary contributions were made by the Plan Sponsor in 2022 or 2021.

(c) Participant accounts

Each participant's account was credited (charged) with the participant's contributions, Plan Sponsor matching contributions, allocations of Plan Sponsor discretionary contributions, investment earnings (losses), and administrative expenses. Allocations were based on participants' compensation or account balances as defined in the plan agreement. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

(d) Payment of benefits

On termination of service due to death, permanent disability, retirement, or upon attainment of age 59½, a participant could elect to receive either a lump-sum payment or annual installments over a specified period equal to his or her entire account.

(e) Forfeited accounts

Forfeitures were created when participants terminated employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. Such forfeitures were used to reduce the Plan Sponsor's contributions to the Plan. At December 31, 2021, forfeited nonvested accounts totaled \$26,792. All forfeitures were included in the assets transferred to the Lincoln Plan on April 29, 2022.

(f) Hardship withdrawals

The Plan permitted distributions in the event of a hardship, as defined in the plan agreement. These distributions were taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Hardship withdrawals were limited to the participant's elective account balance.

(g) Administrative expenses

Certain expenses of maintaining the Plan were paid directly by the Plan Sponsor and were excluded from these financial statements. Fees related to the administration of benefit payments were charged directly to the participant's account and were included in administrative expenses. Other fees incurred by the Plan for the investment management services or recordkeeping were included in net appreciation (depreciation) in fair value of investments, as they were paid through revenue sharing, rather than a direct payment from the Plan.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan were prepared under the accrual method of accounting.

(b) Investment valuation and income recognition

Investments were stated at fair value. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividend income was recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Payment of benefits

Benefits were recorded when paid.

(d) Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(3) Certified information

Certain information reported and disclosed in the accompanying financial statements, including the fair value of investments held at April 29, 2022 and December 31, 2021, and net appreciation (depreciation) in fair value of investments, and interest and dividends for the years ended April 29, 2022 and December 31, 2021, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company ("Reliance").

(4) Fair value measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at April 29, 2022 and December 31, 2021.

- (i) *Money market fund and mutual funds:* Valued at the net asset value (NAV) of shares held by the Plan at year-end at the closing price on the active market on which the individual funds are traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Income tax status

The Plan Sponsor adopted a prototype 401(k) profit sharing plan, which received a favorable opinion letter from the Internal Revenue Service (IRS) on July 8, 2014, which stated that the prototype plan was designed in accordance with the applicable sections of the IRC. The Plan itself did not receive a determination letter from the IRS stating that the Plan was qualified under Section 401(k) of the IRC. However, the plan administrator believes that the adopted prototype plan, as amended, was designed and was operated in compliance with the applicable requirements of the IRC and was therefore qualified and exempt from taxation.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator analyzed the tax positions taken by the Plan, and concluded that as of April 29, 2022 and December 31, 2021, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there were no audits for any tax periods in progress.

(6) Related party and party-in-interest transactions

As described in Note 1, the Plan paid expenses to various service providers which qualified as party-in-interest transactions under ERISA.
