As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Ascensus Trust Company, the trustee, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our engagement letter dated October 26, 2022. Professional standards also require that we communicate to you the following information related to our audit.

#### Significant Audit Findings

##### *Qualitative Aspects of Accounting Practices*

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note A to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during 2022. We noted no transactions entered into by the plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.



Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected.

The financial statement disclosures are neutral, consistent, and clear.

#### *Form 5500 Procedures*

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

#### *Difficulties Encountered in Performing the Audit*

We encountered no significant difficulties in dealing with management in performing and completing our audit.

#### *Corrected and Uncorrected Misstatements*

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that are clearly trivial and communicate them to the appropriate level of management. There were no material misstatements identified that were adjusted or remained uncorrected.

#### *Disagreements with Management*

For purposes of this letter, a disagreement with management as a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.



*Internal Control*

Except as discussed in the following paragraph, in planning and perform our audit of the financial statements of the Plan as of and for the year ended December 31, 2022 in accordance with auditing standards generally accepted in the United States of America, we considered the Plan's internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Ascensus Trust Company that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and, therefore material weaknesses or significant deficiencies may exist that were not identified. However, as discussed below, we identified deficiencies in internal control that we consider to be significant deficiencies.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct misstatements on a timely basis. A material weakness is a deficiency or combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statement will not be prevented, or detected and corrected on a timely basis. We did not identify any deficiencies in internal control that we consider to be material weaknesses.



A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. We consider the following deficiencies in the Plan's internal control to be significant deficiencies:

- The Plan's management is responsible for ensuring the financial statements are prepared in accordance with accounting principles generally accepted in the United States of America. Although the Plan's financial statements were prepared by the audit team, the audit team cannot be considered to be a part of the Plan's internal control, which includes preparing the Plan's financial statements. While it is simply not cost beneficial for the plan this size to recruit and retain personnel with sufficient experience and skill in accounting and financial reporting to adequately address these deficiencies in the internal control, you should be aware of this condition.
- The limited number of office personnel prevents a proper segregation of duties necessary to provide for the prevention and detection of potential financial statement or plan compliance errors. The Board of Directors should be aware of this situation and realize that their most effective control lies in their knowledge of matters relating to the Plan's operations and the impact these matters have on the Plan's financial statements and related disclosures. Management should constantly strive to segregate duties and responsibilities to the greatest extent possible.

*Other Audit Findings or Issues*

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention. As part of our discussions we noted the following:

- We noted that documentation is not retained from employees declining participation in the plan upon receiving notice of eligibility. We recommend retaining signed documentation for all participants declining participation.

This information is intended solely for the use of the Board of Directors and management of the Plan and is not intended to be, and should not be, used by anyone other than these specified parties.

**NOTE A - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

1. Basis of Presentation

On February 22, 2022, the Board of Trustees approved the termination of the Hinckley Management Group, LLC 401(k) Plan, with the resolution to terminate effectively adopted on March 19, 2022. As of May 31, 2022, all participant account balances were distributed from the Plan in accordance with the terms of the Plan. For the period beginning January 1, 2022 through May 31, 2022, the financial statements were prepared using the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America. Prior to 2022, the financial statements were prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

2. Valuation of Investments

The Plan's investments were stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date.

Purchases and sales were recorded on the trade date basis. Dividends were recorded on the ex-dividend date. Interest income was recorded on the accrual basis. Net change in fair value included the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan presented, in the statement of changes in net assets available for benefits – liquidation basis, the net change in the fair value of its investments which consisted of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

**NOTE A - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED**

3. Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid balance plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based on the terms of the Plan document. Related fees were recorded as administrative expenses and were expensed as incurred. No allowance for credit losses were recorded as of May 31, 2022 or December 31, 2021.

4. Participant Direction of Investments

Subject to the provisions of the Plan, a participant had the right to direct the investments of the balance in their accounts in the specific investment funds made available by the Plan administrator. During the period beginning January 1, 2022 through May 31, 2022 and as of December 31, 2021 all investments were participant directed.

5. Payment of Benefits

Benefits were recorded when paid.

6. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**NOTE B – PLAN TERMINATION**

Hinckley Management Group, LLC is the Plan sponsor and Plan administrator. Hinckley Management Group, LLC adopted a resolution to terminate the Plan, effective March 19, 2022 as approved by the Board of Trustees on February 22, 2022. Effective with the Plan's termination, all participants with an account balance remaining in the Plan became fully vested. All participants received the option to rollover their balances to a new account and all other participants with remaining balances were automatically distributed their balances in full. All participant account balances were distributed in full as of May 31, 2022.

**NOTE B – PLAN TERMINATION - CONTINUED**

As no assets remained in the Plan as of May 31, 2022, the Company determined this date is the final reporting date of the Plan.

**NOTE C - DESCRIPTION OF THE PLAN**

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan operated as a Single Employer Plan. The other employers participating in the Single Employer Plan as part of a controlled group, where Hinckley Management Group, LLC was the lead sponsor, were: ALN Donuts, C&P Donuts Inc., DLCCG Donuts Inc., JN Donuts, Inc., and SMB Donuts Inc. The employers listed above will collectively be referred to as the Employer, hereafter.

The Plan was a defined contribution plan established on January 1, 2018 covering substantially all employees of the Employer. An employee was eligible for participation upon reaching age 21 and completing 1,000 or more hours of service in the 12-month period following their hire date, or if 1,000 hours or more of service was completed in a given Plan year.

The Employer was responsible for appointing an administrator and trustee for the Plan. The trustee had discretionary powers in executing investment transactions. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and the Internal Revenue Code ("IRC").

2. Contributions

The Plan allowed participants to contribute up to 100% of their eligible compensation, as defined in the Plan, subject to limits imposed by the IRC. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions as allowed by the IRC. Participants could also contribute amounts representing rollover distributions from other qualified defined benefit or contribution plans

**NOTE C - DESCRIPTION OF THE PLAN – CONTINUED**

2. Contributions - Continued

The Employer's qualified safe harbor matching contribution was required in the amount of 100% of the participants' deferral, up to 5% of the participants' eligible compensation. During 2022, Employer safe harbor contributions totaled \$29,646.

The Employer could also make discretionary profit sharing contributions. During 2022, the Employer did not make any such contributions.

3. Participant Accounts

Each participant's account was credited with the participant's contribution and an allocation of (a) the Employer's safe harbor matching and discretionary profit sharing contribution and (b) investment income (loss), less any administrative expenses. Allocations were based on participant compensation or account balances, as defined.

Changes in a participant's deferral percentage for future contributions could be made at any time during the Plan year. Reallocation of participant investment accounts among the investment options could be made at any time during the Plan year.

4. Forfeited Accounts

Forfeited accounts were used to defray the cost of administrative expense of the Plan or reduce future Employer discretionary profit sharing contributions. As of May 31, 2022 and December 31, 2021, the balances of unapplied forfeitures of non-vested accounts totaled \$0. Administrative expenses paid from forfeitures were \$0 during the period beginning January 1, 2022 through May 31, 2022.

5. Payment of Benefits

Upon termination of service due to death, disability, retirement or termination of employment, a participant could receive a lump sum distribution equal to the participant's vested account balance. Participants with account balances of \$1,000 or less were subject to involuntary lump sum distributions.

Hardship distributions were permitted for participants with qualifying purpose or need. In a hardship withdrawal under the Plan, participants could distribute funds attributable to pre-tax elective deferrals or Employer discretionary profit sharing contributions.

6. Notes Receivable from Participants

Notes receivable from participants were permitted up to the lesser of one-half of their vested balance or \$50,000 for each participant. The minimum loan amount that could be borrowed was \$1,000. The loans would bear a fixed interest rate equal to prime rate plus 1% for a term not to exceed five years unless the loan is used for the purchase of the employee's primary residence. Loans used for the purchase of an employee's primary residence could be repaid within a period of no more than 30 years. Participants were limited to one outstanding note at any given time. The notes were secured by the balance in the participant's account. Principal and interest was paid ratably through payroll deductions.

7. Risks and Uncertainties

The Plan was comprised of investments in a combination of mutual funds and other investment securities. Investment securities are exposed to various risks, such as interest, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE E – FAIR VALUE MEASUREMENTS**

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements*, established a framework for measuring fair value. That framework provided a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gave the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2     Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3     Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques used maximized the use of observable inputs and minimized the use of unobservable inputs.

**NOTE E – FAIR VALUE MEASUREMENTS – CONTINUED**

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 31, 2022 and December 31, 2021.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust funds:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may have produced a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments may have resulted in a different fair value measurement at the reporting date.

**NOTE F – FEDERAL INCOME TAXES**

The Plan, established on January 1, 2018 adopted a Prototype Non-Standardized Profit Sharing Plan with a cash or deferral arrangement of Ascensus, Inc. The prototype sponsor obtained its latest advisory letter dated March 31, 2014, which stated that the Plan, as then designed, was in accordance with applicable section of the IRC. The Plan administrator and the Plan's tax counsel believed that the Plan was designed and operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator and the Plan's tax counsel believed that the Plan was qualified and the related trust is tax-exempt as of the financial statement date. There were no reconcilable differences between the financial statements and the Form 5500 as of May 31, 2022 and December 31, 2021, and for the period beginning January 1, 2022 through May 31, 2022.

The Plan's policy was to evaluate the likelihood that any uncertain tax positions would prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence. The federal income tax returns of the Plan are subject to examination by the IRS, generally for three years after they were filed.

**NOTE G - PARTY-IN-INTEREST TRANSACTIONS**

Ascensus Trust Company was the trustee of the Plan and was the third party administrator.

Merrill Lynch, Pierce, Fenner and Smith (Merrill Lynch), held the Plan's investments and executed Plan transactions involving investments under their control as requested. Merrill Lynch also served as the investment advisor for the Plan.

**NOTE H – SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through February 10, 2023, the date which the financial statements were available to be issued.
