Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Bakersfield Heart Hospital 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

(1) Description of plan

The following description of the Bakersfield Heart Hospital 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement, copies of which were available from the Plan administrator, for a more complete description of the Plan's provisions.

(a) General

The Plan was a defined contribution plan which was adopted on August 8, 2011 to provide retirement benefits for employees of Heart Hospital of BK, LLC (the "Plan Sponsor"). The Plan covered substantially all full-time employees ("participants"). Employees were eligible to participate at the onset of employment. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective January 1, 2022, the Plan was frozen to new participants and no additional contributions were allowed. The Plan was merged into the Surgery Partners 401(k) Plan ("Surgery Partners Plan") effective June 9, 2022 and all participant account balances and Plan assets were transferred June 13, 2022. The net assets were recognized in the participants' accounts of the Surgery Partners Plan as previously carried in his or her accounts of the Plan. Effective January 2022, participants in the Plan became eligible to contribute to the Surgery Partners Plan and contributions to the Plan were suspended.

(b) Contributions

Prior to January 1, 2022, participants could voluntarily make qualified retirement contributions to the Plan which were deductible for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC") or could be made after-tax in the form of a Roth contribution. The Plan had an automatic enrollment program where newly eligible employees automatically deferred 3% of their pre-tax compensation unless they changed the percentage or opted out of the deferral. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participant contributions were permitted up to 50% of compensation, as defined in the Plan document, subject to certain IRC limits.

The Plan Sponsor could make a discretionary matching contribution to participants of the Plan. For the year ended December 2021, the Plan Sponsor matched an amount equal to 40% of each participant's elective deferrals up to 6% of compensation. The Plan Sponsor could also make discretionary non-elective contributions to the Plan. For 2022 and 2021, no such non-elective contributions were made by the Plan Sponsor. Plan Sponsor contributions could not exceed the maximum amount deductible for federal income tax purposes.

(c) Participant accounts

Each participant's account was credited (charged) with the participant's and Plan Sponsor contributions and allocations of investment earnings (losses) and administrative expenses. Allocations were based on participant compensation or account balances as defined in the plan agreement. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants were immediately vested in their elective salary deferral and the Plan Sponsor's contributions plus actual earnings or (losses) thereon.

(e) Notes receivable from participants

Each participant could borrow from his or her fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of his or her account balance. The notes were secured by the balances in the participants' accounts and bore interest at fixed rates that ranged from of 4.25% to 6.50% at December 2021, which were commensurate with local prevailing rates as was determined periodically by the plan administrator. Principal and interest were collected ratably through payroll deductions.

(f) Payment of benefits

On termination of service due to death, permanent disability, or retirement, a participant could elect to receive either a lump-sum payment or annual installments over a specified period equal to his or her entire account. For termination of service due to other reasons, a participant was entitled to receive only the vested interest in his or her account as a lump-sum distribution. If the value of a participant's account was less than \$1,000, the total balance was distributed as an automatic lump-sum payment in cash. For participant accounts greater than \$1,000 but less than \$5,000, the value of the participant's account was rolled into an individual retirement account on behalf of the participant, unless the participant elected to receive a lump-sum payment.

(g) Hardship withdrawals

The Plan permitted distributions in the event of a hardship, as was defined in the plan agreement. These distributions were taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant was younger than age 59½. Hardship withdrawals were limited to the participant's vested account balance.

(h) Administrative expenses

Certain expenses of maintaining the Plan were paid directly by the Plan Sponsor and were excluded from these financial statements. Fees related to the administration of notes receivable from participants and recordkeeping fees were charged directly to the participants' accounts and were included in administrative expenses. Fees incurred by the Plan for the investment management services were included in net appreciation (depreciation) in fair value of investments.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan were prepared under the accrual basis of accounting.

(b) Investment valuation and income recognition

The Plan's investments were stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The investment values are discussed more fully in Note 4.

Purchases and sales of securities were recorded on a trade-date basis. Dividend income was recorded on the ex-dividend date. Interest income was recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Notes receivable from participants

Notes receivable from participants were measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants were reclassified as distributions based upon the terms of the plan document.

(d) Payment of benefits

Benefits were recorded when paid.

(e) Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America required management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(f) Events occurring after reporting date

The Plan Sponsor evaluated events and transactions that occurred between June 9, 2022 and February 22, 2023, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Information related to investments and notes receivable from participants reported and disclosed in the accompanying financial statements, including the fair value of investments and notes receivable from participants held at June 9, 2022 and December 31, 2021, and net appreciation (depreciation) in fair value of investments, interest on notes receivable from participants and dividends for the period from January 1, 2022 to June 9, 2022 and for the year ended December 31, 2021, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus, as agent for Ascensus Trust Company and Branch Banking and Trust Company, respectively.

(4) Fair value measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 and Level 3 are not applicable to the Plan.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at June 9, 2022 and December 31, 2021.

- (i) *Mutual funds*: Valued at the net asset value ("NAV") of shares held by the Plan at year end based on quoted prices in an active market.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Income tax status

The Plan Sponsor adopted a non-standardized pre-approved profit-sharing plan which received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, in which the IRS stated that the pre-approved plan design was in compliance with the applicable requirements of the IRC. The Plan was required to operate in conformity with the IRC to maintain its qualification. The Plan itself has not obtained a determination letter. However, the plan administrator believes that the Plan was designed and was being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 9, 2022, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there were currently no audits for any tax periods in progress.

(6) Related party and party-in-interest transactions

As described in Note 1, the Plan paid expenses to various service providers which qualified as party-in-interest transactions under ERISA. The Plan also held notes receivable from participants which qualified as party-in-interest transactions.
