We have performed audits of the financial statements of Eagle River Capital 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### Note 1 - Plan Description

The following description of Eagle River Capital 401(k) Plan (the "Plan") provides only general information. Participants, and all others, should refer to the plan agreement for a more complete description of the Plan's provisions.

The Plan was a defined contribution plan established on March 15, 2019 and most recently amended on December 1, 2021. The Plan covered ERCO, LLC, a wholly owned subsidiary of Eagle River Capital, LLC (the "Company"), and the following subsidiaries: Eagle River Waste Services of CO, LLC and HBSCO, LLC, which were actively participating employers of the Plan.

On October 5, 2022, the Plan was merged with the AssuredSecure Pooled Employer Plan. Accordingly, all assets, participants, and their related account balances were transferred to the AssuredSecure Pooled Employer Plan effective October 5, 2022.

#### **General**

The Plan covers all employees of the Company who have completed six months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Administration**

ERCO, LLC is the sponsor of the Plan. The audit committee, as provided in the plan agreement, is the plan administrator and has responsibility for the administration of the Plan. Minnesota Life Insurance Company functions as custodian, and Securian Financial Group functions as the Plan's third-party administrator and investment manager. Investment management fees and custodian fees are paid by the Plan in accordance with the plan agreement.

#### **Contributions**

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants make contributions to the plan through regular payroll deductions. The Plan allows participants to contribute up to 100 percent of their compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Newly eligible employees who do not affirmatively elect to have a specific deferral percentage contributed or opt out of deferring into the Plan will automatically have 3 percent of their eligible compensation deferred into the Plan, escalating by 1 percent beginning on the first day of each plan year up to a maximum of 6 percent.

The Company may make annual discretionary contributions. All participants are eligible to receive an allocation of the company discretionary contribution, if any, regardless of service completed during the plan year or employment status on the last day of the plan year. There were no approved discretionary contributions for the period ended October 5, 2022.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with plan losses and an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

### Note 1 - Plan Description (Continued)

#### ***Participant Notes Receivable***

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the Internal Revenue Code. The notes receivable are secured by the vested balance in the participant's account and bear interest at market rates. Principal and interest are paid ratably through monthly payroll deductions.

#### ***Benefit Payments***

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of 59½ years of age in the form of a lump-sum amount equal to the vested balance of a participant's account.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

#### ***Vesting***

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings or losses thereon, is based on years of service.

#### ***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At October 5, 2022 and December 31, 2021, forfeited account balances totaled \$0 and \$3,768, respectively.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Minnesota Life Insurance Company. Minnesota Life Insurance Company is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. In addition, the Plan has loans to participants. These transactions also qualify as party-in-interest transactions. Both of these transaction types are exempt from the prohibited transaction rules.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation***

The Plan's investments are stated at fair value.

The pooled separate accounts are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

Various administrative costs are paid by the Company.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including February 21, 2023, which is the date the financial statements were available to be issued.

**Note 3 - Unaudited Information**

Minnesota Life Insurance Company (the "Custodian") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements are based solely on information certified by the Custodian.

**Note 4 - Tax Status**

The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the IRS. The volume submitter plan has received a favorable notification letter from the IRS dated March 31, 2014. The Plan has not individually sought its own determination letter.
