## INDEPENDENT AUDITOR'S REPORT

To the Chief Human Resources Officer of Luminis Health  
Doctors Community Hospital's Tax Deferred Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Doctors Community Hospital Tax Deferred Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of May 10, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period ended May 10, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Doctors Community Hospital Tax Deferred Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of May 10, 2022 and December 31, 2021, and for the period ended May 10, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Doctors Community Hospital Tax Deferred Savings Plan and to meet our other ethical responsibilities in accordance

with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter**

As discussed in Note 1 to the financial statements, Doctors Community Hospital Tax Deferred Savings Plan was merged with Luminis Health Retirement Plan, effective March 28, 2022. This plan was officially closed May 10, 2022. Our opinion is not modified with respect to this matter.

The Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA requires supplementary information that is not a required part of the financial statements. In this case, the supplemental Schedule of Assets (Held at End of Year) is not required because the plan was merged and all assets were transferred to another plan. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Doctors Community Hospital Tax Deferred Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements, as a whole, are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Doctors Community Hospital Tax Deferred Savings Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Doctors Community Hospital Tax Deferred Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements, as a whole, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Note 1 – Description of Plan**

The following brief description of the Plan is provided for general information purposes only. Participants who desire more complete information should refer to the Tax Deferred Savings Plan (the Plan) Summary Plan Description available from the Human Resources Department of Doctors Community Hospital (the Hospital).

**General**

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established by the Hospital and became effective October 19, 1990 and was amended and restated January 1, 2009, with additional amendments on July 1, 2009, January 1, 2012, September 1, 2013, January 1, 2014, and January 1, 2016. Effective January 1, 2020, the Plan was amended to change the employer match to a discretionary contribution with the amount being determined each year rather than the formula used previously. The Plan was restated effective April 1, 2020 to comply with Internal Revenue Service (IRS) Revenue Procedure 2013-22 which sets forth the procedures for opinion and advisory letters for 403(b) pre-approved plans. Transamerica Retirement Solutions Corporation is the record keeper and State Street Bank and Trust is the custodian of the Plan prior to May 10, 2022, the date the plan was closed after the merger with Luminis Health Retirement Plan.

**Contributions**

All employees are eligible to participate in the Plan, with the exception of leased employees. Each year, participants may contribute up to the Internal Revenue Service (IRS) threshold of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. New employees are automatically enrolled at elective deferrals of 2% of their pay withheld unless the employee “opts out” within the Hospital’s (Plan sponsor’s) designated timeframe of 30 days. Effective January 1, 2016, all existing employees not participating in the Plan were automatically enrolled and had an elective deferral of 2% of their pay withheld and transferred to the Plan as an employee contribution unless the employee “opted out” within the Hospital’s (Plan sponsor’s) designated timeframe of 30 days. The Plan also provides for a regularly scheduled auto-escalation of employee deferrals up to a maximum 10%.

Prior to 2020, the Hospital contributed a match equal to the lesser of 50% of the participant’s contribution or 50% of 4% of the participant’s eligible wages. Effective January 1, 2020, the Hospital contributes a discretionary match after the Plan year end in an amount determined each Plan year. Eligible wages for the purpose of the match exclude bonuses and severance pay. The participant is eligible to receive a match if they were employed at the end of the Plan year, had completed two years of eligible service and had an eligible job status as defined by the Plan. A participant’s prior service with Doctors Regional Cancer Center and Capital Ortho Specialists, LLC is recognized for eligibility purposes in computing a match. For purposes of the match, employees are excluded if they are considered leased, per diem, flex pool, modified non-receipt of benefits, part-time, temporary or contracted. A match is also made if a participant died, retired or incurred a disability in the Plan year. In response to the additional expenses incurred by the Hospital as a result of the pandemic, the match was suspended for the period July 1, 2020 to June 30, 2021.

**Note 1 – Description of Plan (Continued)**

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Hospital's contribution and (b) Plan earnings. Each account is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that could be provided from the participant's vested account.

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Hospital's matching contribution portion of their accounts plus actual earnings thereon is immediately 100% vested.

**Notes Receivable from Participants**

The Plan has a loan provision in which participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may have a maximum of three outstanding loans at one time. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loan account. Loan terms are limited to a maximum of five years per the current Plan agreement, unless used to acquire a principal residence of the eligible participant, at which time the loan period is a maximum of fifteen years. The loans are secured by an equivalent lien on the participant's non-forfeitable interest in the Plan at the time of the loan. The annual effective loan interest rate is not less than the prevailing rate of interest charged on similar commercial loans. If the loans are no longer being paid back but have a remaining balance, the loans are considered "deemed loans" and are used to reduce the participant's loan receivable balance. Based on the Summary Plan Description amendment, loan principal and interest payments are made through employee payroll deductions based on the record keeper's loan agreement and amortization schedule.

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments as defined in the Plan agreement. Retirement age for the Plan is 65. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan makes involuntary cash-out distributions for terminated participants with vested balances of \$1,000 or less. Vested balances of \$1,000 to \$5,000 are subject to the applicable automatic IRA rollover requirements of Code section 401(a)(31)(B).

**Plan Expenses**

The Hospital incurs certain administrative expenses related to the Plan. Participants incur certain expenses related to their individual accounts. See Note 7.

**Plan Merger**

The Board of Directors of Luminis Health approved the merger of this Plan into the Luminis Health Retirement Plan, effective March 28, 2022. As a result, all investments were transferred from the Plan into the Retirement Plan on that date. This plan was officially closed on May 10, 2022.

**Note 2 – Summary of Significant Accounting Policies**

**Basis of Presentation**

For the period ended May 10, 2022 and the year ending December 31, 2021, the Form 5500 and the financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Use of Estimates**

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances. Accrued interest on outstanding loans at year end is recognized for financial statement purposes. Related fees are recorded as administrative expenses and are expensed when they are incurred. As of May 10, 2022, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. Loan principal and interest payments are made through employee payroll deductions based on the record keeper's loan agreement and amortization schedule.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements. All Plan assets were transferred to the Retirement Plan prior to May 10, 2022.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Participants direct their contributions into various investment options offered by the Plan.

**Payments of Benefits**

Benefits are recorded when paid.

**Subsequent Events**

Management evaluated all events and transactions that occurred after May 10, 2022 through February 28, 2023, the date these financial statements were available to be issued.

**Note 3 – Information Certified by Custodian**

The May 10, 2022 and December 31, 2021 Statements of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in Net Assets Available for Benefits for the period ended May 10, 2022, and the accompanying notes to the financial statements are prepared in part or entirely from information certified by the State Street Bank and Trust Company, custodian of the Plan in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$0 and \$100,065,993 at May 10, 2022 and December 31, 2021, respectively, and related losses of \$5,884,448 for the period ended May 10, 2022. Transamerica Financial Life Insurance Company, Inc., with whom the group annuity contract assets were invested, provides additional certification at the fund level as to the completeness and accuracy of their contract investments.

**Note 4 – Guaranteed Investment Contracts with Insurance Companies**

The Plan holds investments in a traditional fully benefit-responsive guaranteed investment contract with Transamerica Financial Life Insurance Company (TFLIC), an affiliate of Transamerica Corporation. TFLIC maintains the contributions in a pooled account. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Contract value of the fully benefit-responsive guaranteed contract at December 31, 2021 was \$15,691,941. There was no fully benefit-responsive guaranteed investment contract at May 10, 2022 due to the plan being merged and all assets transferred to the Luminis Health Retirement Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value.

Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants can ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed-upon with the issuer and is reviewed periodically, but not less than annually.

Certain events limit the Plan's ability to transact at contract value with the insurance company. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events that would cause significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan's ability to transact at contract value was not impacted by the plan merger and transfer of assets to the Luminis Health Retirement Plan.

**Note 5 – Fair Value Measurements**

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs are observable inputs other than the quoted prices in Level 1 while Level 3 inputs have the lowest priority and are unobservable inputs. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measured fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs are not available. Level 3 inputs are only used if Level 1 or Level 2 inputs are not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the period presented.

Level 1 Fair Value Measurements - The fair value of money market and mutual funds is based on the closing price reported in the active market where the individual securities are traded, when available.

As a result of the plan merger, there are no plan assets to be reported at May 10, 2022. Total investments at fair value as of December 31, 2021 were \$84,374,052.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the period ended May 10, 2022, are reported in net appreciation (depreciation) in fair value of investments.

The Plan's policy is to recognize transfers between Level 1 and Level 2 and into and out of Level 3 at the end of the reporting period. For the period ended May 10, 2022 and the year ended December 31, 2021, there are no significant transfers between Level 1 and Level 2 and no transfers into or out of Level 3.

**Note 6 – Restricted Cash**

At May 10, 2022 and December 31, 2021, the Plan has no cash reserve account balance held in State Street Bank and Trust Company. Such a cash balance would represent excess Plan expenses and be restricted for the purpose of future Plan expenses.

**Note 7 – Administrative Expenses**

Administrative expenses totaling \$92,475 and \$257,541 were incurred during the period ended May 10, 2022 and the year ended December 31, 2021 and represent the cumulative amount of quarterly expenses paid to Transamerica Retirement Solutions. These expenses were funded through the change in value of participant investment accounts per the service agreement with Transamerica.

**Note 8 – Transactions with Parties-In-Interest**

During the period ended May 10, 2022 and the year ended December 31, 2021, the Plan invested in contracts with Transamerica Financial Life Insurance Company (TFLIC), an affiliated company of Transamerica Corporation. Transamerica Retirement Solutions Corporation is an affiliate of Transamerica Corporation. Therefore, the investment contracts would qualify as parties-in-interest transactions. See Note 4 for investment contracts with the insurance company and the amounts.

All of these party-in-interest transactions are exempt from prohibited transaction rules of ERISA.

**Note 9 – Income Tax Status**

The Internal Revenue Service (IRS) issued Revenue Procedure 2013-22 to establish a program for opinion and advisory letters for 403(b) pre-approved plans. Based on the start date of the Plan and the submission of Transamerica's prototype plan with the IRS, it has been determined that the Plan operates in conformity with the Internal Revenue Code (IRC) to maintain its tax exemption. The Plan administrator believes the Plan is designed and operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax exempt.

**Note 10 – Plan Termination**

Although it has not expressed any intent to do so, under the Plan, the Hospital has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right. See Note 1 for the plan merger and transfer of plan assets.

**Note 11 – Risk and Uncertainties**

The Plan invested in various investment securities prior to May 10, 2022. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Because the plan assets were transferred as of May 10, 2022, there is no longer a risk that changes in the values of investment securities could occur that would materially affect participants' account balances. There are no amounts reported in the statement of net assets available for benefits.

Plan contributions and beneficiary payments are made to and from the Plan's various investment accounts. These investment funds, comprising of all of the Plan's assets prior to May 10, 2022, are not insured or guaranteed by the FDIC and are subject to investment risk including loss of principal amounts invested.
