Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Mountaire Farms of Delmarva Profit-Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of September 1, 2022 and March 31, 2022, and the related statement of changes in net assets available for benefits for the period ended September 1, 2022 and the year ended March 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of September 1, 2022 and March 31, 2022, and for the period ended September 1, 2022 and the year ended March 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

September 1, 2022 and March 31, 2022

1. Summary of Significant Plan Provisions

The following description of the Mountaire Farms of Delmarva Profit-Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreements for a more complete description of the Plan’s provisions.

- a. **General** – The Plan was a defined contribution plan for the benefit of eligible employees of Mountaire Farms Inc. (the “Employer”). It was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

On March 17, 2022, the employees of Mountaire Farms Inc. voted out the International Brotherhood of Teamsters, Local Union No. 355 (“Local 355”). On April 3, 2022, Local 355 was decertified. These employees were then able to participate in the Mountaire Corporation & Subsidiaries Retirement Plan (the “Retirement Plan”). The Employer executed a merger and transfer agreement where the assets of the Plan were transferred to the Retirement Plan effective September 1, 2022.

- b. **Eligibility** – Each union employee was eligible to participate in the Plan at the next Plan entry date after completing one year of service during which the employee accrued 1,000 hours or more of service. Entry dates were April 1 and October 1. Nonunion employees were not eligible to participate.
- c. **Contributions** – The Plan was funded by contributions from the Employer. The amount of Employer contributions was determined by the Board of Directors of the Employer, Article IV of the Plan Document, and Union Side Agreement. Participant deferral contributions were not permitted. A participant was eligible to share in an allocation of the Employer contribution if, during the Plan year, the participant had been credited with at least 1,000 hours of service and was employed on the last day of the Plan year. It was the Employer’s policy to fund its annual contribution as soon as administratively possible after the end of the applicable Plan year.
- d. **Participant accounts** – Each participant’s account was credited with allocations of any Employer contributions, forfeitures, and Plan earnings/losses, and was charged with applicable withdrawals and an allocation of administrative expenses. Employer contributions and forfeitures were allocated based on the participant’s Employer contribution account balance, earnings/losses, an age based factor, the participant’s length of service and monthly benefits specified by the Plan document. Investment earnings/losses and administrative expenses were allocated based on the participant’s account balance. The benefit to which a participant was entitled was the benefit that could be provided from the participant’s vested account.
- e. **Vesting rights** – The benefits attributable to a participant were fully vested upon retirement, death, or disability. If a participant terminated employment other than because of their death, disability, or retirement, they were entitled to the vested portion of their share of Employer contributions, forfeitures, and income thereon.

- f. **Payment of benefits** – Participants who were eligible for benefits began to receive their benefits as soon as administratively possible after a proper application for benefits was delivered to the Plan administrator. If a participant's account balance was equal to or less than \$5,000, the balance was automatically distributed. Any distribution that was made to a participant without their consent was rolled over to an individual retirement plan designated by the Plan administrator. All benefits were made as lump sum payments.
- g. **Forfeitures** – The portion of the participant's account to which they were not entitled upon termination of participation was deemed a forfeiture and was allocated to the remaining participants in the same manner as contributions. Forfeitures of \$11,202 were allocated for the year ended March 31, 2022. Effective April 1, 2022, forfeitures were allocated first to pay Plan expenses and any remaining amounts were allocated to participants in the same manner as contributions. Forfeitures of \$7,917 were utilized to pay Plan expenses for the period ended September 1, 2022. There were no forfeitures available for future use as of September 1, 2022 or March 31, 2022.
- h. **Termination of the Plan** – The Employer had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Employer executed a merger and transfer agreement where the assets of the Plan were transferred to the Retirement Plan effective September 1, 2022. Participants became 100% vested in their accounts on the date of the merger.

2. Summary of Significant Accounting Policies

- a. **Basis of accounting** – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- b. **Estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amount of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

- c. **Investment valuation and income recognition** – Investments are reported at fair value. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

- d. **Payment of benefits** – Benefits are recorded when paid.
- e. **Administrative expenses** – Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Distribution fees are charged directly to the participant's account.

3. Investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Lincoln Financial Group Trust Company, Inc. ("Lincoln"), the trustee of the Plan, and was not subjected to any audit procedures, except for comparing the information with the related information included in the financial statements and supplemental schedule:

- a. Investments at fair value as shown on the accompanying statement of net assets available for benefits of \$2,702,242 as of March 31, 2022.
- b. Dividends as shown on the accompanying statement of changes in net assets available for benefits of \$26,497 and \$135,177 for the period ended September 1, 2022 and the year ended March 31, 2022, respectively.
- c. Net change in fair value of investments as shown on the accompanying statement of changes in net assets available for benefits of \$(257,179) and \$78,602 for the period ended September 1, 2022 and the year ended March 31, 2022, respectively.
- d. All investment transactions that occurred during the period ended September 1, 2022 and the year ended March 31, 2022.
- e. All information included in the supplemental schedule.

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Further, due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Notes to Financial Statements**September 1, 2022 and March 31, 2022****4. Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is categorized based on a hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at March 31, 2022.

Mutual fund: This investment is valued at quoted market prices on the last business day of the Plan year.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. **Tax Status**

The Plan document received the latest determination letter dated July 27, 2012, in which the Internal Revenue Service ("IRS") stated that the Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of September 1, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

6. **Party-in Interest Transactions**

Lincoln was the trustee and third party administrator for the Plan. The Plan paid Lincoln for their services. Inasmuch as Lincoln served as trustee and third party administrator, they were by definition a party-in-interest. These transactions were exempt from being prohibited transactions under ERISA.

7. **Subsequent Events Evaluation Date**

Management of the Plan evaluated the events and transactions subsequent to its September 1, 2022 financial statement date and determined there were no significant events necessary for disclosure through March 13, 2023, which is the financial statement issuance date.
