We have performed audits of the financial statements of Novidea Healthcare, Inc. Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of May 2, 2022 (in liquidation), and the related statement of changes in net assets available for benefits for the period January 1, 2022 through May 2, 2022 (in liquidation), and the statement of net assets available for benefits as of December 31, 2021 (ongoing), and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or Federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of May 2, 2022 and for the period January 1, 2022 through May 2, 2022 and as of and for the year ended December 31, 2021, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Emphasis of Matter—Basis of Accounting

As discussed in Note 1 to the financial statements, the governing body of Novidea Healthcare Profit Sharing Plan and Trust approved a plan of liquidation during March 2, 2022 with all Plan assets and related balances being transferred into an unrelated plan. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Novidea Healthcare, Inc. Profit Sharing Plan and Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTES TO FINANCIAL STATEMENTS

PERIOD JANUARY 1, 2022 THROUGH MAY 2, 2022 AND THE YEAR ENDED DECEMBER 31, 2021

1. Description of Plan:

General:

The following description of the Novidea Healthcare, Inc. Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Novidea Healthcare, Inc. (the "Company") is the Plan Sponsor and a Professional Employer Organization ("PEO"). The Company was formed in 1998.

The Company provides human resource solutions by entering into a co-employment relationship with participating employers under which the Company and its participating employers each take responsibility for certain portions of the employer-employee relationship. The Company and its participating employers designate each party's responsibilities through its Client Service Agreement ("CSA"), under which the Company becomes the employer of the employees who work at the participating employer's location ("worksite employees") for most administrative and regulatory purposes.

The Plan, established February 1, 2006, is a multiple employer defined contribution plan covering all worksite employees of participating employers of Novidea Healthcare, Inc. (collectively, the "Companies") who meet the eligibility requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company's Advisory Committee is responsible for oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

On July 30, 2021, a participating employer terminated their relationship with the Company. As a result, assets of \$4,611,302 were transferred to an unrelated plan.

On May 2, 2022, the Company merged the Plan into a related plan of its' parent company (see Note 10) and assets of \$6,925,059 were transferred.

Contributions:

Participants may elect to contribute up to 100% of their compensation into the Plan on a pre-tax or post-tax basis (Roth). The amount a participant can contribute is limited to the annual amount set by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Rollovers are included with participant contributions on the statements of changes in net assets available for benefits for the period January 1, 2022 through May 2, 2022 and the year ended December 31, 2021.

The Companies may make discretionary matching contributions to the Plan. The amount to be matched is determined by each individual participating employer. There were no employer discretionary matching contributions made during the period January 1, 2022 through May 2, 2022 or the year ended December 31, 2021.

1. Description of Plan (continued):

Contributions (continued):

The Companies may make a discretionary profit sharing contribution to the Plan. The amount of the discretionary profit sharing contribution is determined annually by each individual participating employer. Employer discretionary profit sharing contributions totaled \$30,439 in 2021. No employer discretionary profit sharing contributions were made during 2022.

Certain participating employers are required to make Safe Harbor Qualified Non Elective Contributions (QNEC) to the Plan. Safe Harbor Qualified Non Elective contributions totaled \$25,858 during the period January 1, 2022 through May 2, 2022 and \$143,817 during the year ended December 31, 2021.

Vesting:

Participants are immediately vested in their pre-tax, post-tax and QNEC contributions plus earnings thereon. Participants vested in discretionary matching and profit sharing contributions in accordance with the following schedule:

Forfeitures of nonvested accounts are retained in the Plan and can be used to reduce future employer contributions. Forfeited accounts not allocated to participant accounts amounted to \$68,213 prior to merger in 2022 and \$61,074 in 2021. No forfeitures were used in 2022 or 2021. Upon termination all participants became 100% vested. The related party parent company is responsible for allocating forfeitures within the merged plan.

Participant accounts:

Separate accounts for each participant are maintained by the custodian (excluding the participant-directed brokerage accounts). Each account is credited with the participant's contributions, as well as allocations of the Companies' contributions and earnings and losses from investments held in the account.

Participants may direct their contributions, including the employer's portion, into any combination of investment funds. Participants may invest in participant-directed brokerage accounts subject to certain terms and provisions.

1. Description of Plan (continued):

Payment of benefits:

Participants may elect to withdraw a specified portion of their contributions prior to their termination of employment subject to certain restrictions under the Plan. All accounts are subject to distribution upon the participant's termination, retirement, total disability or death.

On termination of service for any other reason than death, the participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest or in periodic payments as elected by the participant.

Benefits are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan are paid directly by the Companies and are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments in the statements of changes in net assets available for benefits.

2. Summary of significant accounting policies:

Basis of accounting:

As a result of management's decision to terminate the Plan effective May 2, 2022, the liquidation basis of accounting was used in presenting the statement of net assets available for benefits and the statement of changes in net assets available for benefits as of and for the period January 1, 2022 through May 2, 2022. The ongoing (accrual) basis of accounting was used as of and for the year ended December 31, 2021.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates and assumptions.

Investment valuation and income or loss recognition:

The Plan's pooled separate accounts and guaranteed interest contract are reported at fair value, as provided by John Hancock Life Insurance Company (U.S.A.) ("John Hancock"), the custodian of the Plan. The Plan's participant-directed brokerage accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by its investment advisors and the custodian.

2. Summary of significant accounting policies (continued):

Investment valuation and income or loss recognition (continued):

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. These amounts were provided by the various investment companies for the period January 1, 2022 through May 2, 2022 and the year ended December 31, 2021 and are included in net appreciation (depreciation) in fair value of investments in the statement of changes in net assets available for benefits.

3. Investments:

The following table presents the value of participant-directed investment accounts at May 2, 2022 and December 31, 2021. All investments are participant-directed.

4. Fair value:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

4. Fair value (continued):

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 2, 2022 and December 31, 2021.

Guaranteed investment contract: Fair value is calculated as the number of units of the sub-account held on particular date multiplied by the unit value on that date, and generally is the value that would be paid out for participant-initiated or benefit withdrawals. The fair value of the guaranteed investment contract is determined by John Hancock by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer.

Pooled separate accounts: Valued at their accumulation unit value (AUV). The pooled separate accounts are valued daily as the number of accumulation units held multiplied by the AUV. The AUV is first established when a new fund starts and is then determined daily based on the net asset value of shares of the underlying fund, the fund's dividends, and the contract's separate account charges.

Participant-directed brokerage accounts: The fair value of common stocks is based on quoted market prices. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV), and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The fair value of cash equivalents is valued at face value, which approximates fair value.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation technique is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. **Party-in-interest transactions:**

Certain Plan investments are managed by John Hancock. John Hancock is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Certain fees related to the administration of the Plan were paid by the Plan or Plan Sponsor, which also qualify as party-in-interest transactions.

6. **Administrative expenses:**

Certain administrative expenses for the Plan are paid by the Companies during 2022 and 2021. Certain administrative functions are performed by employees of the Companies. No such employee or the Companies receive compensation from the Plan.

7. **Certified investments:**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments (excluding the participant-directed brokerage accounts) at May 2, 2022 and December 31, 2021, and net appreciation (depreciation) in fair value of investments (excluding the participant-directed brokerage accounts) for the period January 1, 2022 through May 2, 2022 and the year ended December 31, 2021, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock.

8. **Guaranteed investment contract:**

The Plan is enrolled in a non-fully benefit-responsive investment contract with John Hancock. John Hancock maintains the contributions in a separate account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Fully benefit-responsive investment contracts held by a defined contribution plan are required to be reported at contract value. Contract value is the relevant measurement attributable for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investment contract does not meet the criteria of being fully benefit-responsive, and therefore, the investment contract is recorded on the statements of net assets available for benefits at fair value.

The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company and trust company to terminate the agreement prior to the scheduled maturity date.

9. **Income tax status:**

On March 12, 2018, the Internal Revenue Service ruled that the Plan qualifies under Section 401(a) of the Internal Revenue Code (IRC) and is therefore not subject to tax under present income tax law. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan is a prototype plan and has received a favorable determination letter from the Internal Revenue Service. Management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. **Plan merger:**

The Company had the right to discontinue their contributions at any time and to terminate the plan subject to the provisions of ERISA. On March 2, 2022, the Company elected to merge the Novidea Healthcare, Inc. Profit Sharing and Trust into a related Plan of its' parent company. Final distributions and transfers were determined on all participants being 100% vested and were made during 2022. In accordance with U.S. GAAP, the Plan changed its basis of accounting from the ongoing plan basis to the liquidation basis effective in 2022.

11. **Risks and uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

As a result of the COVID-19 pandemic, economic uncertainties have arisen which have resulted in significant volatility in the investment markets. The duration of these uncertainties and the ultimate financial effects cannot be reasonably estimated at this time. No adjustments have been made to these financial statements as a result of this uncertainty.

12. **Delinquent participant contributions:**

In 2022 and 2021, the Plan failed to remit employee contributions totaling \$11,575 in 2022 and \$57,197 in 2021 within the time permitted in accordance with DOL Regulations 2510-3-102(b). Additionally, the related party parent company will calculate and remit lost earnings related to the plan and pay the related excise tax on the lost earnings to the IRS.
