Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of L.I.F. Industries, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of May 12, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 through May 12, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of L.I.F. Industries, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of May 12, 2022 and December 31, 2021, and for the period from January 1, 2022 through May 12, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about L.I.F. Industries, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Note 1 - Description of Plan

The following description of the L.I.F. Industries, Inc. 401(k) Plan (the "Plan") provides only general information. For a more complete description of the Plan's provisions, refer to the document governing the Plan ("Plan Agreement").

General

The Plan, which was established on January 1, 2005, restated on January 1, 2015, and amended effective January 1, 2019, is a defined contribution plan covering all eligible employees of L.I.F. Industries, Inc. (the "Sponsor" or "Company") who have completed three months of service and are age 21 or older. Participants will qualify to receive employer matching contributions on the first day of the calendar month following the day the participant becomes 21 and has completed one year of service. Participants must have completed one year of service during the Plan year and be employed by the Company on the last day of the Plan year in order to qualify for profit sharing contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

On December 18, 2020, 100% interest in the Company was acquired by Unified Door Holdings, LLC through an Equity Purchase Agreement. In February 2022, the board of directors of Unified Door Holdings, LLC approved an adoption agreement to merge the Plan into the Unified Door and Hardware Group 401(k) Profit Sharing Plan ("UDH Plan"), effective May 12, 2022. As a result, all investments were transferred from the Plan into the UDH Plan on that date.

The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees. The custodian of the Plan is Voya Retirement Insurance and Annuity Company ("Voya" or the "Custodian"). Certain officers of the Sponsor serve as Trustees.

Contributions

Each year, participants may contribute up to 100% of eligible annual compensation, as defined in the Plan, provided that such contributions do not exceed the limitations under the Internal Revenue Code (the "Code") for 2022 of \$20,500, plus a maximum of \$6,500 in catch-up contributions for participants who have attained age 50 before the end of the Plan year. Contributions may be made as a pre-tax deferral or after-tax (Roth) deferral. Highly compensated employees are subject to additional limits set forth in the Code. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan was amended January 1, 2019 to add an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Contributions (cont'd.)

The Sponsor makes a matching contribution to the Plan. This matching contribution is a discretionary percentage determined by the Sponsor. For the period from January 1, 2022 through May 12, 2022, the matching contribution percentage was 50% of the first 6% of eligible salary that participants contribute to the Plan each year. The matching contribution is invested as directed by the participant. In 2022, the Sponsor made matching contributions of \$35,355. Profit sharing contributions are also made at the Sponsor's discretion. In 2022, the Sponsor did not make any profit sharing contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Sponsor's matching and profit sharing contributions, as well as allocations of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are 100% vested for profit sharing contributions by the Sponsor after three years of service. Vesting in the Sponsor's matching contribution portion of their accounts is based on years of service as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
At least 1 but less than 2	0%
At least 2 but less than 3	20%
At least 3 but less than 4	40%
At least 4 but less than 5	60%
At least 5 but less than 6	80%
6 or more years	100%

In addition, a participant becomes 100% vested in all allocated Sponsor contributions upon death, disability, or the attainment of age 65 while employed by the Sponsor.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account. Only one Plan loan may be outstanding at any one time. Loans will be subject to interest charges determined by the Plan administrator by reviewing interest rates charged for similar types of loans by other lenders. The loans are secured by the balance in the participant's account. Loans must normally be repaid within such period as agreed to between the participant and the Plan, up to a maximum of five years. However, if the loan is made for the purchase or construction of a principal place of residence, the repayment period may be over twenty years. Repayment will normally be made through payroll deductions. Any outstanding loans must be fully repaid when employment terminates.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a 10-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Deemed Distributions

For participant loans in which the participant has a distributable event, such as employment termination, death, or disability, the loan is considered a deemed distribution. The participant loan is removed from the statement of net assets available for benefits and a distribution is recorded. For active participants who have not incurred a distributable event, but have delinquent loans, the participant loan remains outstanding until a distributable event occurs.

Forfeitures

At December 31, 2021, forfeited nonvested accounts totaled \$17,849. Forfeited nonvested accounts totaling \$20,297 as of May 12, 2022, were transferred to the UDH Plan.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers. See Note 5 for a discussion of fair value measurement. All Plan assets were transferred to the UDH Plan before close of business on May 12, 2022.

Investment Valuation and Income Recognition (cont'd.)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded at May 12, 2022 or December 31, 2021. Delinquent notes receivable from participants are reclassified as distributions once the participant is no longer employed by the Sponsor. Interest rates on loans outstanding during 2022 ranged from 4.25% to 6.50%. As of May 12, 2022 there were no outstanding loans as all loans were merged into the UDH Plan, see Note 3.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation or depreciation in fair value of investments. Certain administrative functions are performed by officers or employees of the Sponsor. No such officer or employee receives compensation from the Plan.

Note 3 - Plan Termination

The Sponsor has no legal or contractual obligation to make annual contributions to or to continue the Plan, and has the right under the Plan to terminate the Plan by approval of the Board of Directors, subject to the provisions of ERISA.

In February 2022, the board of directors of Unified Door Holdings, LLC approved an adoption agreement to merge the Plan into the UDH Plan effective May 12, 2022. Subsequent to the execution of the adoption agreement, contributions were not allowed into the Plan and there were no loans issued out of the Plan; however, payments on existing loans continued to be accepted.

The Plan and its related trust continued to be administered in accordance with the terms thereof until all Plan assets were distributed as of May 12, 2022.

Note 5 - Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Note 5 - Fair Value Measurement (cont'd.)

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at May 12, 2022 and December 31, 2021.

Pooled separate accounts: Valued at the daily closing net asset value (“NAV”) as a practical expedient. Pooled separate accounts held by the Plan are registered with the Securities and Exchange Commission (“SEC”). These funds are required to publish their daily NAV and to transact at that price. The pooled separate accounts held by the Plan are deemed to be actively traded.

Voya fixed account: This is a guaranteed interest account, which is valued at the approximate amount that would have been paid if the contract had been terminated as of the last day of the reporting period and potential surrender charges and market value adjustments were applied as of such date. The credited rate, account balance and formulas upon which payments may be based are observable through the contract and related communications. The credited rate is communicated to the Plan and credited daily. Any market value adjustment or surrender charge is based on the formulas and schedules in the contract.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. For the period from January 1, 2022 through May 12, 2022 and for the year ended December 31, 2021, there were no significant transfers between Levels 1 and 2 and no transfers in or out of Level 3.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value at December 31, 2021. The Plan did not hold any assets as of May 12, 2022, due to the merger, as described in Note 3.

Note 6 - Voya Fixed Account

The Plan invests in a guaranteed interest account with Voya, which maintains the contributions in a general account. Because certain events limit the ability of the Plan to transact at contract value with the issuer, the Plan has determined that the guaranteed interest account is not fully benefit-responsive, so it is presented on the face of the statement of net assets available for benefits at fair value.

The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The crediting interest rate is based on a formula agreed upon with the issuer and is reviewed periodically for resetting.

Note 7 - Related Party Transactions and Party-In-Interest Transactions

Certain Plan investments are shares of pooled separate accounts managed by Voya, the Custodian of the Plan. Therefore, the transactions related to these investments qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included in the net change in the fair value of investments.

Notes receivable from participants also qualify as party-in-interest transactions.

The Company pays for certain approved Plan expenses, including accounting fees. Certain employees and officers of the Company, who may also be participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

Note 8 - Tax Status

The Plan has adopted the CCH Incorporated, DBA FTWilliam.com Volume Submitter Profit sharing plan with CODA. Accordingly, the Plan is permitted to rely on CCH Incorporated, DBA FTWilliam.com's opinion letters. The Internal Revenue Service has determined and informed CCH Incorporated, DBA FTWilliam.com by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, and therefore believes that the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that at May 12, 2022 and December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset, or require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2019.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 - Subsequent Events

The Plan administrator has evaluated all events or transactions that occurred after May 12, 2022 through March 14, 2023, which is the date that the financial statements were available to be issued. During this period, there were no material subsequent events requiring disclosure.
