Reasonable Cause Relief

The taxpayer is seeking reasonable cause relief from late filing of the Form 5500-SF. The taxpayer previous accountant became ill, and retired from practice. The taxpayer engaged another accounting firm to prepare the Form 5500. However, the previous accountant had plan documents and investment information needed to prepare the 2021 Form 5500. Due to her illness the previous accountant was not able to provide the required documents by the filing deadline.

The taxpayer acted in good faith and with reasonable care, the late filing was due to an illness of the previous accountant, and not willful neglect.
